AN IMPORTANT DECISION.
WASHINGTON, Sept. 17.—July 18, the United States commissioner at Detroit, in the case of a Chinaman found unlawfully in the United States, ordered him to return to China as being the country whence he came. The case was appealed to the district court, and the treasury department has received a dispatch that Judge Swan has reversed the decision of the commissioner, and found that Canada was the country from which the man came, and had directed his return there. Acting Secretary Spaulding telegraphed the deputy collector at Detroit that in case the Chinaman came before the court on habeas corpus proceedings, to request the district attorney to take an appeal. If the proceedings were under the exclusion act of 1888, the decision will be regarded as final. At the treasury department with the information now before it, the decision is regarded as one of great importance, and it is said the practical effect, if the proceedings at Detroit will be to render inoperative the provisions of that act. The attorney general has heretofore decided that under the provisions of that act the country whence Chinamen came means China, and the department has been sending all Chinamen convicted of being unlawfully in the United States back to that country.

LOST IN SPECULATION.
ST. LOUIS, Mo., Sept. 17.—Clarence T. Jenkins, middle aged and a prominent member of the First Presbyterian church here, broke down and wept piteously when he was placed in jail last evening on a warrant charging him with embezzling \$14,000. He stole this money from his employees and has confessed his guilt. For some years he has been the trusted cashier of Armstrong, Gilbert & Co., cork manufacturers. As a reward for his faithful services he has been given a long vacation each year, and it was during his summer holiday that his wrong doings were discovered. It is the old story of false entries to cover the thefts, small at first and made with the intention of returning them. Jenkins did not live a fast life, but he speculated in mining stocks and this was the cause of his ruin. He is a member of several benevolent societies, and agent in St. Louis for the American Salt Company. He was released on bail.

HE KNOCKED HIM DOWN.
ROANOKE, Va., Sept. 17.—L. Q. C. Lamar, son of Justice Lamar, of the United States supreme court, who came here on Monday in the interest of the Hamilton Brown Shoe Company, of St. Louis, as the attorney in the case of Grindberg and Morris, had a fight with the junior member of the firm yesterday. Lamar desired an interview, and Morris assaulted him. At the courthouse Lamar again requested an interview. Morris used insulting language, and Lamar struck him two heavy blows, knocking him down, and then stamping his face. Lamar was arrested, tried and acquitted.

WILL OF JUDGE SAWYER.
SAN FRANCISCO, Sept. 17.—The will of the late Judge Lorenzo Sawyer was filed for probate yesterday, together with a petition of the executors, Leland Stanford, Timothy Hopkins and Charles Crocker. A number of bequests were made, and it is stipulated that when his two sons become 25 years of age one-half their shares is to be paid to them. The balance is to be put at interest in good real estate. It is said the estate is worth about \$300,000.

RENEWAL OF AUSTRALIAN MAIL SERVICE.
SAN FRANCISCO, Sept. 17.—R. J. Creighton, local agent for the New Zealand government, has received a cablegram from the postmaster general of New Zealand notifying him that the New Zealand parliament has authorized a renewal of the Australian mail service via San Francisco and New York for the further term of three years. The renewal is for a four-weekly service.

THE BANK ROBBERS.

Albertson and Chandler Captured at Marshfield.

JAMES VICK SUSPENDED.

Fight Between Editors, A Mine Caves in, Another Record Broken, The Armory Annex, Miss Ava, The Fire at S. P. Shops, Railroad Accident, State and Foreign News.

ALBERTSON CAPTURED.

MARSHFIELD, Or., Sept. 17.—Word was here received here from Gardiner, Oregon, of the capture of Edward Albertson, the deputy collector of the Fidelity Trust Co., of Tacoma. Fred Chandler, his accomplice was also captured.

LATER REPORT.—Fred Chandler and Edward Albertson, the Tacoma bank robbers were arrested four miles below Gardiner last night by Chas. A. Lampkins Deputy United States marshal of Tacoma, assisted by W. W. Cochrane of Eugene, and G. W. Moore of Gardiner, and J. T. Thompson of Florence. The arrest was effected by a well arranged plan skillfully carried into execution. Albertson and Chandler were taken completely by surprise, being ordered to throw up their hands. They were slow to comply, Chandler's hands finally went up while Albertson reached for his revolver. Cochrane was too quick, however, and shot simply to cripple the now desperate defaulter, making only a flesh wound. They were now easily captured and taken to Gardiner, where medical aid was immediately summoned. Albertson has the best of care and is resting easily. Chandler talks freely and exonerates all of the others than himself and Albertson from complicity in the robbery but will not give any details leading to the robbery of the bank. Lampkins will take Chandler out by way of Dr. Dr. tomorrow. Albertson will be left in charge of Deputy Sheriff Cochrane until able to be removed.

FIGHT BETWEEN EDITORS.
SULPHUR SPRING, Tex., Sept. 17.—In a fight between E. M. Tate, editor of the Echo and Everett Moore, editor of the Alliance-Vindicator, who have been vigorously attacking each other lately, Moore shot five times and Tate once. Moore is dead and Tate is under arrest.

RAILROAD ACCIDENT.

BAKERSFIELD, Cal., Sept. 17.—The north-bound passenger train, due at 11 o'clock in San Francisco, yesterday morning was wrecked in the mountains between Guard and Tehachapi. Last night the train had stopped to remove rock caused by a landslide and while at work down came a freight train of about thirty cars, some filled with wheat, and ran into the passenger coaches. Colonel William Harney, president of the San Francisco woolen mills, and member of California Commandery No. 1, who was standing on the platform, was killed outright. A. C. Halderman, a traveling man, was considerably bruised and is lying at the Southern hotel. Several others were hurt, including Mrs. A. A. Healy of Los Angeles, and Mrs. Emma Spring, of Lafayette, Ind. A train left here this morning at 6 o'clock with all the wounded on board. The south-bound train is still here waiting for the track to be cleared.

The conductor sent the following dispatch to Superintendent Fillmore, at San Francisco: "I stopped at the east end of tunnel No. 12. There was a slide at the west end, and I sent my brakeman back to flag any train approaching. While standing there with the engine on the slide and pushed into tunnel No. 12. The engine exhausted all the steam and water in doing this. We had to get water and refill, and before we could start, No. 22 ran into us. My flagman had not been called in.

MISS AVA.
CINCINNATI, Sept. 17.—Miss Vera Ava yesterday afternoon closed an engagement with a dime museum to appear on exhibition in their halls and tell visitors about her abduction. She will receive \$300 per week. She will go to Chicago for a two weeks' engagement.

THE TRAIN WRECK.
BAKERSFIELD, Cal., Sept. 17.—Tunnel seventeen near the train wreck, has caved, and another wrecking train has gone up with plenty of heavy timber, but it is thought no trains will get through for two or three days. The jury, at the corner's request, find that Wm. Harney came to his death by a railroad collision last night, being jammed between cars, the cause being gross neglect of attaches of train No. 18 of the Southern Pacific company in not setting hand brakes at the time it was standing at tunnel 15, proving it by testimony that after the train had escaped it was controlled and stopped by hand brakes at tunnel 12; in not sending back and notifying freight train No. 22 that was following, and further, that train No. 18 was sufficiently supplied with men to properly handle it.

LAWYER ALBERTSON BOUND OVER.
TACOMA, Sept. 17.—Testimony in the Albertson case yesterday was unimportant, the witnesses simply corroborating the evidence which had been previously given. The duplicate agreement, by which the

president of the Fidelity Trust company agreed in consideration of the return of the stolen securities not to prosecute Edward Albertson or Fred N. Chandler, his accomplice, was introduced in evidence, being taken from notes of R. B. Albertson's stenographer. R. B. Albertson admitted drawing up the agreement, but denied any knowledge of the crime of who the guilty parties were. Most of the afternoon was consumed in argument by counsel. At the conclusion of the argument Justice Sharp bound the defendant, R. B. Albertson, over to the superior court in the sum of \$5000.

MINER MURDERED.

NEVADA, Cal., Sept. 17.—S. Galavotti, superintendent of the Derlec Drift mine, was murdered by highwaymen this morning while coming to this city with a \$5000 gold bar just cleaned up at the mines. Galavotti and J. D. Ostrom were in a two-horse buggy, ascending the south Yuba river grade, six miles from the city, when a rifle shot was fired from the bank above. The shot entered the back of Galavotti's head, causing instant death. Ostrom struck and urged the horse into a run, holding his companion's dead body in the vehicle with one arm. Reaching the Mount Vernon house, Ostrom left Galavotti's body and hid the bullet in the brush. He then rode to this city to notify the officers. A wagon has just gone out after the dead superintendent's body, and several squads of armed men are starting for the scene of the murder.

JAMES VICK FAIR.
ROCHESTER, N. Y., Sept. 17.—Application for a receiver of the James Vick, seedsmen, corporation, will be made this afternoon and the corporation will be dissolved. Liabilities will amount to between \$175,000 and \$200,000 and assets if advantageous sale of plant is made will be more than sufficient to cover liabilities. James Vick will continue business on a smaller scale.

MOVEMENTS OF BANDITS.

SAN ANTONIO, Tex., Sept. 17.—An authentic report of the ineffectual revolutionary movement in Mexico was received here yesterday. Captain R. L. Sandall, Fifth Infantry, commander of Fort Ringgold, wired General Stanley that the notorious G. G. Garcia had crossed the Rio Grande into Mexico with fifty armed men for the purpose of inciting a revolution. He crossed fourteen miles below Rio Grande City to the town of San Francisco. General Stanley ordered Captain Sandall to take a detachment of cavalry and investigate the case, patrol the river and cut off their retreat in case the band returned. The Mexican authorities at San Miguel have been wired and they are in pursuit of the invaders. Garcia is a professional disturber, bandit and raider. He is a desperate character.

FARMERS' ALLIANCE.

GREENSBURG, Pa., Sept. 17.—The attendance at the state convention of the Farmers' Alliance was very slim, less than seventy-five delegates being present. A platform was adopted, among other things demanding the election of president, vice-president, and United States senators by direct vote of the people. A resolution to endorse the Democratic candidate for state treasurer caused a lively discussion. It was finally decided to place no ticket in the field but allow members of the People's party to choose for themselves from among the candidates of the great parties.

THREE PEOPLE MISSING.
NEW YORK, Sept. 17.—It is more than probable that three persons lost their lives in the fire which destroyed the old Commercial Advertiser building. Friends and relatives of John Adelman, aged 62, a dealer in optician's goods, with an office in the building, reported to the police last night that he was missing. They also reported that the sons of the missing man, Louis and William, who worked with their father, were also missing. No search for the bodies can be made until the ruins have cooled off.

CALIFORNIA HAILSTORM.

FRESNO, Sept. 17.—Tuesday afternoon quite a hurricane passed over this section of country. The wind blew furiously, accompanied by a slight fall of rain and hail. Three or four miles to the west of Fresno it hailed heavily. Hail did considerable damage in some sections, beating down the grapes and fruit, and entirely stripping many vines of their leaves.

MORE FLOODS.

MADRID, Sept. 17.—There was a renewal yesterday of the floods in the Province of Toledo and more damage was done.

PRESIDENTIAL APPOINTMENT.

WASHINGTON, Sept. 17.—The president today appointed Francis Hendrix collector of customs at New York.

MURDER AND SUICIDE.

WOODLAND, Calif., Sept. 17.—The lifeless bodies of Miss May Adams and J. W. Montgomery were discovered this morning, lying in the rear yard of a small, unoccupied residence on College street. It is supposed Montgomery shot and killed Miss Adams, and then suicided. The victims are both of respected parentage. Murder and suicide is the result of refusal on the part of the lady's parents to permit marriage.

MORE BODIES FOUND.

NEW YORK, Sept. 17.—Two more bodies have been identified as the remains of John Adelman and Frederick Hiss, both jewelers found in the Commercial Advertiser building this morning.

CAVE IN MINE.

VIRGINIA CITY, Nev., Sept. 17.—A cave in occurred at Alta mine this morning and five men are imprisoned, their fate is not yet known.

WOOLEN MILLS SUSPENDED.
NEWBERRY, Sept. 17.—The Saxon woolen mills have suspended. Judgements amounting to \$25,000 have been obtained against the concern.

WANT A DELAY.

GUTHRIE, O. T., Sept. 17.—Governor steel and Mayor Spangle have telegraphed President Harrison asking for a delay in opening the lands east of this city.

STATE.

THE P. SHOP BURNED.

PORTLAND, Sept. 17.—The repair building at the Southern Pacific carshops was totally destroyed by fire yesterday.

The loss will foot up about \$40,000. About 5 o'clock Watchman Barker discovered a blaze issuing from the middle of the repair building. On making an examination he found that the flames had enveloped the interior, and that four passenger coaches were burning.

A telephone alarm was sent in to the East Side fire department, which responded as soon as possible, but before a stream could be thrown, the building was almost entirely destroyed.

The efforts of the department were then directed to save the machine shops and tracks, and by 8 o'clock the fire was all extinguished.

The coaches which had been undergoing a course of repairs were completely destroyed, before an engine could be steamed up to remove them from the building. No damage was done to any of the main buildings. The burned building was thirty-six feet wide and 300 feet long and was one story in height. Several thousand feet of fine furnished lumber were destroyed, and the track badly warped. The rails were replaced, however, in time to let the early trains pass. The structure will be rebuilt at once.

The officials of the company refused to say whether the property was insured, but careful inquiry at the insurance offices failed to develop the fact that any insurance was carried. Nothing is known as to the cause of the fire.

EARTHQUAKE IN PORTLAND.

PORTLAND, Sept. 17.—At 8:40 last evening an earthquake shock was distinctly felt in this city. The vibrations were from east to west.

THE ARMOY ANNEX.

PORTLAND, Sept. 17.—The new annex to the National Guard armory, all furnished and completed, was formally turned over to Colonel Charles F. Beebe, representing the organization, by county Judge Moreland, acting for Multnomah county, last evening.

The annex was erected by the county for the purpose of giving the National Guards suitable accommodations for drilling, as they were somewhat crowded in the armory. The annex is oblong-shaped, and has a circular gallery and orchestra stand in the west end. Three thousand people can be seated comfortably. The dedication was witnessed by nearly 5000 people. Many of the spectators were obliged to stand, and craned their necks to get a view of the proceedings. Judge Moreland presided and United States Senator J. N. Dolph was the speaker of the evening.

FOREIGN.

BALMACEA AGAIN.

PARIS, Sept. 17.—A dispatch received here from Buenos Ayres says: Ex-President Balmaceda of Chile has arrived at Mendoza, the capital of the Argentine province of that name.

ANOTHER RECORD BREAKER.

HAMBURG, Sept. 17.—The German line steamer Fuerst Bismarck has broken the best previous record between New York and Southampton. Her time was 6 days, 16 hours and 58 minutes.

The trick is a very smart one, and even the young lady who operates it, and who is apparently created out of solid masonry, cannot see through it. It is very hard to learn how to fix up an illusion at first, but after awhile, and with practice in half a dozen types, a man can combine ideas and produce a great variety of results.—Interview with St. Louis Globe-Democrat.

A Queer Letter Writer.

A member of a wealthy family, the name of the head of which is known all over the commercial world, has a peculiar mania. He is crazy on the subject of letter writing—love letters at that—and writes a dozen or more every day, all to himself.

At noon every day he hands the butler a batch of letters to be posted and receives them at the hands of the same individual at 7 o'clock every evening. He reads them with the greatest manifestation of delight and sits down to answer them after dinner. He has kept this pastime up for a year, beginning with one letter every week and gradually increasing his correspondence to the present batch.

He is a good looking young man of five and thirty, and was as bright mentally as could be desired till his eighth year, when scarlet fever left him little better than a simpleton. If he wrote 1,200 letters a day on the same expensive note paper he uses he could not spend a thousandth part of his father's income. Perhaps the pastime is as good as any he could be engaged in, but it seems just a trifle silly.—New York Commercial Advertiser.

How Different People Buy Groceries.

Says an Asbury Park grocery clerk: "If a woman comes in with a basket and a tin bucket and asks for a print of butter she's from Philadelphia. What's more, these Philadelphia people are the best judges of butter. No cheap or shabby stock for them. They taste it always and can tell more about its manufacture than I can. An idea that many Quaker City people have is in having a basketful of groceries and a 'butter kittle' home with them, when we have wagons to deliver it for them. They appear to be brought up that way.

"New Yorkers ain't particular about butter. They ask the price, tell me to put up a dollar's worth and that ends it. One of their give aways is on eggs and sugar. Always know when they want a quarter's worth of eggs or three and a half of sugar. That's the way they buy at home—so much for two shillings. A Trenton customer will ask for a score of eggs, and a Boston woman gets nervous when we show her our stock of beans. She asks for factory cheese, so I won't make a mistake and give her the imported article."—New York Tribune.

Danger of Drifting at Sea.

Two days out from Valparaiso we had a strange experience. The ships Montreal and Edward Everett drifted into uncomfortable proximity, each moment visibly lessening the distance by which they were separated and increasing the prospect that the vessels would grind each other to splinters. A collision seemed inevitable, and men stood facing each other on the decks with pale faces and a common expression of infant helplessness. And all the while the sea was glassy, the sky placid and the atmosphere beaming with serenity.

As they approached to within half a ship's length, the Everett, as though impelled by a mysterious power, seemed to forge ahead slowly, while the bow of the Montreal swung as slowly to starboard, until, with her jibboom fairly over our port quarter and for a moment foul with our spanker gaff, she swung clear and the two ships drifted apart and out of danger to either.
