THE STREET CAR LINES.

Litigation between the Oregon Land
Co. and the Salem Street Rail-
way Company.

On the morning of Nov. 21 the
Oregon Land Co. applied by its at-
torneys, Boush and H. Jones, for a
temporary injunction to stop sale of
personal property of the Salem
Street Railway Co. by H. W. Cottle
under chattel mortgage.

The papers were served barely in
time to prevent a sale, as the prop-
erty had already been bid in by F.
N. Derby, the manager of the new
company that proposed to take hold
of the lines.

THE COMPLAINT
sets out that Jan. 6, 1891, the de-
fendant Street Railway company to
secure a debt of \$9,986.50 gave its
chattel mortgage to Geo. Williams,
H. W. Cottle, J. A. Baker, B. S.
Cook and H. J. Minthorn.
The State Insurance Co. is also
made defendant, by virtue of hav-
ing another chattel mortgage which
it claims ante-dates the mortgage be-
fore referred to, but which the Ore-
gon Land Co. asserts is an unjust and
wrongful claim. It bears date Dec.
20, 1890, but the Oregon Land Co.
claims it is of no validity against its
claim, as it proposes to show in court.
It bases its claim on furnishing three
cars and ten head of horses at the
request of Mr. Cottle, as secretary
and manager of the Street Railway
Co. and upon the assurance that it
should be secured in the purchase
price of the articles furnished. There
are serious charges made in the
long pleadings on file not neces-
sary to be published.

THE INJUNCTION
was granted and the same will be
heard at the special term of Judge
Boise's court set for Monday, Nov.
16 at 1 p.m.

THE ANSWER
of defendants covers ten pages of
legal cap and is made by their at-
torneys Ford & Kaiser. It denies
that the State Insurance Co.'s
chattel mortgage is in justice and
fair dealing of no validity against
the plaintiff's alleged mortgage of
Jan. 6, 1891. It denies that any of
the money claimed to have been
paid out by the Oregon Land Co.
was of its private funds or that it
had any assurance of security. They
deny that there was any collusion
to defraud the Oregon Land Co.

The whole controversy will now
come before the circuit court and
threatens to become one of the most
complicated pieces of litigation ever
in our courts.

MONDAY AFTERNOON.
Judge Boise spent some time in
hearing motions in equity cases.
All the attorneys were present and
the street railway case will probably
come up before evening. The ses-
sion will not last over two or three
days.

THE WATER LIARS.

No Water Pumped Into the Reservoir
On Fairmount Park.

It is time to quit lying about the
Salem Waterworks. Too much
lying may cause the truth to be told.
There was no foundation for the
report that water was pumped into
the reservoir on Fairmount Park for
the simple reason that no water was
pumped up there. Inspection of
the reservoir Sunday evening showed
not a drop of water in it.

The water never had been in it,
never had poured into it for hours at
\$90 gallons a minute, except in the
brain of the Salem water-liar.
When water is pumped into Fair-
mount reservoir THE JOURNAL will
tell the people so, and they will not
believe it until then. THE JOUR-
NAL is not the best liar of Salem.
Water has not yet been pumped
up the hill or anywhere near up the
hill. A new suction will be run out
into the river before the reservoir
will be used, and it may not be used,
for sometime. It is high time to quit
lying about the waterworks.

In deference to the big undertaking
of the managers THE JOURNAL has
not felt inclined to give expression
to the almost universal complaints
of the public at the Salem water sup-
ply all the past summer. The city
has been poorly served and served
with poor water. This is a
notorious fact. How long this
situation continue no one at present
can say. There have been so many
promises made the public of a bet-
ter service and unfulfilled that there
is evidently a lack of ability to give
a good service or an incompetent
management in charge of the plant.

The Water Co. have had plenty of
time to improve the service but have
not succeeded in doing so. With a
river of pure water, uncontaminated
from any source whatever, this
water company has furnished the
city with a supply of stale, flat and
a good share of the time, impure
water. These are the undiluted
truths about our water service the
past year. How long it will remain
so we cannot tell. The people are
tired of being lied to in place of
getting a good supply of pure water
for their money. It is time to quit
lying and high time our city was
getting better water.
