THE STRAIGHT OF IT.

A Correction From Marion County Alliance as to their Attitude toward the Railroad Commission.

EDITOR CAPITAL JOURNAL: The attention of Marion County Alliance having been called to several errors in THE JOURNAL with regard to the Alliance endorsing the railroad commission of the state, would respectfully ask you to make corrections as follows:

In THE WEEKLY JOURNAL of Dec. 3, you say, the Marion County Farmers Alliance, at its regular monthly session at Salem, Saturday, sustained the Oregon railroad commission in its fight to enforce the law by an unanimous vote.

Please state that the question of sustaining the commission did not come before the Alliance and that no vote was taken on it.

In the weekly of Dec. 10, you say: The Farmers Alliance and the Grange last Saturday endorsed the Oregon railroad commission in its fight to enforce the state laws regulating freight on the railroads. Please state that in so far as the above statement applies to the Marion County Alliance, it is erroneous.

Further in your issue of Dec. 17, you say in reply to a statement by the N. W. Reform Journal in which it quotes part of the resolutions passed by the Alliance. "The above paper should be fair. It should print what the Marion County Alliance, did pass at its largely attended meeting in December."

Please state the Marion County Alliance has had no December meeting until today, that it has passed no resolutions either sustaining or condemning the Oregon R. R. commission and that it strictly adheres to its November preamble and resolution as follows:

Whereas, the Southern Pacific R. R., is openly defying both the commission and the laws of the state, thereby causing endless litigation and increasing the burdens of the taxpayers of Oregon, and

Whereas, the experience of the several states has proven that the R. R. commission is, at best, but a poor excuse for the purpose of regulating freight and fares so as to do justice between the railroads and the people.

Therefore: Resolved, by Marion County Alliance, that we favor the government ownership and operation of the railroads in the interest of the whole people.
