that the result can soon be safely
declared irrespective of their con-
stituents. Last night Senator Per-
kins, of Cuyahoga, declared irrevoc-
ably for Foraker, and this morning
Senator Hawkins, of Hamilton, is out for
Sherman. This is a distinct gain of one for the
Shermanites, as Hawkins has been
constantly claimed by both sides.
The Sherman people this m. insisted
they will have the support of Sena-
tor Lamson, president of the pro-
tem of the senate, but the Foraker
people also claim him, while the
senator himself maintains his posi-
tion of uncertainty. Sherman on
being questioned, said: "I have re-
ceived assurances that Lamson
will cast his vote for me." Strong
efforts are being made by the For-
aker men generally, to induce the
labor organizations throughout the
state to declare for Foraker and
against Sherman. A little excite-
ment was occasioned this morning
by the claim by the Foraker
people that the Sherman forces are
endeavoring to secure the vote of
representative Padney of Cleve-
land, through the influence of
Chauncey D. Pew, who they said had
consented to take a hand in the
fight for Sherman. It was discovered
this morning that Padney would be
deprived of his position as attorney
of the Lake Shore and Michigan
Southern Railway Co., at the town
in which he resides if he fails to
vote for Sherman. The Sherman
people denounce this statement as
malicious and state neither De-
pew nor the railroad company are
interested in supporting Senator Sherman.

frame to be found in the market. Fail-
ing to do this, one has often to nearly
double the expense by having a frame
made to order, and perhaps to spoil
her work by cutting down the panels.
The frame of the screen and the sub-
ject treated must be considered as care-
fully with its relation to the room as
any other piece of furniture.

FOR INSTANCE, A RECESS FRAME IN GOLD

and white with Watteau figures and
landscape on a light silk canvas would
be strikingly out of place in a dining
room or other apartment furnished in
dark tones and with massive furniture.
Its place would properly be in a Louis
XV drawing room or boudoir.
