THE HOP CROP.—E. Meeker & Co. of Puyallup, Wn., have issued their annual hop circular. From it we gather interesting information about this great crop. They say they are able to congratulate the hop growers of Oregon upon the results of the crop of 1891 and the cheerful outlook for the future. Shipments aggregate over 40,000 bales and stocks on hand are variously estimated from 3000 to 5000 bales. Although the quality has been below the average, yet they have found favor in the London market beyond our most sanguine expectation. They say: "As a whole of experience is worth a mountain of theory, we propose to stick by the English method of fighting the hop louse. Much loss has been incurred by the attempt to use the coal oil emulsion recommended by Professor Riley, instead of the quassa wash used by the English growers. We estimate that it will require about 50 to 75 pounds of quassa chips per acre for the season, according to the severity of the attack of vermin. A horse power sprayer, simple in structure, light, but durable, will, with one horse and two men, spray five acres a day and brush away the great dread of expense that at first seizes upon the minds of our growers. Hops forwarded from Washington over the Northern Pacific railroad from Sept. 1 to Dec. 31, 1891, grand total, 34,026 bales. Total shipment of hops from Oregon from Sept. 1 to Dec. 31, 1891, via the Northern Pacific railroad, 7420 bales. We estimate Oregon's shipments via all other lines during the same time at 7000 bales."

A SCHOOL LECTURE.—Prof. P. O. Getz, of the Ashland schools, was in the city yesterday upon invitation of Supt. Grubbe of the Salem schools, and addressed the Salem Teachers' association yesterday afternoon on the methods of education. In his talk the professor dwelt almost entirely upon primary work. His ideas might be summed up as advocating development rather than cramming in child culture. He very emphatically presented the theories of Pestalozzi and Froebel as demonstrated by the kindergarten system, and insisted that the best results could be obtained through more heart work and less of cut and dried routine. Prof. Getz stands high in this state as an educator, and it is gratifying to know that he spoke in the highest terms of Salem's schools and their management. His compliments bore especially upon the practical features of the work, such as discipline, the orderly conduct of the children in marching through the buildings, and encouraging the children in hearty understanding rather than in ritualistic methods. He also emphasized the necessity of employing trained teachers, saying that like the poet they might be born for the work, yet needed thorough training to be successful. The thanks of all present were gracefully tendered by Mrs. Grubbe for the enjoyable and instructive talk.

IT MUST GO.

The Electric Railway to the Rural Cemetery—Commercial Street Viaduct Indispensable.

Contracts are being closed by the Capital City Electric Railway line for its extension to Rural Cemetery. All work is to begin February 1, 1892.

The reputation of this company leaves no room to doubt that before May 1st its cars will be running on its South Salem extension. The company is having plans made and will contract for a separate trestle over South Mill creek, as it does not consider the present bridge safe if it could use it, which is impossible.

VIADUCT NECESSARY.

The Commercial street viaduct now becomes an absolute necessity, or we must allow the electric company to erect another trestle work, and run its cars around the present bridge site. While a \$20,000 or a \$30,000 solid arch stone viaduct may not be within reach of the city, an \$8500 or \$10,000 steel bridge resting on a stone pier at each end, is obtainable.

The electric railway company and property owners still express a willingness to assist in building the viaduct, and the city council should not overlook this fact. If the railroad company is allowed to go ahead and put in its own bridge, the opportunity for immediate co-operation is lost. This is an important matter and the proper attention should be given it.

THE JOURNAL has canvassed the matter some and its reporters find a practically unanimous sentiment in the city for this improvement. There was no opposition in the last council, except that no proper arrangement could be made for the finances. It is believed the financial difficulty can be overcome by the new council and that no time will be lost in pushing this improvement.

A SUBSTITUTE APPOINTED.
