This Government Accepts Chili's Apology.

WILL CHILL SALUTE OUR FLAG.

Gives Satisfaction, The Deep Water Canal, What England Thinks, Took the White Veil, Fatal Accident, Butler's Book, A Murderer's Death, Train Wrecked, Killed in a Mine, The Thirty-Third Degree, About Garza, Foreign and State News, Etc.

GIVES SATISFACTION.

VALPARAISO, Jan. 30.—The United States acceptance of Chili's reply to the ultimatum, has given great satisfaction here, and exchange has risen 1/2 pence.

WE ACCEPT CHILL'S APOLOGY.

WASHINGTON, Jan. 30.—Secretary Blaine cabled Minister Egan this morning that this government's acceptance of Chili's answer to our ultimatum, in accordance with the president's message of the 25th inst. The salute to the flag was not mentioned.

MUST SALUTE THE FLAG.

NEW YORK, Jan. 30.—The Herald's Washington special says: President Harrison will send today another ultimatum to the little South American republic. In substance this cable was sent from her by Blaine yesterday morning.

"President Harrison accepts Chili's apology in the broad and generous spirit in which it was offered."

A cable to this effect will follow: "While Chili's apology is in terms all this country could ask, yet there is one thing more to be done before the dignity of the United States is fully satisfied. Chili must salute the stars and stripes."

WASHINGTON, Jan. 30.—There was nothing said at yesterday's cabinet meeting on this subject and there is no reason to believe this government will require a salute from Chili.

THE CRISIS IS OVER.

LONDON, Jan. 30.—The Times dispatch from Santiago de Chili says a short official dispatch from Senator Montt, the Chilean minister to the United States, was read today in the senate and chamber of deputies and confirms the unofficial report that the crisis between Chili and the United States is ended. The Times dispatch also says the message of President Harrison to the American congress was read in the lobbies, but neither the American message nor the official dispatch or Minister Montt caused much comment.

WHAT ENGLAND THINKS.

LONDON, Jan. 30.—The Saturday Review, in an editorial apparently inspired by a friend of Lord Shackleton, says: The conduct of the United States in the Chilean matter is only another version of the Sackville West incident. In characterizing it as cheap and wanting in dignity we recognize that its changes have point, and would be felt if made against statesman or gentleman. But we are not aware that the machine politicians of the United States are either. They have acted toward Chili as they have repeatedly acted toward us when they knew that bounce and bluster were without danger. It must console Chili to know that the dime museum heroes of President Harrison has since been made to look utterly ridiculous. We, who have often suffered from having to endure this same underbred swag, certainly learn with unaltered amusement that Chili's apology was received before the president's thundering message was issued. The so-called American humor is as often as dull as it is vulgar, but Americans have enough sense of the ridiculous to see the absurdity of the situation. It is like the story of the gentleman who announced boldly that he would kick the door open or die, when he had every reason to believe that there was no enemy behind it.

FAVORABLY DISPOSED.

NEW YORK, Jan. 30.—The Herald's Santiago, Chili, special cablegram says: "A cable dispatch was received yesterday morning from Minister Pedro Montt at Washington, in which he says that he is now assured that the government of the United States is favorably disposed to that of Chili, and is content with Minister Pierrera's reply. Senator Pierrera read Senator Montt's dispatch at the session of the senate yesterday afternoon. Nothing was said in the dispatch relating to the question of future arbitration and indemnity, but Chili will certainly pay whatever indemnity is agreed on. Little is heard either in Santiago or Valparaiso but expressions of satisfaction at the peaceful solution of the trouble. There is no doubt that up to yesterday the utmost anxiety prevailed, but now it has been relieved. Minister Egan congratulated him on the successful termination of the negotiations. Judge of Crimes Foster, of Valparaiso, will today pass sentence on Gomez Honada and others for the killing of Riggen and Turnbull and assaulting the members of the Baltimore crew.

TOOK THE WHITE VEIL.

ACOMA, Jan. 30.—The white veil of the order of Nuns of Visitation of the Catholic church, was bestowed for the first time on the Pacific coast yesterday in this city, at the Visitation convent. The veil was taken by Miss Rose Ryan, daughter of Matthew Ryan, a wealthy pork packer of Cincinnati. The ceremony was conducted by Father Hylebos, of St. Leo's church, who is vicar general of the Catholic church for Washington. The young lady took the vows of seclusion of a lady teacher of the academy. After the ceremony a reception was held in the convent chapel. She will be known as Sister Mary Agnes.

FATAL ACCIDENT.

SEATTLE, Jan. 30.—Willie Jackman, an 11-year-old boy, was killed yesterday at Maydenbauer bay on Lake Washington, by a stump falling on him. Another boy had his leg broken in the same accident. The boys were playing at recess in a lot that was being cleared for a new school house, and a half-burned stump was tipped on them while they were hiding under it. The boy's head was driven into the ground, and he was dead before he could be got out.

BUTLER'S BOOK.

BOSTON, Jan. 30.—"Butler's Book" was issued yesterday. In the preface the general gives as one reason for the publication, "to correct much wrong done myself as prejudiced representation of facts, and circumstances as to my own aims in the service of the country."

Gen. Butler asserts that Salmon P. Chase sent him at Fort Monroe to solicit him to accept the vice presidential nomination of the Republican party in case Chase secured the first place, and that Simon Cameron made a similar proposition in behalf of Lincoln less than three weeks afterwards. He gives his reasons for the refusal of both offers. He maintains his position taken in the controversy over the conduct of the late Admiral Porter at New Orleans, and declares that the latter acted untruthfully and villainously; also charges that Porter and his subordinates were guilty of the powder boat plant at Fort Fisher. He asserts that Grant was drunk before Peterburg, and criticizes Smith severely. He closes his work with a summary of the things done by him, and says that in all his military movements he never met with disaster or uselessly sacrificed the lives of his men.

A MURDERER'S DEATH.

NEW YORK, Jan. 30.—The Sun yesterday publishes a long article in which it says that Stanislaus Padowski, who, December 18, 1890, murdered in the Hotel de Rade at Paris, General Michael Desolavertoff, chief of the Russian secret police of that city, lies buried in a suicide's grave in the potter's field at San Antonio, Tex. The story details Padowski's act of nihilistic vengeance, the plot that preceded the assassination in Paris by the help of two newspaper men, his concealment by students in New York City and his suicide, as it is called in Texas, the victim of poverty and of terrors that may or may not have been terrors of the imagination only. The life, work and death of General Desolavertoff are matters of history. The escape from Paris of Padowski, through the aid of Dr. La Bruddere, Mme. Duquerroy and M. and Mme. Grezou, has also been fully detailed. Dr. La Bruddere accompanied the assassin to Trieste, where he left him. From there Padowski made his way to England, where he took passage on the steamer Etruria and arrived in New York on February 18, 1891. Here Padowski was cared for by the socialist agitators. He was known as Otto Heiler, under which name he had registered on the steamer. He was taken to a house in Fifteenth street, New York, where he remained in seclusion for some time, and the agents of the Russian and French police got close on his track. When this became known he was taken from the house on Fifteenth street to a small town in New Jersey. Here he remained concealed until March 4th, when he was put aboard a steamer for Texas. He carried with him a letter of introduction to some persons who lived in San Antonio, Tex. In this letter he was referred to as Otto Hauser, and the San Antonio people never knew that he was the noted and hunted assassin, Padowski. His San Antonio friends secured for Hauser a place as a workman in the employ of a man named Schroeder, near Selma, Bexar County, Tex. He worked here for two months, and after that secured employment in various places near San Antonio, but finally he could get nothing to do, and he seemed to be at the end of his resources. He was expecting a registered letter all the time towards the close of his life, but it never came. In the last three days of his life he seemed to be in an utterly hopeless condition. He showed signs of great fear when on the street, and there are indications that he was losing his reason, or had made a startling discovery of some kind which had terrified him. At dawn on the morning of October 30, 1891, his body was found in Maverick Park. A small pistol lay within the outstretched hand, and there was a bullet hole nearly in the center of his forehead, which had caused his death. He was buried in a pauper's grave in San Antonio, and it was not known by those in this city who had befriended him what his fate had been until some time afterward. They now make public through the Sun the fate of the noted criminal, which has, for so long a time, been a matter of conjecture.

FAILURE FROM ROBBERY.

NEW YORK, Jan. 30.—The failure of A. Peabody & Co., wholesale jewelers, of 184 Broadway, which was announced yesterday, created a sensation on account of the cause to which it is attributed. The firm claim they were forced to suspend because thieves had robbed them of their assets. Five weeks ago Mr. Peabody says his son, while in St. Louis on a business trip, had a valise containing \$25,000 worth of stones stolen. The thieves were arrested, but the gems were not recovered.

ENGAGED TO ONE, MARRIED ANOTHER.

WASHINGTON, Jan. 30.—My Mrs. Sanders Johnston, widely known as Marie Decca, prima donna, was quietly married in this city to Francis L. Christian, her manager. An element of sensation is given to the affair by the fact that she had ordered a tressau for marriage to a wealthy citizen of Richmond, who, however, insisted on her leaving the stage, hence the broken engagement.

CANADIAN BOODLERS.

MONTREAL, Jan. 30.—The royal commission investigating the charges of corruption against the late Quebec government has convened here. Brokers Daley and Seneca, who had acted for parties having accounts against the government, testified that they usually got 4 per cent commission for their emoluments went to Montreal political agents of the government and ex-premier Mercier's son-in-law, Grovin.

THIRTY-THIRD DEGREE.

CHICAGO, Jan. 30.—To few men is given the thirty-third degree of masonry, and rarely is a special one called in order to give it to one man. The honor was yesterday conferred upon Thomas W. Palmer, president of the World's Columbian commission. A special session of the supreme council of the sovereign grand inspectors-general, thirty-third degree, Ancient Scottish Rite of Free Masonry, from the northern Masonic jurisdiction of the United States, was called to allow the candidate to take the initiation. When he had successfully performed the task sixty of those who had gathered from various parts of the country to witness it adjourned to the Wellington hotel, where in honor of the event an elaborate dinner was spread.

TRAIN WRECKED.

SYRACUSE, N. Y., Jan. 30.—A terrible wreck on the New York Central freight track, a mile west of DeWitt, occurred soon after 5 o'clock yesterday morning. A freight train, drawn by engine No. 485, Charles Crady, engineer, slowed up at Messina Springs crossing to pick up a flag, and just at that time the freight train drawn by engine No. 483, which was following, crashed into the rear end. No. 483, being a powerful engine and running at the rate of twenty miles an hour, tore through the caboose and six cars spreading the wreck on both sides of the track. It claimed the crew on the first train were asleep, as only those men were injured. Conductor John Welch, of Clyde, had both legs chopped off, Middle Brake-man William Cox, of DeWitt, was killed, and Flagman Patrick Welch, of DeWitt, is suffering from severe scalp wounds and internal injuries.

KILLED IN A COAL MINE.

STAUNTON, Va., Jan. 30.—Thursday morning a terrible accident occurred at the Bush Run coal mines, Fayette county, W. Va. While the process of blasting was going on, by some misadventure, a blast, owing to a defective fuse, went off unexpectedly, killing five men, and wounding five, all colored laborers—ten hands employed in the mine all killed or wounded. They were brought to Staunton. The coal mine was owned by Howard & Eslinger. The nearest place to it is Red Ash.

SEAT DUBOIS.

WASHINGTON, Jan. 30.—The senate committee on privileges and elections will submit a report to the senate Monday, recommending to the senate that Dubois, of Idaho retain his seat.

SELECTING U. S. SENATORS.

WASHINGTON, Jan. 30.—House committee on election of president vice president and congressman, by a formal vote, today approved the principle that United States senators should be elected by the people of the respective states. The question details an amendment to the constitution to the effect that the purpose be referred to a special meeting to be held next Wednesday.

SHOT HIMSELF.

NEW YORK, Jan. 30.—Julius Somborn, a wine merchant, was shot today by his cousin, Jacob Somborn. When the police attempted to arrest Jacob he killed himself. Julius Somborn had frequently given his relative pecuniary assistance. When Jacob came into the store today he made a demand for \$25, which was refused and led to the shooting. Julius was only slightly wounded.

HER SON A PRINCE. CITY OF MEXICO, Jan. 30.—Mrs. Alice Green Iturbide, who was married to a son of Emperor Iturbide, died today. She was the mother of Prince Augustin Iturbide, who was sentenced to a year in prison for disrespectfully speaking of the administration of President Diaz, and contracted the disease of which she died while nursing her son during his incarceration.

WOODS WILL BE CONFIRMED.

WASHINGTON, D. C., Jan. 30.—No further hearings will be held by the senate committee or judiciary in the matter of the confirmation of Judge Woods, as one of the new circuit judges. Said committee will report favorably upon the confirmation of Judge Woods.
