BIOGRAPHICAL.—A friend at Silverton sends us the following additional facts about Mrs. Eastham, who died at that place of pneumonia: "Deceased was born in Jersey county, Ill., Feb. 15, 1830. She was a daughter of Benjamin Cleaver, who recently died near Lebanon. In company with her parents she crossed the plains to Oregon in 1848, and in March of the same year was married to W. F. Eastham. The fruits of that union were six sons and five daughters: Senator Edward L., who died at Oregon City January 18, 1891; J. E., of Salem; Ernest, who died in Linn county, October, 1891; Dr. A. B., of Vancouver; Junius and Orange, of Silverton; Mrs. Prof. VanSoy, of Portland; Mrs. Viola Thompson, of Dayton, W.; Misses Ivy and Ruby, of Silverton. All of these children now living were at the family home in Silverton at the time of her death. In 1850 Mr. and Mrs. Eastham took up a donation land claim near Monitor Mills, in this county, and resided on it forty-two years. Last fall they disposed of one-half the old homestead and removed to Silverton, hoping to there pass the remainder of life, but Mrs. Eastham was taken sick about three weeks ago and her age made her case almost hopeless from the start. The whole community mourns the death of Mrs. Eastham, who embodied the true goodness of the lady with the great sympathy and open hospitality of the pioneer."

ORGANIZED.

A Local Board for Works of Charity organized.

Following gentlemen met Friday night at the law office of Ford & Kaiser for purpose of organizing a city board of charities as projected by a number of Salem clergymen: W. L. Wade, D. C. Sherman, Frank E. Hodgkin, W. M. Kaiser, J. B. Stump, E. W. Jones and C. G. Griffin. The committee on constitution presented a report, which was adopted.

The following gentlemen were elected as permanent officers of the organization: W. L. Wade, president; D. C. Sherman, vice-president; Frank E. Hodgkin, secretary; A. N. Bush, treasurer.

Executive committee—W. L. Wade, Charles Claggett and J. E. Stupp.

Finance committee—D. C. Sherman, W. M. Kaiser and E. W. Jones. This movement should meet with the cordial support of all who are able and disposed to assist in organized work for the relief of the poor. There are hundreds of workmen in the city who are out of employment and who ask only to be given employment. These men and their families deserve consideration as well as the destitute, because to assist them will prevent sickness, suffering and destitution.

PUSH THE VIADUCT.
A Stone Arch Bridge Could be put up for \$10,000.

The street committee that reported on the Commercial street viaduct favored the construction of it and bore the expense as it was represented to cost \$30,000. The stone arch work was figured at \$8 a perch. It is now learned that the work can be done at \$3.50 a perch. It is believed the bridge can be put in of rock and steel for \$8000 to \$10,000. With the help that can be had that is now in sight the city can get it for still less.

Every true friend of public improvements should join in the effort to secure the immediate construction of the Commercial street viaduct. Now is the time to do it, not five years from now, when in place of securing help from the Capital City railway it will cost the city money to get its trustees removed and may have to sue the company to force it to move its track.

The Street Railway Co. is understood to be prepared to pay a good share of the expenses of the Commercial street viaduct. The city certainly can never again have so much assistance to build that bridge as now. Push the viaduct!

BAD APPROACH.—The new bridge recently built over North Mill creek, on Liberty street, is said to be a fine structure, but sadly wanting in the approach on the south end. This has been an expensive bridge in the past and should be so protected as to save the structure for the future. This approach should be filled properly and all possible safeguards against washing or caving should be made.

RETALIATION.—Out of the knocking down of one Thos. Holland by Wm. R. Anderson in his saloon last fall, there grew a civil damage suit by the former for \$10,000. Now comes Anderson and goes Holland \$2000 better, suing him for \$12,000 for knocking Anderson down on State street shortly after. It will be a case for the lawyers to settle which knock-down shall be the more costly.

He went in front of his residence and fired his revolver, when he was arrested and testimony will be taken to have him keep the peace, as Clark avers he is afraid of his life.

ILLEGAL LIQUOR SELLING.
Is what three women of ill fame, Stella Wilson, Edna Homer and Ida Chase, are charged with. They were brought before Recorder Goodell near midnight and will have hearing at three p. m. The complaining witness is John Wright, bartender for Mel Hamilton and he cites a list of witnesses, whom the defendants have expressed a desire to be confronted with. The usual result in these cases is a fine and costs of \$15 apiece. In this case the saloon keepers become the informants against unlicensed sales and propose to enforce the law to secure their own protection.

CHINESE SCHOOL TAXES.
Collector Simpson Makes a Raid on China Town—Mongolian Tax-payers.

School Clerk Simpson has had a funny experience collecting school taxes of the Chinese of this city. Of course, only the business men among them pay any taxes. As a rule, they are very prompt. The tax list of Salem Mongolian merchants is not large. Here it is with each one's assessment:

In all they pay \$18.50 tax.	

There are two of Sun's children enumerated, but none attended school. The first day the collector went among them he could not get a cent. Friday he took an assistant along who claims to be an expert at collecting from the Chinese. But it was the same. They all said: "No sale!"

At last one of the more intelligent said it was their New Year time and it was against their principles to pay during that sacred season. They have now arranged to pay up the first day after their celebration is over.

BLOODED HORSES AND DOGS.
A Carload Arrives From Kent, Washington—To Make the Season at Salem.

A carload of blooded trotting horses arrived in Salem Friday evening, that represent \$20,000 coin. They are accompanied by the owner, his family and grooms and a fine collection of prize-winning English and Irish setters and fox terriers. The proprietor Mr. Van Boekeln and family are quartered at Hotel Willamette and the stock is at the Farrar warehouse on Water street, which is being refitted with box stalls to receive the pedigreed scions of royalty in horseflesh.

At the head of the stud is Holmdel

5290, a seal brown stallion that cost \$6000 at auction and on which there is at present a somewhat fancy figure. He is a dovetail gentle beauty, with a skin like silk a record of 2:24, and 2:25, at 3 year old. He has a pretty Abdallah head and the high-toned blood of Maud S. In his veins, "Celtic" is next—a golden sorrel worth \$5000, of Green's Bashaw and Vermont Blackhawk blood. He is a sure sire, has made his only race in 2:50. There are two colts and two brood mares with foal by Celtic. The mares are by Ira Wilkes, and Italian Boy. Besides these there are Walter, (a trotting gelding by Royal Farnought), with a mark of 2:38; Oliver Goldsmith, and Governor by Green's Bashaw, with a mark 2:24, and a long distance record superior to any horse ever shown in Oregon. The proprietor is a thorough gentleman and will be pleased to see horsemen and those desiring to breed roadsters. A pedigree of Holmdel and Celtic has appeared in THE JOURNAL and announcements of record and term will be made later. After making the season at Salem the track horses will go upon the circuit.
