PAVING STREETS.—W. C. Cassell, of Albany, publishes in the Oregonian a letter on paving material. He says: "I wish here to call the attention of our city council, and especially your city engineer, to brick as a paving material. It is being used largely in the Middle and Eastern states, and is growing in favor wherever in use. It is the coming pavement. It is more desirable as a paving material than all others, for several reasons. It costs less to make; it costs less to keep it in repair, all work being done by common labor. It is noiseless; it is not slippery; it is clean and healthful, and is next to granite in lasting qualities. For verification of this I will refer to Winchester, W. Va.; Peoria, Bloomington, Champaign City and Quincy, Ill. The latter city contracted last year to have twenty streets so paved. Also will refer to D. V. Purrington, of Chicago, or Anthony Itiner, of St. Louis, who will freely give information. These places are not in Europe, but can be quickly visited, and the matter fully investigated, and should be. Also the manufacturer at Galesburg, Ill., should be consulted. 'Vitrified paving brick' is the thing to use. It requires a particular kind of clay to make paving brick, but in Oregon we have all kinds of clay. I may in a future issue have something to say as to the manner of constructing this kind of pavement, and present for inspection samples of brick that will be in every way desirable."

THE VIADUCT GOES!

Property Owners Aroused and Come to the Rescue.

THEY WILL CONTRIBUTE \$2000.

The Electric Property Owners and County Will Assist the City.

Hon. Ed. Hirsch, Alderman Johnson, John G. Wright and other prominent property owners on South Commercial street, have held a conference and decided to offer the city council two thousand dollars, at its next session, towards building the viaduct.

THE RIGHT SPIRIT.
That is the right spirit to secure the enterprise. These business men know that it would be a good investment for the city and for themselves. They know that the removal of the old moss-covered shed bridge and throwing a full street width stone arch bridge over the creek would be a noble improvement and an extension of Salem's first business street south in a most effective manner.

IT WILL GO.
There is now no good reason why the city shall not build this viaduct. THE JOURNAL feels proud of the enterprise with which the property owners have met the advances of the city officials. All should pull together now in good faith and let the council at its next session order the work to be proceeded with.

K. G. ASSOCIATION.—There is to be a meeting held this Friday, evening at 7:30, at the Kindergarten school room, (formerly Unitarian hall), opposite Reed's opera house. A number of Salem ladies have canvassed the city in behalf of the new educational system. The enrollment at Miss O. Ballou's school has grown to nearly forty children and she has two assistants. These ladies have not only worked up this attendance, but have enlisted many others to support the work of free kindergarten for Salem. At the public meeting this evening consultation is to be had to further spread the work. The precious years of childhood when the most lasting impressions are made, and most important influences are exerted, are now to a large extent lost so far as education is concerned. They do not go to the public schools until they are five, six, or seven years old. There they are taught in rooms of fifty or seventy to a teacher. Excellent as the public school system is, there is a system almost infinitely better. It is this latter that is to be considered at the meeting this evening. All are invited to attend. The meeting is for fathers, mothers, teachers, citizens and all who love our country and its childhood and would see both preserved to nobler possibilities. The kindergarten work is universal in its principles and application and knows no sect or creed.

KINDERGARTEN RALLY.—The first step is to be taken this evening at the hall opposite Reed's opera house to organize a kindergarten association. The one kindergarten school now in the city has three teachers and is self-sustaining. There is no reason why every little child in the city should not have the benefit of the new education which develops not alone the head, but the heart and hand, the eye and ear, as well. Let there be a good attendance at the old Unitarian hall.

UNANIMOUSLY SUSTAINED.—Thursday evening at the prayer-meeting of the Congregational church the trustees submitted resolutions expressing their confidence in Rev. C. L. Corwin, declaring that the church will stand by him, and believes him innocent of the charges preferred in a Portland paper recently. The room was crowded with people, and the resolutions were adopted by a rising vote.

SCARLET FEVER SCARE.

Several Light Cases at North Salem—An Inspection of the Schools.

There are a small number of mild cases of scarlet fever in North Salem, some within a few blocks of the school house.

Children of families where the disease has a foothold have all been excluded from the schools. Several red flags are out and some families are keeping children at home. If there are no deaths and there seems no likelihood of that, the scare will blow over in a few days. The families where it has appeared even in mild form should be rigidly quarantined and kept from contact with the school children. Right here it may not be wrong to say that a good common sense health officer would not be an altogether useless official in the city of Salem.

AT THE SCHOOLS.
The reporter found no signs of danger. All is neat and clean. The basement floor on the girls side is damp at one end and inquiry shows the drain tile either were not properly laid or have no proper outlet. The well is sixteen feet deep and water comes up through cemented joint sewer pipe, so that nothing can get in but from below. The closets are remarkably clean for a school house, but there is no sewer connection. The closets are nearly full and smell badly. A sewer should be ordered built at the annual meeting.

THE GOVERNOR'S OPPORTUNITY.

In its efforts to make a point against THE JOURNAL, the Portland Telegram gives itself away. It also gives away the Democratic politicians of this state who are more anxious to make capital for political purposes, against our senators or any one, than they are to open the Columbia river. Judged by the test of earnestness and sincerity and singleness of purpose to give the people water competition and open and free rivers to the sea, these politicians will be discarded by the people, as they should be. Their desire to down some one who has an office that they want for themselves is so much greater than their desire to serve the people that the people can see through their thin disguise of clamoring for open rivers and realize that there is nothing in it.

So THE Telegram in saying that THE JOURNAL is blaming the governor "for the present situation," whatever that may be, reveals the twinges of a bad conscience on the part of the politicians it would defend against a charge that has not yet been made. The Telegram cannot quote THE JOURNAL in blame of the governor for the "situation" so far as the portage railway is concerned. THE JOURNAL has not yet blamed the governor for the present contingency, but the people of Eastern Oregon and the whole state will blame him very severely if a year is frittered away trying to get something from congress of which there is not any hope whatever, and then try to blame it on the Republican senators who will never get an opportunity to act upon the matter for the simple reason that the Democratic house will never pass a \$431,000 appropriation for a portage railway at The Dalles, and the Democratic politicians know it.

If Governor Pennoyer wishes to put the Republican legislature on record in this state, let him call a special session for the purpose of providing a portage railway, and if they refuse to do so, Governor Pennoyer will have nothing to lose, to say the least, and all to gain thereby.
