GLUT IN THE COAL MARKET.

Prospect That Low Prices Will Be the Rule.

SAN FRANCISCO, April 1.—A local coal broker, in reviewing the market, says: "Since the sailing of the last Australian steamer there have been the following arrivals from Sydney: The C. F. Sargent, 2320 tons, and Alex McNeil, 1537 tons. No arrivals from Newcastle. These very light arrivals within the past four weeks should help to better prices, whereas the market is in a much more condition than when the last mail left. This is caused by overstocks on hand and free arrivals from coast mines, together with liberal offerings of English and Australian for future deliveries at lower figures than at any time last year. With these in view, the wholesale dealers are afraid to order, and no largest consumers feel assured that fuel will remain low during the year and show no desire to purchase ahead of their immediate requirements. This brings business to a standstill for the moment, as very few contracts are being made. Every one in trade is amazed at the low prices named for future loading and with figures named for future grain freight when these coal carriers shall arrive here; it is sadly at variance with all past records of business."

"It would be supposed that the present quotations would force coal products out of the market."

"Such is not the case, as they are shipping liberally at prices that must leave a very small margin for profit, but they are so circumstanced that they must keep the mines working."

BISMARCK'S BIRTHDAY.

The Veteran German Statesman Congratulated.

HAMBURG, April 2.—Prince Bismarck was 77 years old yesterday, and in this city, as throughout Germany, the anniversary was celebrated with enthusiasm. Bismarck is at Frederichshagen with the prince, his wife, his son, Count Herbert and the countess. The prince has recovered from his recent attack of illness and was able to enter with interest into the events of the day. Early in the day the reveille was sounded under the window of the prince's apartment by the Ratsberg Jäger. Every train brought large numbers of delegates, including several Hamburg guilds and representatives of organizations in all parts of the empire. Tenants of the estate have testified their loyalty by birthday gifts, more acceptable to the prince from sentiment than value, and messengers were kept busy in the deliverance of telegrams.

DETAILS OF THE STORM

Which Prevailed in Kansas and Missouri.

THURSDAY'S TORNADO.

Telegrams Coming in from All Parts.

KANSAS CITY, Mo., April 2.—Specials from St. Louis, Horton and Lawrence, Kansas, and Dolan and Marysville, Missouri, report great loss from Thursday's tornado. Towanda, a small village thirteen miles from Eldorado, of 1300 inhabitants, has not a house standing. Of 50 families, there is not one but is sorrowing for dead members or friends lost in the storm. Six persons were killed outright and several so badly injured that they can not live. The killed are Herschel Cupp, William Bartley, Dr. D. Godfrey, an infant child, John Blake and James Bailey. The fatally and seriously injured number twenty-five.

At Strong City, Kansas, the storm raged furiously. The house of James Glasse was completely demolished and Glasse, his wife and child were killed outright. Several others were injured, but none fatally.

At Olathe, Kansas, the general store of Mariner & Marvel was partially wrecked by the storm, farm houses and stables were unroofed but no one was injured. At Marshall, Mo., considerable damage was done, the cupola of the Methodist church was blown down, plate glass windows blown in and roofs carried away. At Salina, Kan., a house was carried from its foundation and wrecked, the family were at supper at the time, all being more or less injured. One daughter had her leg broken, another hurt about the back and with internal injuries. Neither are likely to recover. The name of the family is Brother. A young man was badly injured also, being bruised about the head but not fatally. The house of Samuel Buckholder was demolished, but the family escaped injury. Mrs. Zimmerman took refuge in the cellar of a house which was demolished and Mr. Zimmerman was fatally injured.

At Ottawa, Kan., the Water company's tower toppled over, trees were uprooted and much damage was done to orchards. At Warrensburg the Methodist church was unroofed and the cupola blown down. At Chillicothe, Missouri, the cupola of the Methodist church was blown down and the building unroofed, no one was hurt. At Kansas City, Kans., Annie Connors aged five years was thrown violently to the ground by the wind and had her hip crushed. At Chillicothe, many houses were unroofed and the house of James Potter, at edge of town was demolished but the occupants escaped injury.

The house of John Moore was leveled to the ground and Mr. Moore and one child killed; the others escaped. John Burmaster's house was crushed like an egg shell, and his whole family killed, consisting of a wife and three children. Mrs. Frank Sheppard was killed by flying timbers. Others were injured in the storm, but it is believed that no more fatalities have occurred. Eight miles north of Wellington, the house of J. H. Showalters was demolished and the whole family of thirteen members were injured, none however, fatally. John Little and wife, living four miles north were killed.

More Details, Though it is Difficult to get News.

MORE OF THE STORM.

In Nebraska, Kansas and Missouri.

KANSAS CITY, April 2.—A tornado swept over Kansas Thursday night. Butler county seems to have suffered the greatest havoc. Tonawanda was wiped off the face of the earth, and Augusta, a few miles distant, buffeted out of all semblance to its former self. No house or building is left standing in Tonawanda. The town was asleep when the storm swept down, and not a house or building was left standing. The storm raged everything in its path, and left dead bodies lying in its wake. Four have been recovered from ruins searched. Twenty persons are fatally injured and forty more or less seriously, besides a large number slightly. At Augusta, Herman Hawkins, Jas. Rains, and infant child of Will Rhodes were killed outright. Fifteen others were hurt more or less seriously. The wires are all down, and it is impossible to get a detailed account from either place.

In Kiowa, the Missouri Pacific depot and a number of buildings were demolished. Though no loss of life is known, several mishaps are reported. The damage to property is great. At Wellington, William Little's house was wrecked, Little and his four children were killed. Joe. Walter's house was carried from its foundation, and thirteen inmates more or less injured. Butterworth's house, with its occupants, was carried several hundred yards, and some fatally hurt. From indications the storm swept across the country from the Indian territory through Barbour, Frazier, and Sumner counties.

Chicago, April 2.—At 6:30 last evening, the sky, which had been threatening all afternoon, became densely black. In another moment a cloudburst occurred. The wind, which blew a hurricane rate, swept everything before it. At the corner of Halstead and Duane streets, the cyclone blew down a seven-story brick building surrounded by one and two-story frame buildings, which were crushed to the earth, killing three persons and fatally or seriously injuring many others. In Thomas Hulet's house, immediately in the rear of the seven-story brick building, the family were all at supper when the seven-story building fell and crushed the Hulet residence. Of thirteen at the table, the 6-months' old baby of Hulet was crushed into a shapeless mass. Others were plucked under the broken timbers and brick, and soon rescued. Those instantly killed were Horace Mott, aged 5; Eddie Mott, aged 2; and David Hulet, aged 6 months.

OMAHA, April 2.—Telegraph wires all over the state are prostrated and it is difficult to obtain news to any extent of yesterday's storm. The Western Union Telegraph company has but one wire in operation in Nebraska, that being along the Elkhorn road. The storm traveled 150 miles of the richest farming section, dotted with small cities and villages. Tornado continued in Kansas and Northwest Missouri, but was less destructive. Southeastern Kansas was also visited by one of the most destructive storms in years.

Sent to a Private Asylum.
MILWAUKEE, April 2.—For some time it has been quietly talked among the friends of Marian V. Dudley, the poetess, that she was consigned to an insane asylum without proper examination. Thursday the state board of control was in the city, and it was said that the members came for the purpose of investigating the complaints made by Mrs. Dudley herself relative to her confinement in a madhouse. She claims perfect ability to care for herself and alleges that she was committed with the object of giving to other people the control of her property which is said to be valued at \$10,000. The complaint as to the mental condition of Mrs. Dudley was made by her aged husband last January, and after a private examination by the physicians she was committed to a private asylum without a jury trial and without an opportunity to be heard in her own defense.

French Man-of-War.
SAN DIEGO, April 2.—The French man-of-war Champlain arrived yesterday. The vessel arrived from Calais, stopping at Acapulco and Manzanillo. She will remain till Tuesday, and sail for San Francisco to stay a month.

Revolution in Venezuela.
NEW YORK, April 2.—The Herald yesterday morning has Caracas, Venezuela, advices from official sources which say that the revolutionists are reported to be in full flight on the road leading from Valencia. General Crespo's forces are said to be completely disorganized and panic-stricken, and Crespo himself is reported to be fleeing on horseback toward Guanare. In official circles, the dispatch adds, a strong anti-American feeling is apparent, and foreigners are seeking refuge in the different consulates.

Advices from the insurgent side have a different story to tell. They say that Crespo's forces are being rapidly augmented, both with men and arms, and that by the middle of April he will have a force of from 10,000 to 20,000 men, who will begin an advance upon Caracas. These latter facts agree with the dispatches received Thursday night.

Delyannis, Greek minister of foreign affairs. The honor was recently conferred on Prince Bismarck.

COMMITTED SUICIDE.

Another Case of a Young Girl's Unnatural Affection.

ALTONA, Pa., April 2.—Miss Emma Fox shot and killed herself because Miss Birdie Boate, with whom she had fallen in love, refused to return her affection. The young women are both of good parentage and well-to-do. Miss Fox was a brunette, 24 years of age, and Miss Boate, who is a blonde, is 22. Almost a year ago Miss Fox began to show an unnatural affection for Miss Boate, seeming content only when in her presence. When Miss Boate was attacked by diphtheria Miss Fox nursed her, and after that she was continually following her. Miss Boate never returned the love and had lately tried to avoid her. Miss Fox was not to be disconcerted, however, and she even attacked young men she saw with Miss Boate. The latter then became frightened and never went out unattended. In company with a relative she was returning from church when Miss Fox approached, and drawing a revolver, cried, "Birdie, I am before you for the last time." Miss Boate ran, but heard the revolver crack. Miss Fox was dead when picked up. The coroner's jury rendered a verdict of suicide, but assigned no cause.

FOOLISH BOYS.
Poisoned by Sugar-Coated Pills They Picked Up.

CHICAGO, April 2.—There are four youths on the West Side who are lying in a precarious condition, and all on account of a medicine-advertising agent. It seems that a fakir was discovered by the youths yesterday while distributing some new panacea in the shape of sugar-coated pills. Boxes containing four each of the sweet-covered pellets were left at every door for several blocks. The residents of the house did not have a chance to try the samples, however, for the boys kept a short distance behind the peddler and gathered up the boxes at the doorsteps as fast as he left him. Willie Schuyler, a youth of about eight years, reaped a heavy harvest, and soon secured and devoured the contents of forty-four boxes. It took three doctors from 1 o'clock in the morning to 3 in the afternoon to bring Willie to consciousness, and he may yet die. The other boys are also under the doctor's care, but they stopped at something like a dozen boxes and their cases are not so serious. The pills were for headache and contained strychnine.

Wholesale Jail Delivery.
TOMBSTONE, A. T., April 2.—Ten of the sixteen prisoners confined in the county jail escaped through a twenty-inch hole of brick and wood. Two Americans confined in the cell where the hole was cut did all the work, which occupied two weeks' time. All the prisoners were awaiting the action of the grand jury, which is to convene in May. The trusty who locks the prisoners in their cells did not turn the keys in the locks, although he pretended to, and when the word was given they slipped out and went through the hole. A common tablespoon and a piece of wire were all the tools the men had. Rewards are offered for the escaped men, but nothing has been heard of them. Officers are scouring the country in all directions.
