

GEARY'S CHINESE BILL.

Fears of Another Indian Outbreak—Oxford Wins.

THE HEATHEN CHINEE.

Geary's Anti-Chinese Bill and Senator Dolph.

SAN FRANCISCO, April 9.—A Washington special says: "The Pacific coast senators have resolved to make a determined effort to pass Geary's Chinese bill in the senate. There is a good deal of opposition to be overcome. The fact that Senator Dolph is not as warm in support of Geary's bill as he should be, is a little bit discouraging to his friends of the coast. Senator Dolph's bill extending the existing anti-Chinese laws for a further period of ten years was ignored by the house of representatives, consequently, the senator has a grievance against the lower body, and he declares Geary's bill is almost too radical. The senator's Pacific coast friends, however, are inclined to think he will not manifest any serious opposition to the Geary bill, having always heretofore been arrayed on the side of the laboring men against cheap-labor of China."

DIED INTESTATE.

He Was Worth Thirty Million Dollars.

WILKESBARRE, April 9.—Arlon Pardee, a wealthy coal operator who died in Florida two weeks ago died intestate. The estate is worth about \$30,000,000. Pardee who was married twice had children by both wives. A big legal contest is anticipated. Many educational institutions will be disappointed when they hear there is no will. There are ten near heirs; his wife and nine children.

THE GHOST DANCE.

Fears of Another Outbreak Among The Pawnee Indians.

GUTHRIE, O. T., April 9.—Frank White and Buffalo Black, two Indians who claim to be the prophets of the coming messiah have been released from jail on a writ of habeas corpus and have left for the Pawnee reservation accompanied by a large number of their Indian followers who had come here to attend the trial. The ghost dance will once more be renewed and as many of the Indians are arming themselves and refuse to obey the agent's orders it is very probable that troops will be needed to quell an outbreak the next two weeks.

To Be Guillotined.

PARIS, April 9.—Lieutenant Anastasy, who murdered the aged Baroness de la Roche last, is to be executed at 5 o'clock tomorrow morning. The chief executioner has received a number of threatening letters from anarchists. Anastasy has requested his brother, a medical student, to experiment on his hand as soon as it is decapitated. He promised by a movement of his eyes to certain questions. The brother will ask regarding the sensations experienced when the knife cut the head from his body. The object of the conversation is to afford a test as to whether any vestige of life remains in the human head immediately after it has been severed from the body.

Confederate Reunion.

NEW ORLEANS, La., April 9.—A grand reunion of confederate veterans was opened yesterday under auspicious circumstances. The convention was called to order by General Behan, of Louisiana. A felicitous address of welcome was made. A resolution offered by General Gordon was unanimously adopted. On suspension of the rules, it was agreed that it was the sense of the convention that the late confederate states grant a small pension each to Mrs. Jefferson Davis, widow of the president of said confederate states, and earnestly recommend to the legislatures of the confederate states to vote her an annual pension of \$500 each during the remaining years of her life.

Hetherington Acquitted.

WASHINGTON, April 9.—News was received at the navy department this morning that Lieutenant G. H. Hetherington, of the United States navy, has been acquitted of the charge of killing Mr. Robinson, an Englishman, at Yokohama about two months ago.

Oxford Wins.

LONDON, April 9.—Oxford today won the Oxford-Cambridge boat race by one and one-half lengths. Oxford's time was nineteen minutes and twenty-one seconds. The time is the best ever made over the present course. Out of fifty-five races rowed between Oxford and Cambridge, Oxford has won twenty-six.

High Water.

MARQUETTE, Ill., April 9.—The Kankakee river has risen eighteen inches in the last twenty-four hours, and is still rising. There is now three miles wide. There is great damage all along the bottom lands.

Another Blizzard.

BLOOMINGTON, April 9.—Another blizzard has struck Illinois. A strong wind and heavy snow is reported from outside points.

Cotton Bagging.

WASHINGTON, April 9.—The house has passed the free cotton bagging and cotton tie bill.

WORDS FROM THE POPE.

Contained in a Letter Written to Cardinal Gibbons.

BALTIMORE, April 9.—The Catholic Mirror of this week will contain correspondence between Cardinal Gibbons and the pope. In his letter to Rome the cardinal wrote: "We need hardly say how much light your holiness' recent encyclical letter has thrown on social questions closely connected with the good of religion, since its wisdom has been apparent even to many who are not of the faith. However, if we are not mistaken, it would seem that several things which it contains were especially written for the good of the country, and for this reason have been productive of much fruit among us. There was yet another matter which we recognized with no less pleasure. A groundless fear had taken possession of many minds lest what was being commonly circulated about 'national bishops,' though without any foundation, whatever, should be reduced to practice. We did all in our power to dispel this idle apprehension, especially when we saw the matter latterly discussed in the public press and looked upon with disfavor by the government. Our words, however, were of no avail until the voice of your holiness was heard. This put an end to all discussion and manifested to our government with which Catholic affairs are handled by your holiness."

The answer of the pope contained the following:

"We rejoice, indeed, that you esteem the care which we have bestowed upon your dioceses and the sentiments of gratitude which your letter expresses have for us no small comfort. All these things avail, as your devotion increases, to incline our good will daily more and more toward you and your flock, and thus to draw close those bonds of charity and faith which give such great strength and glory to the church. It is most agreeable to us to know that your prayers are offered to God for us, for nothing is better suited to the difficulty of the times in which we live. With a like feeling of charity therefore, we on our part implore an abundance of heavenly graces for you, and as an earnest of them impart permanently in the Lord, to you our loved son, and to your brethren, and to the episcopate of the United States, as well as to the clergy and faithful committed to your watchfulness, the apostolic benediction."

Shipping Dull.

SAN FRANCISCO, April 9.—There has been considerable dullness in shipping affairs lately, the bay is full of idle ships, sailors are a drug in the market, and there is a slight prospect of a silent rate. The battle between shippers and owners of deep water bottoms being ended for some weeks to come. Out of 103 deep water vessels in port, 64 have no business, their movements being marked as "uncertain."

FAVOR CLEVELAND.

Battle Between Cattlemen and Horse Thieves, Etc.

MASSACHUSETTS DEMOCRATS In Convention, Adopt a Platform Favoring Cleveland.

Boston, April 9.—The Democratic state convention for the choice of four delegates to the national convention at Chicago, met yesterday.

Hon. Edward Avery, of Braintree, was chosen permanent chairman. When Avery said that the next president was to be a Democrat, there was applause and shouts of "Cleveland." Avery attempted to proceed, but cheers were demanded for Cleveland, and given with a will and a tiger. Then came a call for cheers for Hill. These were given, but with a liberal mixture of hisses. As Avery proceeded to draw the ideal candidate, the convention was in a state of confusion. Avery sought to recognize the portrait of Cleveland, and there were reported cries of "Cleveland."

A platform was adopted with a few dissenting voices. It reaffirms the principles of the Democratic conventions of 1880 and 1891, and says that from the power to tax arises the whole force of government, but taxation must be limited, and so more money be collected than is necessary for an economical administration of the government. The free wool bill now in congress is approved; as are bills to place coal and iron on the free list; it favors general reduction of tariffs imposed by the bills of 1883 and 1890. Referring to money, it says: "We believe in honest money, the gold and silver coinage of our constitution, and a currency convertible into such coinage without loss. We believe that all dollars coined by the United States should be equal in intrinsic value, and all paper currency issued by the government should be redeemable in either gold or silver coin, at the discretion of the secretary of the treasury. While we believe in the full remonetization of the latter metal by international agreement, we are equally opposed to the free and unlimited coinage of silver by our government, independent of action by other nations. We denounce the Republican act of 1890."

The platform declares the best interests of the Democratic party demand the nomination of Grover Cleveland. When Cleveland's name was mentioned there was rapturous applause, and the convention was plainly in sympathy with the resolutions. Thomas F. Keenan, of Boston, offered a resolution favoring David B. Hill, of New York, but as there were some objections to it, Keenan withdrew it.

A REGULAR BATTLE.

Cattle Men and a Band of Horse Thieves Fight.

HELENA, Mont., April 9.—A dispatch from Dillon announces that a battle occurred two days ago between a band of horse thieves and cattle men on the Montana side of Windy river. The cattle men being exasperated by the depredations of horse thieves, began to organize a search for the robbers and a large body entrenched in winter quarters. They attacked them, and were repulsed, losing eight killed and many wounded. The robbers lost heavily. The place where the fight is said to have occurred is isolated, and news of the fight would not reach outside for several days.

CASPER, WY., April 9.—A courier

from the seat of war arrived here yesterday and reported that an army of Pinkerton's cattle men were after the "rustlers" in camp at Marrows about seventy miles north of here. The army is well supplied with ammunition and supplies. The "rustlers" made small ranchmen believe it to their interest to oppose the army. It is believed that a fight will take place today, the "rustlers" are prepared, and they think the army will show no quarter. Another army of cattle men is reported to be on their way to reinforce the first. No one doubts that the cattle men from Texas and Montana are combining in an effort to crush out the "rustlers." If they unite they will undoubtedly win the battle.

BLAINE'S FRIENDS.

They Assert He Will Not Be a Candidate.

WASHINGTON, April 9.—The stories which have been assiduously circulated the past week with reference to Mr. Blaine's supposed willingness to accept the nomination for the presidency have created a good deal of comment in Washington, and have been a source of annoyance to Mr. Blaine's friends. Senator Hale said yesterday to a correspondent that there was absolutely no foundation for them. "I do not speak for Mr. Blaine," he said, "because I have no authority to do so; but I know he stands today as he did when he wrote his letter of withdrawal. He has not reconsidered his determination, and he has given no intimation of any intention to reconsider it. There is not the slightest truth in the report that he was worried into writing that letter. He did it after full consideration, of his own free will, and in opposition to the wishes of some of his best friends, and nothing has happened since to make him change his mind."

A senator who has been as close

to Mr. Blaine during the past twenty years as any man in public life, said that the agitation which had been started during the past few days did not originate with anybody who was friendly to the secretary of state. "Mr. Blaine does not want the nomination," he said, "and he could not take it. It is unjust to him to continue the use of his name."

Lieutenant Backus, Heard From.

WASHINGTON, April 9.—The only information received at the war department concerning Lieutenant Backus is confined to a foreign dispatch stating he had turned up and been identified. It is presumed that the war department that the officials at Governor's Island will look after the lieutenant, and until they have reported no instructions will be given as to the disposition that will be made of him. The natural course will be to have him examined by the medical officer at Governor's Island, and if found insane, as his conduct would seem to indicate, to bring him to this city for treatment at the government insane asylum. Lieutenant Bliss, aide to General Schofield, who was a classmate of Lieutenant Backus, says he has not seen the latter for a number of years, but when he graduated he was an exceptionally bright young officer, and a man of the most exemplary habits. A letter received here from a friend of the lieutenant, attributes his trouble to the too free use of morphine, which he has been taking to allay neuralgic pains.

Death of Judge Crosby.

SAN FRANCISCO, April 9.—Judge H. R. Crosby, of Vallejo, died at that place Tuesday night, after a lingering illness. Judge Crosby was born in Philadelphia sixty-three years ago. He entered the army in 1847, and served as aid on General Winfield Scott's staff in the Mexican war. During Buchanan's administration he was appointed United States judge for Utah territory, and later went to Washington territory, where he was elected a member of the legislature. He subsequently removed to this state and engaged in journalism. He retired from newspaper work some years ago upon obtaining a position at Mare Island navy yard.
