Revival Closing With Six Hundred Saved—Farewell Service.

Tuesday is the last day of the Mills meetings at Salem but the pastors of the several churches in the city will hold special services on Wednesday, Thursday and Friday evenings of this week at 7:30.

Salem has several preachers who are as able men in their way as Mr. Mills is in his and whose powers of gospel pleading enable them to keep a constant stream of accessions to their churches all the year around.

MONDAY MEETINGS.
In the afternoon Rev. Kellerman led in prayer and Mr. Greenwood sang "The Harvest is passing." Mr. Mills chose for his text words recorded in John 11:28: "The Master is come and calleth for thee," and drew an analogy between the death, burial and resurrection of Lazarus and a revival of religion. It was an earnest, eloquent appeal to church members to take away the stones of indifference, of secret sins, of bitterness, of any and everything that separates them from God.

MONDAY NIGHT'S MEETING.
The church was filled again to its utmost, a number of camp stools even being brought into use. Rev. Mills took for his text John 11:29: "Therefore for his could not believe." The evangelist said: "Our theme tonight is the most solemn we possibly can take, the question whether a man can be physically alive and spiritually dead."

Up to this time 580 persons had signed cards declaring their intentions of leading a Christian life.

"You have a very fine town. The people are very responsive, quiet and attentive and very well behaved at all the meetings. Your ministers are pleasant men. There should be some larger churches built and when I come again I trust no one need be turned away. I hope to come here again before I die, but life is uncertain. Mr. Greenwood said the people had sustained them well and been very patient in the jam that took place at each meeting. "The choir people were willing and faithful and did as well as in any town of its size we were ever in."

Messrs. Mills and Greenwood were both very busy at their rooms at the Willamette. They conduct a large correspondence, and answer many personal letters of inquirers. Mr. Mills corrects proofs of his sermons for a large number of religious papers and also prepares them for publication in book form. THEY TOIL WHILE OTHERS SLEEP.

There is a vast Army of Busy City People Who Work All Night.

Did you ever stand at Clark and Madison streets after midnight? Have you any idea of the number of persons who look upon midnight as the world in general does upon noon? It is a vast army that toils while others sleep, and it keeps busy a great number of attendants.

For the benefit of the great number of night workers dozens of stores are kept open nights—restaurants, drug stores, baker shops and saloons. Of course these are not patronized exclusively by the all night workers. They catch the transient trade of that big community that loves to roam about when other folks are in bed.

It is a queer community, this night crowd. First comes the actor fresh from his night's labors. He may deserve to be classed with the night worker, though he disappears at 1 or 2 o'clock. The men of the boards are followed by the men of the tables—the waiters of the big downtown restaurants which close between 12 and 1. By the time these are well on their way home comes the first platoon of the newspaper brigade, the "day" reporters for the morning papers.

These linger a little and give way to the first batch of printers. The printers struggle along all through the night, for they get off in gangs—increasing as the night advances. With them, too, comes a portion of the night editorial force—the men who have remained after the departure of the reporters to edit the work of the latter.

These all gather by ones and twos until by 4 o'clock, when the night reporters cease their labors, the throng of printers, of editors, of reporters, is a great one. They are lovers of gossip and good fellowship and gather in the various downtown resorts to break bread or sip a social glass previous to a tedious journey in a horse car. These cars, by the way, are run for the benefit of the many night workers.

Then comes the crowd of night rambles—men about town—and people who attend dances. All these furnish a lively to the fruit vendors, "hot tomale" and "red hot" men, etc., as well as the stockbroker.

The vast multitude of early risers—the dinner platoon—begin hurrying to their places of daily labor when the last of the night workers leave for home. These are the newspaper stereotypers and pressmen, the bakers, the telephone girls and those who work in the all night stores.—Chicago Tribune.

A Giant Chestnut Tree.

Probably the largest chestnut tree in Connecticut stands in the town of Mansfield on the land of Mr. Whipple Green. It was pointed out to me by Mr. Nathan Starkweather. We visited it on Aug. 27, 1890. It is in an open pasture, about three-fourths of a mile east from Mansfield Station, perhaps fifty rods from the house of Mr. Green and not far from the traveled road. A small brook runs a short distance from the tree. The circumference is twenty-three feet at four feet from the ground. It is heavily buttressed all around, and the trunk is apparently sound. Four large branches have been sent out; the lowest, ten feet from the ground, measures sixteen feet four inches in circumference and extends toward the northeast. The circumference of the buttresses, or rather of their roots, exposed above the ground is fifty-four feet.

Some of the large and high branches have been broken, the result probably of severe snow or ice storms, so that it is not perfectly symmetrical. The diameter of the spread of the branches from the northeast to the southwest is eighty-three feet, and from the northwest to the southeast 100 feet. Mr. Starkweather estimates the height to be eighty feet. It is a noble specimen of the American chestnut, which has withstood many years of winds and storms and promises to live many years yet unless attacked by the woodman's ax. Let us hope he will spare that tree.—Gardner W. Russell in Hartford Times.

A Suggestion for City Physicians.

The emergency which occurred recently in a family living above Twenty-third street and below Fifty-ninth street should serve as a suggestion to physicians of that district. Shortly after 11 o'clock in the forenoon the wife and mother of the household referred to fell and sprained her ankle as she was about to enter her carriage in front of her residence. She was immediately assisted into the house and the coachman dispatched to the family physician.

He soon returned with the word that the doctor was out, and a round among the medical offices followed with the same result. Every physician in that neighborhood appeared to have the same office hours and not one could be reached. It was over an hour before the suffering woman got medical assistance, and then it was through her work in a certain hospital that one of the surgeons was dispatched to her relief.

It would seem to be a good plan for doctors to arrange their office hours with some regard to those of other medical men in the same district, so that one or two should be always on call, good as well for the profession as for the laity.—Her Point of View in New York Times.

A Remarkable Sermon.

A well to do, well fed London clergyman recently preached to a congregation of poor people in the slums, and took for his topic, "How to Be Happy Though Hungry." He eloquently reminded his hearers that, though they might be hungry in this world, they would be filled in the next world, and therefore discontent with their lot was a grievous sin.—Boston Globe.
