

unending efforts to keep the matter a secret, it has become known that the Kaiser, without consulting any of his advisers, has twice, within the past six months, addressed messages to the St. Petersburg government, which, if they had been taken seriously as the acts of a man answerable for his conduct, must have led to an immediate war. The czar, however, fully understands the unfortunate mental condition of his fellow monarch, and being also anxious for peace, has found a way out of the difficulty by ignoring the messages or pretending to misunderstand them; but such a fortunate result of these eccentricities cannot, in the nature of things be always hoped for. Were the czar, for instance, desirous of a pretext for a justified declaration of war, the insane act of the Kaiser would plunge the nation into a bloody and expensive combat, whose outcome no man could predict. There is a feeling deepening in Berlin among those familiar with the situation, and it is all the deeper because nobody ventures to speak openly of what thousands are thinking.

PLEADS HIS OWN CASE.

A Lawyer Sentenced to Death Argues His Case.

MEMPHIS, May 26.—Today will be presented in the supreme court of Tennessee, at Jackson, the curious spectacle of a distinguished lawyer arguing his own case in an appeal from a verdict which condemns him to death. The man is Col. H. Clay King, of the Memphis bar, who is under sentence to hang for the murder of David H. Poston, a brother lawyer. The crime was committed on the street in this city on March 10, 1891, and was most deliberate and unprovoked. The appeal was taken on points of law which are in themselves of unusual interest. By the rule of the supreme court, attorneys are limited to two hours for argument, but Colonel King has taken his case entirely out of the hands of counsel, and, owing to the peculiar circumstances attending it, the supreme court has agreed to allow him three hours. Lawyers from every part of the state and from other states will be there to hear him.

BLEW UP THE SHOP.

A Blacksmith Refuses to Recognize the Union.

SAN DIEGO, Cal., May 26.—At 11 o'clock a loud explosion drew people to a place where a blacksmith shop had stood up to that hour. Some one had blown it up with dynamite. The shop was on a principal street and was owned by a man named George Schmidt, who advertised to conduct the shop independently of the blacksmiths' union. Owing to the late hour the owner of the place could not be found, but persons who knew him say that the blacksmiths' union had expressed the determination to do him up, and it is the general belief that the explosion tonight was in direct execution of that threat. The building was completely wrecked, the roof being blown off and the sides blown out. A night mounted patrol had just hit the horse in front of the building and moved a little way off, and the horse narrowly escaped being struck by flying timbers. Dynamite and fuse seems to have been used to produce the explosion.

THE WORLD'S FAIR.

The Passage of a Bill to Close on Sunday.

THE WORLD'S FAIR.

Up in Congress Yesterday—The Colored Man.

WASHINGTON, May 26.—There was some surprise in the house yesterday when Representative Henderson, of Iowa, arranged President Harrison and the governors of states for their failure to give representation to colored people in connection with the world's fair. He was followed by Johnson, of Indiana, in a speech eulogistic of President Harrison, denunciatory of the Democratic party in the treatment of the negro in the South, and strongly in favor of the force bill. There was great excitement during Johnson's speech.

The house went into committee of the whole yesterday morning on the sundry civil appropriation bill. The subject was for a government exhibit at the world's fair.

Houk, of Ohio, offered an amendment appropriating \$100,000 to pay the expense of collecting, preparing and publishing facts and statistics pertaining to the industrial advance of United States citizens of African descent from January 1, 1863, to January 1, 1893, to constitute a part of the government exhibit.

Henderson, of Iowa, said the colored people numbered one-eighth of the population, yet evidence taken by the special committee at Chicago disclosed the amazing fact that neither the president of the United States nor the governor of a single state, nor the woman's commission, nor the local corporation, had given representation to these eight millions of people. It was a shame, and he proclaimed it with indignation. He believed there were two or three petty little places held by colored men, places that did not rise to the dignity of a barber. The civilized world was interested in knowing what was coming from freedom to these people.

Holman made a point of order against Houk's amendment, which was sustained.

Johnson, of Indiana, replied to what he characterized the "remarkable speech" of Henderson. The president of the United States, said he, had during his entire life been the firm, unswerving, and constant friend of the colored race. It ought not to be forgotten that the president stood in favor of a just measure of national relief which, if passed by congress, would provide for the supervision of national elections whereby the colored people of the South would have a right to cast their votes and have them counted. The president had stood for the measure known as the "force bill," when men with less courage failed to stand up for the rights of the Republican party. Allusion to the force bill brought a number of Democrats to their feet with questions, but only one was heard, that propounded by Richardson, of Tennessee, as to whether the president favored the force bill now. Johnson replied that the president was in favor of any system of constitutional legislation that would guarantee to the lowest man of the South the right to cast his vote without fear, favor, or intimidation. He proceeded in vehement language to denounce the treatment of the negro by the Democratic party of the South, and as he was vehemently contradicted by a number of Southern members, the house became a perfect bedlam. Some Democrats made a reference to 1876, whereupon Mr. Johnson proceeded to review the Hayes-Tilden controversy. The confusion became intense. Finally McMillan rose to a point of order, and Johnson was directed to address his remarks to the speaker.

Hooker, of Mississippi, denied that the people of the South were enemies of the negro. There never had been any disorders save when carpet baggers and aliens came down there and stirred it up.

Cleatham, of North Carolina, the only colored man in the house, regretted that the debate had taken a political turn. Colored people should have this appropriation. He wanted to see democrats and republicans come together to help the negro and do something for him.

Dockery, of Missouri, offered an amendment reducing the salary of the director general of the World's fair to \$80,000, and that of the secretary to \$30,000; also providing that not more than one meeting of the national commission or of the lady managers be held during 1893; delegating powers to board of control. Agreed to.

Editorial Convention.

SAN FRANCISCO, May 26.—At the National Editorial association meeting yesterday President Cappeller made the annual address, in which he dwelt upon the wonderful advance of the press in the United States within the past few decades, and the consequent enlarging of the responsibilities of the journalistic profession. The report of the committee on legislation, through Chairman Scott, of Illinois, made a number of recommendations, among them one urging the repeal of the sections of the revised statutes permitting the government to print "return in 10 days" envelopes. SHIP ST. CHARLES.

Some Particulars of the Explosion.

SAN FRANCISCO, May 26.—The crew of the ship St. Charles, blown up at sea off the Oregon coast on May 17th, arrived here yesterday on the steamer Willamette Valley. The following additional details of the explosion are obtained: The second mate, Mike Flynn, and Charles Lenberg, sailor, went to the fore-hatch to get some potatoes, taking with them the ship's lantern. Lenberg was reaching through the hole into the fore part of the ship, and was about to crawl through when an explosion occurred, and Flynn was lifted bodily in the air. He fell, with a great hole in his scalp and his legs burned to a crisp. Lenberg was thrown back against the ladder and was terribly cut and burned. Ned Riely, a sailor, who was on deck at the time, states that when the explosion occurred, ropes, hawsers and main hatch were hurled from the deck by the force, and the deck opened wide from the fore part of the house to the stern, and the ship generally was demolished. The rigging was on fire and pumps would not work. Captain Chapman was found pinned to the floor in his cabin under an overturned safe, his spine broken. The men extricated him with difficulty from among the timbers, and made haste to get into the boats, as the vessel was sinking. There were nineteen men divided among three small boats. When last seen, the St. Charles' mainmast was afloat and the ship foundering. The boats were two hundred miles from land without a compass. They succeeded in making Cape Koul-weather safely, and there Captain Chapman died. The sailors believed that coal gas ignited by the lantern caused the explosion.

THE BRIGGS CASE.

It is Opened by the Appellants in the Assembly today.

PORTLAND, May 27.—An immense audience filled the First Presbyterian church, where the assembly is sitting this morning to hear arguments in the Briggs case. When the preliminary routine was finished, the moderator read from the book of the discipline, calling attention to the solemn business of the assembly, as a court of Jesus Christ enjoining due deliberation and warning speakers they must not refer in any way to the merits of the case, as this is to be an entirely constitutional argument. Dr. Birch for appellant then took the floor in behalf of himself and colleagues.

Dr. Birch was followed by Dr. Briggs, who spoke an hour and twenty minutes in his own defense contending that the matter should be referred to a synod of New York.

Chief Parrish to Resign.

PORTLAND, May 26.—There is a well-defined rumor about the streets that Chief Parrish will present his resignation at the next meeting of the police commissioners and that it will be promptly accepted. It is also reported that his successor will be John Minto, now in the United States appraiser's office. Mr. Minto was for many years city marshal of Salem and served two terms as sheriff of Marion county. He is well known as an efficient officer, and it is pointed out that there will be a shakedown among the gang about the city jail which the last grand jury characterized as "rotten to the core." The ring bosses are thoroughly alarmed, and the removal of Chief Parrish is intended to pave the way for the election of a ring police commissioner at the city election. The citizens have one commissioner now, Mr. Logan, and the election of another commissioner would be a death-blow to the crowd that have been so long masters.

PAIRISH WILL NOT RESIGN.

PORTLAND, May 26.—Chief of Police Parrish emphatically denies the alleged rumor to the effect that he intended to resign in order to make place for John Minto. Mr. Parrish says the rumor is a surprise to him.

Interested in the Jews.

ROME, May 26.—Jesse Seligman, of New York, accompanied by Dr. O'Connell, rector of the American college here, visited Cardinal Rampolla, papal secretary of state, with the object of enlisting his sympathy on behalf of the Jews. The cardinal said he would be most happy to do his utmost to aid the humane cause. The pope, he added, has always been the protector of the Jews. When persecuted everywhere else, they found refuge in Rome.

Lesson in Patriotism.

ALBANY, N. Y., May 26.—General Palmer, commander-in-chief of the G. A. R., is earnestly co-operating with the executive committee of the national Columbian school celebration on October 12th, which aims to impress upon 15,000,000 pupils a powerful lesson in patriotism. In a letter to half a million of veterans of the country he urges that they assist in the celebration, acting as an escort to the parades, raising and saluting the flag, etc.

LEVEE BROKEN

In Mississippi, Causing Wide Destruction.

VICKSBURG, Miss., May 26.—The crevasse which occurred at Craig's Landing will overflow a large portion of East Corral, Madison, Tensas and Cordia, parishes which are among the most populous in the state. This means bankruptcy to the planters and starvation for the laborers and tenants. The levees are being guarded by armed men for the reason that they fear it has been purposely cut. All passers are compelled to give an account of themselves. At Gunnison a white man was caught trying to break the levee with dynamite and was shot dead.

In Congress Today.

WASHINGTON, May 26.—The house went into committee of the whole on the sundry civil bill, pending the question of Sunday closing of the world's fair. After various amendments and substitutes looking to the exclusion of the sale of liquor on the ground, exhibitions of nude or partially nude pictures or statuary, or allowing games of chance or lotteries within a mile of the fair grounds, or the sale of cards, dice, etc., had been lost, the following was adopted: "Provided that the government exhibit at the World's Columbian exposition shall not be open to the public on Sunday."

Disastrous Cloud Burst

CHICAGO Ill., May 26.—A cloud-burst at Kinsman, a small village in Tremont county, in one of the most prosperous farming communities in northern Ohio on the Pymaburg river, last night resulted in a flood which caused the death of at least six people and destruction of a vast amount of property and stock. Physicians from here have gone to the scene. After two hours down-pour on the flooding stream, a large dam above the village broke sending down a solid wall of water. No one was warned till the flood was on them. J. B. Robbins, his wife, two children and K. Stewart and son were caught in the rush of waters and drowned.

Hiscock Says Blaine Will Run.

NEW YORK, May 26.—Congressman Hiscock visited Secretary Blaine today and subsequently said: Blaine will accept if nominated and I am sure he will be nominated. He will write no more letters of declination. While not quite as I expected to find him, he is improving daily. I am satisfied he is strong enough to undergo the presidential campaign.

The Methodists.

OMAHA, May 26.—The Methodist conference today took up the proposition that the word "Laymen" in the discipline meant men only. Dr. Hamilton offered a substitute in case the proposition was not carried by a two-thirds vote. The word "Laymen" should thereafter mean both men and women. After a sharp discussion the substitute was adopted; 234 to 174. This was a decided victory for the friends of women in the general conference.

Killed at Breakfast.

OMAHA, May 26.—Special to Bee from Lincoln: Charles E. Montgomery, president of the German National bank, was shot and killed at breakfast in the Lincoln hotel this morning by W. H. Irvine, a real estate broker and a former partner of the murdered man. Irvine claimed his wife and daughter had been seduced by Montgomery.

Ordered Down Our Flag.

MONTREAL, May 26.—On the queen's birthday three petty officers and five men of the artillery garrison entered a number of stores above which the Stars and Stripes, with flags of other nations, were floating for purely decorative purpose, and compelled the proprietors to take down the American flag.

Tennessee Democrats.

NASHVILLE, Tenn., May 26.—The Democratic state convention met this afternoon, a thousand delegates are in attendance. Hon. Ernest Pillow, a strong Cleveland man, was made temporary chairman. The mention of Cleveland's name in his speech of acceptance was rapturously cheered.

The United Presbyterians.

PITTSBURGH, May 26.—The general assembly of the United Presbyterian church met in regular session this morning. Rev. Dr. David McMill, of Xenia Ohio, was chosen moderator.

L. F. Conn Appointed.

WASHINGTON, May 26.—The president yesterday nominated Lafayette F. Conn, of Oregon, commissioner for the district of Alaska, to reside in Ounahaska.

Dying of Cholera.

CALCUTTA, May 26.—In Serinagar of the capitals of Calcutta with 50,000 inhabitants, five hundred are dying daily from cholera.

Ellsworth for the alienation of his wife's affections, and that had it not been for Ryerse the suit would never have been begun.
