Bisot was Pardoned.
INDIANAPOLIS, May 28.—Arthur Bisot, who was sentenced to life imprisonment sixteen years ago for the murder of the city marshal at Bedford, was yesterday pardoned by the governor. Bisot, soon after his incarceration, received a sixty-day leave to visit his sick mother. He broke his parole and fled to Mexico, where he led an upright life and grew wealthy as a physician under another name. Recently he surrendered to the prison authorities with the understanding that he should be pardoned.

ENGLISH PARLIAMENT.
Question of Dissolution Considered.

LONDON, May 28.—A cabinet council was convened yesterday for the purpose of determining the date of the dissolution of parliament. The bulk of the conservative election agents are of the opinion that it is urgently necessary to dissolve parliament within one month, as was the case with the unionist members. Prior to the council a number of members had an interview with Balfour, and impressed upon him the necessity of settling the question without delay. The almost unanimous representation made advised that dissolution either take place at the end of June, or be postponed until the spring of '93. The tenor of the communications made after the council adjourned indicates that it is the decision of the government to proceed with the Irish local government bill and abandonment of the intention to resort to dissolution. Balfour promises a definite declaration the evening of Whitsuntide adjournment. The decision will enrage the opposition, who, without delay, will resort to every device for obstructing the government business, but the majority of unionists will approve it, though it will embarrass many. If conservatives' anticipations taken from that council be fulfilled, no Gladstone government is possible till the end of the spring of '93, and no home rule till '94.

TO COMBAT EVIL.
Ministers Should be Acquainted With All Vice.

PITTSBURGH, May 28.—In the United Presbyterian general assembly yesterday the committee on prevalent evils, and means of reforming them, reported at great length on Sabbath desecration, by railways, newspapers, masts, secret societies, murder, divorce, social evil, theaters, church lotteries, gambling, etc. The report recommended the clergy to boldly and openly make themselves acquainted with these evils, in order to be able to effectually combat them.

It was decided to build a church at Salt Lake City.

A report on the religious interest of the army and navy urged congress to provide an adequate number of chaplains in those services.

A Jawbreaker.
St. Louis, May 28.—Henry Shelton is pretty well known among the young men of Olive street who take rides with drivers out for a spin through the park. Yesterday Shelton got on the seat of a furniture van with the driver, a friend of his, named Jack, Jack drove for a while on Olive street, whose owner calls it the "Pantechuon."

"How do you pronounce the name of that warehouse of yours?" asked Shelton.

"The Pantechuon," said Jack. Shelton made an effort to repeat the word, gasped and fell sideways off the seat. Jack caught him by the coat with one hand, stopped the horses and let Shelton down to the street. Then, jumping down after him he found that Shelton was dead. A blood vessel in his heart had been ruptured. The doctors say it was caused by the effort to pronounce the word. Shelton was colored and ignorant, and it is believed the combination of physical and mental labor involved in the pronunciation was the cause of the rupture.

APPALING CALAMITY.

The City of Wellington, Kan., Destroyed.

BY A CYCLONE.

A Horse Deposited on Top of a Two-Story Building.

WELLINGTON, Kan., May 28.—The destruction to life and property by last night's cyclone is terrible. In the darkness and confusion of last night it was not possible to realize the enormity of the calamity. The light of day invests the scene of destruction with a distinct, awful realization of its scope. The loss of life is appalling, and the destruction of property great.

The storm was rotary, coming from the southwest, and descended on the city with terrible force, and suddenly rose, sucking everything and as suddenly dropping it. Trees are torn from their roots, houses are spun around, freight cars lifted and carried 200 feet, stoves lifted up to second stories. In one instance a horse was taken up and deposited on a two-story building. A little child was taken out of its cradle, carried two blocks and deposited on the ground uninjured.

The loss of property in this city alone will amount to half a million dollars, nearly all the large stock of goods in the city are destroyed by the cloud burst which followed the cyclone. Reports from all the country west are very discouraging, while no definite indications, as yet, as to many more partially demolished. All the casualties are not yet known, but following is as accurate as can be made: Mrs. Sasher, a bride, the young husband leaving; Miss Strand, Mrs. Sasher's sister; Henry Adams; James Weaver; Ida Jones. The fatally wounded are Chas. Adams, Mrs. Capt. Mahan; Mrs. J. T. Hanna; Mrs. Murphy; Charles Stoner; Santa Fe conductor Little; Maggie King; Ed Forsythe; Walter Forsythe; Silva Forsythe; Ex-sheriff Thall's children; Mrs. Robert Millard; James Miller the Republican candidate for attorney-general, leg and arm broken; Lieut. William French and Cadet Simons of Salvation army; Mattie Hedges; Guy Colby; Dick Weaver; Carry Mitchell and E. J. Forsythe. The missing are Prof. Nayer, and Hart Upson. Forty or fifty more are injured but not seriously.

The Cyclone.
TOPEKA, Kan., May 28.—Messengers advise to the Santa Fe road states the cyclone which demolished Wellington also struck Harper and Argona. The latter is a town of 750 inhabitants, in Sumner county, the former is the county seat of Harper county, and has 2300 inhabitants. It is not known whether there is any loss of life, but the train which took physicians from Wichita to Wellington has gone on to those places with all the doctors who can be spared.

Harper Destroyed.
WELLINGTON, May 28.—Messages from Danville report a very disastrous cyclone at Harper.

MURDERED BY INDIANS.
Dr. Sheldon Jackson Reported to Have Been Killed.

SEATTLE, Wash., May 28.—A Victoria, B. C., bulletin just received says word has reached there that Dr. Sheldon Jackson and party have been murdered by Yukon Indians.

VICTORIA, B. C., May 28.—The steamer Danube from the North brings additional particulars of the trouble and murder on the Alaskan borders. Despite every effort of Missionary Rev. Sheldon Jackson, whisky was being continually brought in. Jackson with the aid of Indian constables arrested two of the ringleaders. After binding them, Jackson and constables laid down to sleep. One of the manacled Indians severed the ropes which bound him and freed his two companions. Stealing up to the sleeping missionary and party, and snatching up Jackson's pistol fired two shots at him with fatal effect. A fierce struggle between the two constables and the two prisoners ensued. Being deprived of their rifles one of the constables ran away making his escape, the other was beaten to death. The scene of the murder was near Juneau.

Discount on Mexican Silver.
HAVANA, May 28.—Owing to the heavy importation of silver from Spain, over \$10,000,000 having been received since the commencement of the year, another monetary conflict has arisen. The majority of the retail tradesmen accept the dollar only for 95 cents because of the discount on silver as against gold. In some parts of the interior Mexican silver is only accepted at 70 cents on the dollar.

Senator Epps Hunter.
RICHMOND, Va., May 28.—The governor has appointed General Epps Hunter, United States senator to fill the vacancy caused by the death of Senator Barbour.

Earthquake.
ONTARIO, Cal., May 28.—Two light earthquake shocks this morning, first at 3:15, second five minutes later, was heavy enough to stop clocks. The course of the wave was northeast to southwest.

GYPSIES IN MOUERNING.

Their Queen Dies and is Buried With Peculiar Ceremonies.

SPRINGFIELD, O., May 28.—There were imposing ceremonies at the gypsy camp between this city and Dayton, Wednesday night when the body of Mrs. Hannah Smith, the gypsy queen, who died a few days ago, was sent to Elizabeth, N. J., where it will be buried. The camp includes the Smith and Costello families, wealthy gypsies, who own farms in New Jersey and on the California coast. The queen, aged 35 years, died suddenly in camp. The tribe dressed the corpse in Mrs. Smith's wedding gown, a blue silk plush, and decorated the fingers, breast and ears with diamonds and gold rings. An undertaker furnished an expensive casket, and the body was then removed to the undertaker's establishment. The gypsies in camp, then broke up all their utensils, and the fragments of iron, tin, brass, copper and porcelain were piled up under the wagon on which the queen formerly rode. The five families made all the sacrifices possible, and in a few days will leave this vicinity. The queen's diamonds, gold rings and bracelets will be buried with her.

BLAINE ALL RIGHT.
With a Few Precautions He is Fit For Anything.

WASHINGTON, May 28.—Dr. Pepper of Philadelphia, provost of the University of Pennsylvania, one day last week made a thorough physical examination of Secretary Blaine, at the latter's request. The doctor sounded Mr. Blaine's lungs, tested his heart, examined his muscles and tested all his other vital organs. After the examination was finished, Dr. Pepper said to him: "Mr. Secretary, you are a perfectly sound man; there is not a symptom of organic disease about you. The only possible defect that I can discover lies in your muscular system. Your nervous system is a little strained, but that can be remedied very speedily. MORE OPIUM FOUND.
Steamer City of Puebla Carrying Contraband Goods.

SAN FRANCISCO, May 28.—Another seizure of opium was made on the steamer City of Puebla. In all 140 five-ounce tins of contraband Lal Yuen opium were found stowed away in the engine room of the steamer between the circulation pumps and the bulkhead. The seizure is worth \$10 a tin, or \$1400. Six inspectors guarded the ship last night, and this morning searchers went on with their work.

The Presbyterians.
PORTLAND, May 27.—At last night's session of the assembly the report and recommendations of the committee on revision were adopted and sent down to the Presbyteries. This ends the revision question before the assembly. The assembly then adjourned till 9 a. m., today.

PORTLAND, May 28.—The usual devotional exercises of the general assembly were led this morning by Dr. Halladay of Brooklyn. The discussion upon the adoption of minutes called forth the facts that there was a deep seated objection to the action taken on the revision last night. Notice was given that in due time a formal protest against the action would be entered. The moderator introduced Governor Penoyer who delivered a brief address of welcome. The supplementary report of the committee on the theological seminaries was then presented. Union seminary is declared to have failed to comply with its obligations, the chair of biblical theology occupied by Dr. Briggs is de jure vacant. It then recommended that the status quo be recognized so far as difference of opinion upon the interpretation of compact, and that the matter be given to a committee of fifteen, for arbitration. Hearing of Dr. Briggs on appeal was then resumed.

A Young Murderer.
MACON, Ga., May 28.—Deputy Sheriff Ben F. Wilder was shot and killed yesterday morning on the streets of Macon by Willie Bell, a 14-year-old boy, whom he had under arrest for larceny. Wilder caught the boy on the outskirts of the city, and had brought him in and was waiting with him at the corner of a street that passes close to the jail. The officer stepped forward a few feet and instantly the boy drew a pistol and shot him in the head, death ensuing two hours later. The boy ran like a deer and reached the swamps in the lower part of the city before the pursuing crowd could catch him. A posse was out all day, without avail. Four brothers of the murdered man are with the posse, and it is believed that the murderer, boy as he is, will be lynched if caught.

The Gun Went Off.
SACRAMENTO, May 28.—Early yesterday morning Chas. F. Bauer, a clerk in the employ of Holbrook, Merrill & Stetson, while undressing was about to lay his pistol on the bureau, when by some means the weapon was discharged, the ball entering his left breast and coming out under the shoulder blade. He is alive, but his chances of living are very slim.
