PORTLAND, OR., June 11.—The Republicans concede the election of Chamberlain, as attorney general by a small majority. According to returns received, he leads by two hundred and eighty. Counties not heard from are Curry, Gilliam, Harney, Malheur and Wallowa. The official canvass of Multnomah county will be finished tonight.

THE STATE RETURNS.

Chamberlain Still in the Lead—The People's Party Slightly Increases.
PORTLAND, June 11.—Only five counties unheard from, but with the possible exception of the attorney generalship these can only change the figures of the majorities, and can in no way affect the general result. The race between Webster and Chamberlain still continues close one and as near as can be figured, the latter leads by 193 votes. The Peoples party vote still increases gradually and in one or two places almost the entire county ticket has been elected.
The totals as far as heard from are Moore, 3,373 plurality; Hemann, 5,119 plurality.

RED LODGE, June 11.—A letter from Arland, Wyo., says Jack Bliss, king of the Rustlers, was killed on the 4th inst. on the south fork of Stinking Water Creek, by Deputy Sheriff Iry and a posse of his place. Bliss occupied a stone fortress, and supplied himself with food by pillaging the miner's cabins. Officers took him unawares.

Indians on the War Path.

GUTHRIE, O. T., June 11.—There is more trouble with the Osage Indians. The deputy marshals who went out to arrest them for recent outrages on Charles McBride, were driven off the reservation. News is received of a party of Indians who captured a man traveling alone they held a war dance around him and tore off his scalp.

THE CONVENTION.

Nominates Whitelaw Reid for Vice President—Adjourns.

MINNEAPOLIS, June 11.—Shortly before the meeting of the evening session, the New York delegation held a conference and the seventy-two delegates of that state unanimously agreed to present the name of Whitelaw Reid for the vice presidency. At this meeting the following communication was received: "To the Republican national convention and members of the New York delegation—At a meeting of the undersigned, a committee representing Typographical Union No. 6, of New York, the following preamble and resolutions were unanimously adopted: 'Whereas, the differences hereof existing between our union and the New York Tribune have been honorably adjusted, to the complete satisfaction of both sides; and whereas as the Hon. Whitelaw Reid, editor of the Tribune, has been favorably mentioned as a candidate of the Republican party for the office of vice-president; therefore be it resolved that this committee endorse his candidacy and request that he be named for the office.' (Signed) John A. Kennedy, president Typographical Union No. 6; W. J. Brennan, Robert Costello, Thomas Hancock, Pierce P. Harley, committee."
The evening session of the convention was called to order by Chairman McKinley, who announced the order of business the presentation of candidate for vice-president of the United States. The secretary called the roll, and when the state of New York was reached Senator O'Connor presented the name of Hon. Whitelaw Reid. The chairman then asked that the nomination of Reid be made by acclamation. The motion was seconded.
J. S. Settle, of Tennessee, in obedience to the request of the Tennessee delegation, named Thomas B. Reed, of Maine. General Littlefield said it was the opinion of the Maine delegation that Reid would decline the nomination if it was tendered to him. Settle then formally withdrew Reid's name, and Whitelaw Reid was nominated by acclamation.
