### STREET IMPROVEMENTS.

Bids Advertised For—The Work to be Pushed—Crushed Rock or Gravel.

In today's JOURNAL appears the city's request for bids on street improvements. This is of great importance just now, as the work is to be pushed right through. The Chemeketa and South Commercial street improvements are about completed, and men will soon be idle unless more work is provided, besides there is no time to be spared if the work is to be completed this season. The committee propose to ask for bids for both crushed rock paving and on the gravel plan as petitioned for by the citizens. The general plan of both is the same, with the difference of twelve inches of crushed rock in one case and two inches of fine gravel in the other.

The petition is given below, as it has never been published before:

### CITIZENS' PETITION.

To the Honorable Mayor and Common Council of the City of Salem, Oregon.

Gentlemen:—We, your petitioners, owning property on Commercial and State streets in the said city, in view of the contemplated street improvements, respectfully represent that in our judgment no good purpose will be observed by removing the surface of said streets to twelve inches below the established grade, or any greater distance than two inches, or by placing the curb at a greater distance from the building line than fourteen feet, or by placing sub-drains.

We therefore petition your honorable body to cause the business portion of said Commercial, Court and State streets to be improved as follows: First. Remove surface where necessary to two inches below the established grade, and fill to grade with fine gravel and sand, properly rolled and packed. Second. Place concrete cutters fourteen feet from the building line against curbs, as already constructed, of sufficient capacity, properly connected with catch-basins, and without sub-drains. Third. Place at street crossings, and in the center of the principal business blocks, cross walks of stone or some other substantial material, and you petitioners will ever pray.

### LAWYERS WHO LOST THEIR FEES.

Their Healtless Courtroom Quarrel Did Not Hoodwink Their Clients.

Speaking of lawyers' courtroom quarrels, and the friendliness which they afterward display outside the courtroom, I am always reminded of the experience of S. F. Nuckolls, a groceryman here in the early days of this territory. There existed a very bitter feud between Nuckolls and another man, and the matter got into court. One of the men retained A. J. Poppleton and the other J. M. Woolworth, both of Omaha. Each circuit instructed his lawyer to take the other party to the suit over the coals in the liveliest possible manner. Nuckolls, in telling the story, said: "When my lawyer got up I settled comfortably back in my seat ready to enjoy myself thoroughly. As my lawyer warmed to his work he gave my opponent such a tongue lashing that he seemed to fly him alive. When the lawyer sat down I thought it was proved to the satisfaction of everybody that the other fellow was the meanest skunk that ever infested the earth. When the opposing lawyer got up I wondered what he could have to say. I didn't have long to wait. He sailed into me and belted me all over the earth. Before he got half way through he pictured me as the meanest scoundrel this side of Jericho, and I sneaked out of the courtroom until the storm was over.

"After he was through speaking I came in again and sat down beside my lawyer. I took it for granted that the lawyers had as much personal feeling in the matter as their clients had. I was therefore very much surprised to see Poppleton hand a note across the table to Woolworth, who opened and read it and then smiled back. This note he twisted up and threw under the table. I had the greatest curiosity in the world to find out what was in it and after court adjourned remained behind. The note contained these words: 'What will we charge these two fools?'

"I was mad. I took the note and hunted up my friend, the enemy, and showed it to him. Then he was mad, and we both went to the courtroom, had the suit withdrawn, settled the costs, renewed our broken friendship and bent the two Omaha lawyers out of big fees."—Cheyenne Leader.

### Steady Ships at Sea.

Mr. Thornycroft, the famous builder of torpedo boats, has devised an apparatus for steadying ships at sea and has completed a series of experiments which are said to prove that rolling may be diminished very greatly without extravagant cost and with comparatively small sacrifice of cargo space. Some of the fastest liners on the Atlantic ocean have been known to roll through an angle of 40 degrees, each way—a performance of wonderful significance to persons afflicted by seasickness. Mr. Thornycroft's device, which it would be difficult to describe clearly and briefly in detail, consists of a shifting weight moved by hydraulic power and controlled by the oscillation of short and long period pendulums.

This gear was fitted to a steam yacht of 230 tons displacement, and a roll of 18 degrees, was at once reduced to one of 9 degrees. The weight employed was eight tons, or 8 per cent. of the yacht's displacement, but as the vessel happened to be one of peculiar model, it is thought that a far smaller weight, in proportion, would be necessary in the case of an ocean racer.—New York Telegram.

### Treasure in Rubbish.

From time to time hidden treasures of a valuable nature have been unearthed in the freights of street refuse and rubbish which are regularly taken to Sittingbourne from London, and a portion of which is used in the manufacture of bricks. A large heap of this rubbish, many tons in weight, had been for several months on one of the wharves attached to a brick field, when some boys accidentally came across two or three coins, which after having the dirt removed turned out to be sovereigns. A more extended search then took place, in which numbers of men, women and children eagerly joined. The total sum recovered amounted to about £130, which was equally shared among the searchers.—London Tit-Bits.
