### STATE NORMAL SCHOOL.—

The State Normal School at Monmouth has made a remarkable growth during the past year, as shown in a gain of 80 per cent. in attendance over the attendance of the year before. The enrollment this year reached 376 students, and the faculty anticipate that the number will reach fully 500 next year. The school is wide-awake, full of life, and draws a remarkably fine body of students. Two new members have been added to the faculty. Prof. P. A. Getz, a graduate of the Millersville, Pennsylvania, State Normal, and Miss Alice L. Priest, a graduate of Cornell University. The music department has also been strengthened by the addition of Miss Fanny A. Ayres, a specialist in vocal culture, who has studied with some of the most famous singers of America. The school is broadening its work in many ways and is rapidly adding to its facilities for the special training of teachers. The rapid growth of the school would indicate that it is doing all in its power to merit the highest degree of success.

### THE POLYTECHNIC.—

Work has commenced in earnest on the building for the Friends' Polytechnic Institute, in Highland addition, and the brick basement is almost finished. Ten carpenters are at work, and they will rush the building ahead rapidly, for the institute, which is to be opened for the reception of students on the 13th of September. The building will be two stories above the basement, besides an attic, and will be a very fine appearing structure.

## A DOUBLE MURDERER.

Wilson Claims to Have Murdered Mrs. Scott.

### HIS STATEMENTS OF IT.

Scott's Story Corroborates Wilson's—Both Interviewed.

The report went out yesterday evening that Wilson, the murderer of Mamie Walsh, had confessed to the murder of Mrs. William Scott in Polk county two years ago, for which Mr. Scott is now serving a life sentence in the state prison. As Wilson is being accused of almost everything that is bad just now, a JOURNAL reporter hastened to investigate the matter this morning. At about nine o'clock he found Subt. Downing at the prisoner's cell looking after the dressing of his wounds. During the night Wilson had bled his head against the wall of his cell and cut it badly. Blood marks show that he hit it no less than a hundred times, and he appears to be suffering greatly this morning. He claims he did this to stop the intense pain in his head, and as the attendants were putting bandages on his head he would repeat "Take it out; take it out," referring to a real or imaginary pain.

Since his confinement of a week Wilson has changed wonderfully in appearance, having a haggard, worn-out look. The attendants claim he makes more trouble than all the other 429 prisoners combined. He was constantly biting and sucking his arms, until he has been put into muffs. The splints have been taken off his broken arm, and it is improving considerably since his arms are fastened down by use of the muffs.

Yesterday as Mr. Scott came down the hospital stairs he noticed Wilson through the grate, as the guards had him out in the corridor, and asked permission to see him. Although he seems to be growing somewhat phlegmatic, the prisoner at once noticed Mr. Scott, and as he passed out Wilson asked Warden Cavanaugh if that was not old man Scott. The warden said it was, and thereupon commenced drawing out information which may yet be the means of clearing up a great mystery.

### TO MR. CAVANAUGH'S QUESTION,

"What do you know about Mr. Scott?" he replied: "More than you might think." To the question, "What do you know of Mrs. Scott's murder?" he said: "A great deal more than you think of."

### "WHAT BECAME OF THE MAN WHO MURDERED HER?"

"He ran out through the orchard." To the question as to when the Scott murder took place, he could not reply directly, but finally asked: "Wasn't she murdered on Sunday morning?"

To the question, "Did you not murder Mrs. Scott?" he answered: "If you say so, I guess I did."

A little later the subject was crowded, and Mr. Cavanaugh asked: "Did you really murder the woman?"

He replied: "I reckon I did," This is in substance all that could be drawn out of the prisoner, for he seemed to be suffering intensely in the head, but he finally said: "I will tell you all about it some day when my head clears up."

Much of the prisoner's talk is unintelligible, and it is a question in the minds of the prison officials if he is not feigning to mislead them.

### OLD MAN SCOTT'S STORY.

Wm. Scott was found out in the prison yard sitting in the shade, and when asked whether he had ever seen or known Wilson before he came to the prison, he said: "No, not that I have any knowledge of."

### "When was your wife murdered?"

"On Sunday morning, Feb. 16th, 1890, between six and seven o'clock."

"Who do you think committed the deed?"

"I don't know. I had been away from the house about half an hour doing chores, and was coming from the barn to the house when I heard the noise. I saw my wife in distress on the floor, and also saw a man running in the upper end of the orchard with the dog barking after him. I naturally turned to help my wife and could not notice the man very closely."

"How did the man look who ran away?"

"I really cannot tell much about it, except that he was a medium-sized man, and appeared to weigh about 100 pounds."

"How far away was the man?"

"About seventy-five or eighty yards."

"Do you think you are rightfully imprisoned here?"

"No sir, for two reasons. If I had committed the murder, I should have been hung; not having committed it, I should be a free man."

Thus it will be seen by Mr. Scott's story that he corroborates several important statements made by Wilson—that of the murderer running through the orchard and of its occurrence on Sunday morning. Wilson's statements also corroborate Scott's claims to innocence. The remarks made by Wilson to the officers just before his escape, concerning the Scott murder are now more easily understood. Although Wilson claims to have been in the East at that time, he certainly shows considerable knowledge of the case. The whole matter will in due time no doubt be cleared up by what Wilson may yet further confess, and by what his trial for the murder of Mamie Walsh may develop. Many sympathizing friends of old man Scott hope this strange story may in time clear up the whole mystery, and give him his liberty.

### A THING OF BEAUTY.—

Hundreds of citizens these days are feasting their eyes on the south Commercial street improvement. Instead of dark tunnel bridge and a "hog's back" of a hill beyond there is now as fine a sweep of street with a light grade as anyone may wish to see. Mr. Goodhue deserves great credit for the good appearance he has given to his work.

### To Rail Road Commissioners.

Yesterday Governor Penney addressed the following letter to the state board of railroad commissioners: EXECUTIVE OFFICE, SALEM, July 13, '92.

Messrs. G. W. Colvig, Robert Clow and A. N. Hamilton, Railroad Commissioners, Salem, Or.

Gentlemen:—The supreme court of the United States, in the case of Budd vs. New York—143 U. S. 517—having recently reaffirmed the doctrine that "it is within the power of the legislature to declare what should be a reasonable compensation for the services of persons exercising a public employment and to fix a maximum beyond which any charge would be unreasonable," while at the same time it has not resented from its position in the Minnesota case—134 U. S. 418—that the reasonableness of the rates fixed by a railroad commissioner can be inquired into by the courts, necessarily imposes upon you, in order to procure the definite establishment of just rates, free from judicial interference, the grave necessity of reporting to the next legislature a maximum rate bill for enactment. Your investigation of such matters will enable you to prepare such a bill, and the six months intervening before the legislative session will give you ample time and ought to be employed by you in formulating such a measure.
