

OREGON CROP REPORT.

The Republican League—Attempt to Rob a Cable Car, Etc.

Crop Report. PORTLAND, Or., Aug. 2.—Weekly report of Oregon weather bureau says: Harvesting is in full progress throughout Oregon except East and South of Blue mountains. Wheat is turning out better than was expected. General crop will average about that of last year. Spring grain has improved somewhat but it will be a short crop. Hops are coming on well and although lice are plentiful yet nothing serious is expected from them.

Held Up a Cable Car. KANSAS CITY, Aug. 2.—A masked highwayman at midnight attempted to hold up the cable car on Summit street and rob the conductor. Police Sergeant Parker happened to be one of the passengers and a fusillade ensued. The officer was wounded in the groin dangerously but the robber escaped.

MURDERER WILSON. Talk of Disturbing His Body From Among the Pioneers.

PORTLAND, Aug. 2.—From present indications the body of Charles Wilson, the murderer of Manie Walsh, which was interred in the Oregon City cemetery, will not be allowed to rest in peace. H. E. Hayes, of Oregon City, was in Portland and gave some interesting facts about Wilson. Mr. Hayes saw Wilson in his cell in the county jail at Oregon City several times before he committed suicide, and says his actions indicated that the dividing line was very faint within his brain. "Wilson," he continued, "was the most supple man I ever saw. When confined in his cell he would attempt to commit suicide by rolling himself up like a rattlesnake and then spring headfirst against the wall and then fall on the floor and lay apparently lifeless. I attribute the softening of the frontal lobes of his brain to these attempts to commit suicide. Wilson always ate heartily."

It may be interesting to note that Wilson's brain, which weighed 64 ounces, has but one superior and one equal in weight, viz: that of Cuvier, the French naturalist, which is the heaviest on record, and that of Henry Knight, which also weighed 64 ounces. "When Wilson suicided the authorities announced that they would bury the body in a far corner of the cemetery, known as the 'suicide's corner.' Instead of doing this, however, they buried it in the heart of the cemetery between lots owned by the Latourrettes and Nobles, two of the oldest families of the city, and near the grave of Dr. McLaughlin, the Hudson Bay trader, who was here in 1824. The bodies of D. L. Latourrette and the elder Mr. Nobles rest in the family lots near Wilson's grave. There is considerable talk of having Wilson's body removed, several parties, relatives of the families mentioned, declaring that they will go to law about it."

Still Filibustering. WASHINGTON, D. C., Aug. 2.—After an hour or more of filibustering the house today adjourned after revoking all leaves of absence to members, even on account of sickness. Majority of Democrats in the house are making strong efforts to bring about a compromise on the World's fair matter and this afternoon a conference of forty or more members was held in the ways and means committee room. Both sides in the Democratic party were represented and the following committee, to talk over the matter within the party was appointed by Dockery. Against world's fair: Bandhead, Cummings, McCreary, Culbertson, and McMillan; in favor: Durbrow, Williams, of Illinois, Fellows, Reilly and Shively.

An Old Soldier Dead. NEW YORK, Aug. 2.—Lieutenant Colonel L. S. Small, assistant commissary general of subsistence, stationed at Governor Island, died early yesterday from a complication of diseases. He was 61 years old, and has been a sufferer, from Bright's disease and catarrh of the stomach. He was born at York, Pennsylvania, August 9, 1831, entered the army when he was 19, and continued in the service up to the time of his death.

To Arrest Frick. PITTSBURGH, Pa., Aug. 2.—Anarist Bauer and Knoll made application for release on bail this morning Judge Ewing fixed the bail at \$500 and Attorney Friedman suggests to secure bondsmen today. It is rumored information will be made against H. C. Frick some time today on a charge of conspiracy and that he will be arrested before long. Information is made by Organized Association.

Webster Seen Near Albany. ALBANY, Or., Aug. 2.—A. Webster, the escaped convict, was seen in the woods three miles below Albany last evening. Three officers came up from Salem last night and organized a posse to capture him. Two of the men met Webster, but did not know him. They ordered him to halt, when he ran. They fired several shots at him, but he escaped into the thicket. About twenty men are searching the woods for him.

Confessed the Crime. TACOMA, Aug. 2.—Zales, the man accused of murder of Officer Cuddehe, yesterday made a statement pleading guilty of assault. He has been kept ignorant that the officer was killed, and was persuaded that this was the best method of getting out of the trouble. This positively identifies him and will convict him of murder.

Assaulted the Post Master. NASHVILLE, Tenn., Aug. 2.—Jesse Bloodworth a youth of Edgefield Junction entered the post office at that place and on being told that there was no mail for him returned a few minutes later and assaulted Post Master A. Ramlly with a knife. The latter is not expected to live. Bloodworth is still at large.

The Republican League. NEW YORK, Aug. 2.—President W. W. Tracy, of the Illinois League, says in his opinion J. S. Clarkin will be elected president of the National Republican league by acclamation at the annual convention in Buffalo on September first. He has talked with Clarkin and has reason to believe he will accept.

FROM HOMESTEAD. The Usual Report of Strikers Weakening and So On. HOMESTEAD, Aug. 2.—There is great activity among the leaders to prevent the weakening of the strikers in the mechanical department from returning to work and a meeting has been called for this afternoon. Amalgamated Association still contends that if Homestead men stand firm the company can never find men who can operate the machinery. Manager Potter says he has received 222 men from Baltimore, Philadelphia and Cincinnati this morning, many of whom are experienced skilled workmen. In addition he says seven of the old men have applied and been taken back. Committee of strikers this morning attempted to persuade the railroad engineers at Munnhall to refuse to haul freight to the yards but failed. The engineer stated that railroad men were in sympathy with strikers but not to jeopardize their positions by such actions. Sheridan troop and part of Battery B were ordered home this morning. Three regiments still remain.

From Homestead. PITTSBURGH, Aug. 2.—The Duquesne mills did not resume operations with non-union men. The company posted notices giving the old men until Wednesday evening to return to work. The steamer Tide carried two hundred non-union men to Homestead yesterday. Joseph Drivers, Charles Reynolds, John Williams, and George Kincaide, brought here to take the place of strikers, yesterday came to the city, where they called upon Attorney Brennan, and complained of the treatment received while in the mill. All say they were brought here by false representation, and also that there are at least fifteen men in the mill that want to come out but are prevented by officials, who will not allow them outside the fence.

A Shooting Scrape. BAKER CITY, Or., Aug. 2.—Cracker Creek Mining camp, thirty-five miles from this city, was Sunday night the scene of a shooting scrape. Joseph Mickets, saloon-keeper, shot and fatally wounded Andrew Olsen. The trouble arose over Mickets' kicking a dog belonging to Olsen. The latter started to go behind the bar after Mickets, who at once drew a revolver and commenced firing, the fourth shot taking effect in Olsen's abdomen. Immediately after the shooting Mickets started for this city to give himself up, and was met on the road by the sheriff. The parties have been the best of friends, and for several years have been almost inseparable.

Canadian Ministers Excited. OTTAWA, Ont., Aug. 2.—A cabinet council was held Saturday to consider the consequences of President Harrison's exercising the power placed in his hands to retaliate on Canada for discrimination at the Welland canal. So urgent does the government consider the possibility of the president's enforcing heavy discrimination tolls at the "Soo" canal that a conference of Sir John Thompson and two of his colleagues was held last evening in the room of the minister of militia, at the Russell house. It is said that the cabinet is divided on the question, one section being in favor of revising the Canadian policy on the spot, and the other of appealing to England for sanction to make reprisals against the United States. Mr. Chapleau, the new minister of customs, is strongly in favor of abandoning the policy of discrimination at the Welland canal. No decision has yet been reached.

WORLD'S FAIR BILL.

The Discussion on the Joint Resolution. WASHINGTON, Aug. 2.—Before the passage of the resolution there was a spirited debate in the House. Holman made a speech of some length, declaring he had been acting in harmony with the action of the house, that the gentleman from Illinois [Hopkins] had objected. Hopkins was willing, said Holman, to stop the wheels of legislation in order to compel the house to give five millions to a corporation in Chicago.

Reed (Maine) replied, Holman, said he had offered an example of unexampled courage. With a Democratic majority of more than 140, of which he was the factional leader, the house had stopped the business of government, and now Holman was endeavoring to charge this stoppage on somebody else. He (Holman) had deliberately blocked the wheels of business. The World's fair legislation had received the sanction of the senate without regard to party. Further than that, it had the sanction of the Democratic house, and there was nothing against it but a miserable technicality, that some gentlemen thought to be an appropriation bill. Yet the gentleman from Indiana had the courage to stand before the house and the country and charge the result of his own action to another member, to charge in a house of 140 Democratic majority the stopping of public measures by a member of the minority. He did not wonder the gentleman from Indiana had had a long career of courage like that which carried a man through Indiana.

Cummings, of New York, said that the wheels of government were stopped by Hopkins. The latter retorted that, next to Holman, Cummings was responsible for the condition in which the house found itself today. McMillin, of Tennessee, asserted that the gentleman from Illinois had virtually said, "You either give that \$5,000,000 to the World's fair, or you don't get your sundry civil bill." The joint resolution was agreed to without division.

COBB WAS NOT DRUNK. Testimony of Many Witnesses to This Effect. WASHINGTON, Aug. 2.—The special committee appointed to investigate the charges of drunkenness in members of the house resumed session yesterday and many witnesses testified that in their opinion Representative Cobb, of Alabama, was not drunk when he delivered his argument in the Noyes-Rockwell election contest, the witnesses generally testifying that Cobb was suffering from exhaustion incident to the delivery, when in poor health, a long speech marked by many interruptions and much badgering. By none testified it was not uncommon practice for members to take

bullion, beef tea, coffee, and other stimulants out of a cup during long continued arguments, and from his knowledge of Cobb's physical condition, he was satisfied that the gentleman could not speak continuously for two hours without taking some stimulant. Andrew Devine, one of the official stenographers of the house, produced the manuscript official report of Cobb's argument, and testified that he saw nothing in Mr. Cobb's conduct to justify the charges. It is likely that Simpson, of Kansas, will file a minority report in behalf of his fellow alliance member, Watson, of Georgia, it being practically assured that the majority will at least make strictures on Watson.

FIRE IN PORTLAND. Paint and Oil House and Grocery House. PORTLAND, Aug. 2.—Fire broke out in the third story of the paint and oil house of Whittier, Fuller & Co., in the Starr block, on Front Street, at 8:30 last night, and in a few minutes the flames were burning from every window of the two upper stories. Owing to the great amount of inflammable material the departments were unable to control the fire, and it spread to the wholesale grocery house of Wadhams & Co., adjoining. The two upper stories of Whittier, Fuller & Co., and Wadhams & Co., were entirely gutted, and the two lower floors badly damaged by water. The building is a four-story brick, and is owned by Senator Dolph and D. P. Thompson. The losses are as follows: Whittier, Fuller & Co., \$75,000; Wadhams & Co., \$50,000; Dolph and Thompson, damage to building, \$30,000. It is understood that all the losses are covered by insurance. J. J. Flynn, fireman, had his leg broken. It is supposed the fire started from spontaneous combustion, as one of the men in the building heard an explosion and soon after the flames burst out. The fire department did excellent work in confining the flames to Whittier, Fuller & Co., and Wadhams & Co.'s stores, notwithstanding the hose burst frequently. Had the fire caught the oil warehouse in the rear the result would have been much more disastrous. For a time it looked as though the entire block would surely be destroyed, but Frank Bros., who adjoin Wadhams & Co., were only slightly damaged. The Starr block is one of the first, four-story buildings erected in the

city, and is very substantial, covering the entire block bounded by Front, Oak and Pine streets and the river.

The Mori's Marriage. SALT LAKE, Aug. 2.—Herbert Slade, a prize fighter, has caused a tremendous sensation in the Mormon church. He stole a bishop's daughter because he loved her. Not long ago Slade, who is known as the "Mori" was imported because it was believed he was the only man who could whip John L. Sullivan. Slade was a fine, bulky specimen of manhood, but he proved a dismal failure and was relegated, about three years ago, to Salt Lake. He is now hiding from Bishop John Sweeney, who ruled over a small agricultural town known as Mover, about 100 miles from Salt Lake. He is wealthy and his only child, a girl about 18 years old, was a recognized beauty. She had all the young members of the Mormon church within a circuit of 500 miles at her feet, but when the giant fighter, Slade, appeared in the town the two became desperately enamored. They eloped, but Slade had to first play Romeo to his Mormon Juliet because she was locked in an upper chamber of her wretched parents' home. Bishop Sweeney learned of his daughter's love-making before the elopement, and his temper rose to a high pitch. The union was denounced, and the girl was locked in her chamber, from which Slade stole her in the most approved and romantic style. They hastened to a justice of the peace 20 miles away and were married. The bishop and all his clan pursued the elopers, but they arrived at the house of the justice half an hour too late.

Democratic Caucus. WASHINGTON, Aug. 2.—Democrats of the house held a caucus last night for the purpose, if possible, of agreeing upon some plan by which the present deadlock may be broken and an adjournment of congress be brought about. A resolution was presented proposing to lay over until December next the proposition to vote \$5,000,000 in aid of the World's fair. The resolution, in effect, was that a vote on a separate world's fair bill be had on the 7th of December next; but that three amendments shall be in order. Another resolution provides that Bingham's resolution ordering a reconsideration of the disagreement on the senate amendment be laid aside, and another resolution provides for the continuance of the Dockery subcommittee on appropriation to investigate the World's fair management during the recess. Most of the speeches made were in favor of the resolutions and against the World's fair men. After considerable debate, the resolution to throw the fair appropriation over until December carried, and the caucus adjourned. The result was received with manifestations of displeasure by world's fair people, and expressions of feeling between two sides became quite warm at the close of the caucus.

The Letter May Cause Trouble. WASHINGTON, Aug. 2.—Some very sharp correspondence is promised between the second controller of the treasury and the secretary of the navy, as soon as the latter learns that the former has expressed himself, in an official letter, as doubting the word of the head of the navy department. It seems that Colonel McCowley, lately deceased, was asked by the department to vacate the quarters he was occupying in this city while awaiting retirement and proceed to Philadelphia. This was done by the secretary, he says, to enable certain repairs to be made to the house occupied by the colonel at the headquarters. The case finally came before the controller, who decided that Colonel McCowley was not entitled to be paid commutation for quarters. Secretary Tracy wrote the controller that McCowley had vacated the quarters for "the convenience of the government." The controller, in a letter which he wrote to the navy department, said that the officer had not vacated his quarters in Washington for the benefit of the government or for its convenience, but that the whole matter was conducted with a view to bring the case within the regulations entitling the officer to commutation. In other words the secretary was guilty of trying to swindle the government and then lying about it. The controller's letter went to the commandant of the marine corps in its regular travels as a red-tape document, and the secretary never saw it. The officers at the marine corps had not the courage to show the letter to the secretary and have allowed the matter to drop. The chances are that when the knowledge of the letter reaches the secretary there will be some interesting remarks made of and to Controller Gilkerson.

Oil Tanks on Fire. LUDLOW, Ky., Aug. 2.—The fire which started on Tuesday night in Garlich & Co.'s sheds and turpentine warehouse is still raging. The blaze is now issuing from three large tanks, also at the manhole near the bottom of the tank on the north side, the lead gaskets that encircled the manhole having melted away, and causing an opening all around the manhole two feet in diameter. A large amount of oil is permitted to flow from the tank. The oil that is not consumed is sweeping into the ravine. Residents in the ravine are warned, lest the manhole, which is made of cast iron

give way, and empty the contents of the big tank, which contains nearly 60,000 gallons, upon them. Should it occur it will cause serious damage.

Acceptance of Straw Bonds. DENVER, Col., Aug. 2.—The big mining suit of A. W. Rucker, of Aspen, against Harvey Young is still hanging fire between the district and the supreme court. The defendant filed a bond in the sum of \$1,000,000 which was approved by Judge Beatty. Rucker's lawyers maintain that the court was imposed upon and that the bond is of no account. An affidavit made by the plaintiff, Rucker, in New York, on the 30th inst., is on file in the case. Mr. Rucker swears that the principal, Otto Mears, has very little, if any, property not encumbered for a larger sum than the same would bring if its creditors should proceed against him. Rucker also claims that L. C. Ehrlich, another surety, during the present month had made an effort at Colorado Springs to borrow \$20,000 on a note, with J. B. Wheeler as indorser, and that he failed to raise the cash. It is claimed that Charles Adams is largely involved. The plaintiff asserts that he has been unable to ascertain that the remaining sureties have any property whatever Judge Beatty decided that when the case has been adjudicated so far as the district court was concerned, and when the appeal bond had been approved and filed, the court lost jurisdiction of the case, and its orders made had to stand.

Fatal Accident. EUGENE, Or., Aug. 2.—Mrs. C. D. Maxwell was the victim of a fatal accident near Elmira last Saturday. Maxwell and his wife were having some trouble, the result of a recent separation, when J. H. Gates, brother of Mrs. Maxwell interceded in her behalf. Maxwell gave indications of an assault with a pistol, and Mrs. Maxwell went to the house to get a shotgun for her brother. It was accidentally discharged, the load entering her left side.
