

THE KNIGHTS TEMPLARS.

A Strange Decision, Crimes, Suicide, Etc.

REMARKABLE DECISION. Damages for \$1900 That Cannot Be Collected.

PORTLAND, Or., Aug. 10.—Judge Dwyer, in the United States district court yesterday, decided the case of William Ingate Ball against the members of the common council of the city of Portland. Ball brought a suit against the members of the council to recover damages to the extent of \$9850 for personal injuries, alleged to have been sustained some time last year by stepping on a defective plank in the sidewalk near the corner of Washington and Seventh streets.

The case was tried several days ago. Under the charter, suit could not be maintained against the city as a municipality, but must be brought against the members of the council and the superintendent of the streets. This suit was so brought. The court did not award Ball damages, on the ground that actual and constructive notice had not been served upon the members of the council and superintendent of streets that the sidewalk at that point was out of repair. This should have been shown at the trial. It was not shown that an ordinance was passed providing for the repair of the sidewalk. The court found that the plaintiff had sustained severe injury by reason of the accident, and was entitled to recover \$1900, but held that, under the law, the members of the common council could not be held responsible for the amount, for the reason given above. Under the circumstances, the plaintiff will not be able to recover and a judgment for costs was entered against him.

Knights Templars.

DENVER, Colo., Aug. 10.—The Grand Knights Templars parade began at 10 o'clock yesterday. The division presented a magnificent appearance and marched in the following order: First division, Colorado with the Right Eminent Sir Byron L. Carr commanding; second division, District of Columbia, Massachusetts, Rhode Island and South Carolina; third, New York, New Hampshire and Connecticut; fourth, Ohio and Kentucky; fifth, Pennsylvania; sixth, Indiana and Texas; seventh, Michigan, Mississippi and Manitoba; eighth, Illinois; ninth, California, Georgia, Wisconsin and New Jersey; tenth, Missouri, Alabama and New Mexico; twelfth, Kansas and Utah; thirteenth, Nebraska, West Virginia, Arkansas and Oklahoma; fourteenth, North Carolina, North Dakota, South Dakota, Arizona, and the following: Oregon—Portland, No. 1; Portland Temple No. 3, F. W. Langdon, Albany, Washington—Cataract No. 3, Henry Bush, Spokane Falls; Yahey, C. Blalock, Walla Walla. Representatives from Montana and Wyoming.

The day's parade was so perfect that not the slightest hitch occurred. The grand encampment officers reached the reviewing stand a few minutes after 10 o'clock, and the great parade, headed by the Colorado commandery, made its appearance before the grand stand at 10:30. Nearly 200,000 people were scattered along the line of march when the parade started. The business of the grand encampment was confined principally to welcoming officers by representatives of the city and state. Frank Neill, chairman of the triennial executive committee, extended a cordial greeting, and Governor Boutz and Mayor Rogers each delivered addresses of welcome. General Carr, grand commander of Colorado, extended a fraternal greeting. Grand Master Cobin, in responding, spoke highly of the manner in which the Knights Templars were received. After addresses, the grand encampment went into secret session, and subsequently settled that the successor of Grand Master Cobin will be present. Dapudy Grand Master McCurdy. Last evening a round social was exchanged between various headquarters.

DENVER, Aug. 10.—The real business of the Knights Templars convocation began this morning. Consideration of the new ritual on the report of the ritual committee was taken up. It is almost certain Judge Hugh McCurdy, of Michigan will be elected grand master. Reuben H. Lloyd, of San Francisco, will probably be the grand generalissimo. The exhibition drill this morning was witnessed by ten thousand people.

Washington Republicans.

OLYMPIA, Wn., Aug. 10.—Republican state convention was called to order today at 10 a. m. by E. T. Wilson, chairman of state central committee. After prayer, Colonel Howlett of Yakima and J. M. McMillan placed in nomination for temporary chairman. The ballot resulted in the choice of Howlett for chairman. Wilson in surrendering the gavel to Howlett said: "I am pleased to present this emblem of authority made of American tin by an American thruster."

Found Dead at Hotel Portland.

PORTLAND, Or., Aug. 10.—Charles Wolf, from San Francisco, was found dead this morning in a room at the Hotel Portland. It is thought he committed suicide. Deceased was about thirty years of age and traveling for a boot and shoe firm.

DESPERATE INDIAN.

Killed the Authorities and Was Killed by a Cowboy.

ALBUQUERQUE, N. M., Aug. 10.—The killing of a desperate Navajo Indian took place at Navajo Springs, on the Atlantic & Pacific railroad. The sheriff of Apache county, A. T., was called to arrest the unruly savage, when the latter pulled his pistol and threatened to kill the sheriff. The officer then summoned two cowboys to his aid, and when one of the cowboys told the Indian to surrender he was ordered to fall back or be shot. The cowboy, however, pulled his gun and fired pointblank at the Indian, the ball passing through his heart. Several other Indians witnessed the killing, and carried the dead body off with them, swearing vengeance. Word received from Navajo today states that the whites have collected all the Winchester and shotgun traps that are to be found, and are afraid the Indians will carry out their threats.

From Coeur d'Alene.

WARDNER, Idaho, Aug. 10.—Forty-two prisoners who refused to sign the parole were released on bond ranging from three hundred to one thousand dollars. They are the men whom Captain Johns examined and recommended for parole, the evidence against them not warranting their being held for any crime. Two companies are under orders to conduct the remainder of the prisoners to Wallace. It is expected that headquarters and the remaining troops will be moved to the same place in a short time, the only existing necessity for troops being to guard prisoners here. There is no danger in removing them from this point. It has been definitely decided by the war department to retain four companies in the vicinity of Wallace until Governor Willey decides their services are no longer necessary as a protection to life and property. The other troops will be withdrawn the first of September.

Outlaws Go to Church.

PITTSBURG, Aug. 10.—News has been received that the Cooley gang of outlaws Sunday night boldly attended church in Smithfield village, Fayette county. They rode up to the Methodist church door, hitched their horses, and entered the sanctuary as calmly as the oldest members. They wore their belts with revolvers displayed, but carried no guns. As they sat on each side of the door they were recognized by dozens of the members who knew them well by sight, but the terrified congregation were too timorous to go out past the bandits and give the alarm. No more outwardly d vent than the outlaws on the back seat could be found among the members, and when the contribution-box was circulated they all clipped in. While the congregation sang the Doxology, the outlaws slipped out, mounted and rode off, yelling like Indians. No attempt was made to arrest them. Constable Wilson, of this place, is organizing a posse here to go to the vicinity of Dietrich's and entrap the outlaws.

Get Threatening Letters.

PITTSBURG, Aug. 10.—Alderman Mc Masters received anonymous letters posted at New York saying "Some time this week a party of men will leave here and will try to kill you and Superintendent Frick again." All attorneys engaged in the prosecution of the Homestead riot cases have within a week received several letters of threatening character. Other officials of Carnegie company are still receiving letters threatening their lives.

Alabama Doubtful.

WASHINGTON, Aug. 10.—The Star's special from Montgomery, Ala., says that B. F. Kolb, late Alliance candidate for governor, is out in a published letter this morning disputing the claim of Jones' election. The letter creates a sensation, and is regarded as evidence of Kolb's intention to challenge an official count, which is nearly completed and fixes Jones' majority at between 9000 and 12,000.

The Body of Riggan.

NEW YORK, Aug. 10.—Body of Chas. W. Riggan, sailor of the U. S. S. Baltimore who was murdered in Valparaiso, Chile, during the recent trouble, arrived last night. It will be taken to Philadelphia for interment.

Found Murdered.

DEMING, N. M., Aug. 10.—Intelligence has just been received of the murder of Lee Hodgdon, the 21 year old son of J. B. Hodgdon, of this town, and a Mexican named Escantala, whose bodies were found near Hatcheria, yesterday. It is thought a band of fifteen renegade Indians from San Carlos reservation are the murderers.

Georgia Democrats.

ATLANTA, Ga., Aug. 10.—Georgia state Democratic convention met today. There is no doubt of the nomination of W. J. Norther, the present incumbent for governor and there will be very little contention in the other offices.

Republican Illegible.

CHICAGO, Aug. 10.—Special from Omaha, Neb., says it has been discovered that Rev. J. G. Tate, the Republican nominee for lieutenant governor is illegible. Tate is an Englishman and failed to take out his naturalization papers until a year ago.

THE IRISH POLICY.

Gladstone Attacks the Government.

LONDON, Aug. 10.—In the commons, after some unimportant business, Gladstone began his speech against the government. He said the government had departed from all precedents in not resigning when the verdict of the country was against them. The house has now met, but what for? The queen's speech told them nothing. Was the house of commons to fight the battles of the last six years over again? Never had a greater issue been submitted to the country been so fully discussed as the issue decided at the last general election. Turning to the matter of home rule, amid loud cheers from the Irish members, Gladstone said the claims of Ireland had been for years the forefront of the battle, and that the position he held, and the principle of his home-rule bill were perfectly well known. By the provisions there would be a full and effectual maintenance of imperial supremacy, while Ireland would be given conduct of her own affairs. Gladstone said that for seven years the bill had received his first and absorbing attention, and would continue till the end. The house would pass a bill giving Ireland self-government, and it would then go to the lords. He would not argue upon the probability of the lords rejecting the bill. The obligations of the Liberal government would utterly forbid acquiescence in the rejection of obligations to promote the settlement of a great subject. He said the various measures of reform which the Liberals pass while in opposition represented the essential character of the Liberal policy. In regard to evicted tenants, Gladstone expressed the hope that in autumn a voluntary arrangement between landlord and tenant would obviate the necessity for such legislation as would become inevitable if no arrangements were made. In concluding his speech, Gladstone recurred to the conservative argument that the Irish majority is trying to coerce England. He held that such was the strength of England in relation to the other kingdoms that she never could be coerced by them.

Balfour followed Gladstone.

Balfour followed Gladstone. He maintained that the commons had a right to know before entrusting the government to the Liberals what their policy was. Lieutenant Colonel Edward James Sanderson (Conservative) made a bantering speech, in which he charged that Rome would govern Irish affairs, saying that the chief member of Gladstone's cabinet would in reality be Archbishop Walsh.

Redmon predicted the Irish parliament would be as free from interference on the part of Rome as from interference on the part of the British parliament.

His Teeth for Their Reward.

BRUNSWICK, N. J., Aug. 10.—John Lucas, known as the African Zulu, rode well high naked on top of a wagon in a circus parade here yesterday. The boys guided him, and finally employed eggs and fruit. This so enraged the Zulu that he sprang from the wagon with a war-whoop and attacked the boys like a savage beast, biting into their flesh wherever he could fasten his teeth. Before the negro could be driven off he had severely bitten John Hickey on the arm, James Johnson on the neck and Robert Applegate on the breast.

Reduction in Freight Rates.

SAN FRANCISCO, August 10.—A reduction in freight has been made by the Southern Pacific company between this city and points in Eastern Washington and Western Idaho reached by the Mount Shasta route in connection with the Union Pacific at Portland. Spokane at the north and Caldwell, Idaho, at the east, are outer railroad limits of the territory affected by this change. The order will go into effect on August 15th. Reduced rates, first-class, \$1.77; second-class, \$1.62; third-class, \$1.47; fourth-class, \$1.37; fifth-class, \$1.02; class A, 82 cents; class B, 82 cents; class C, 77 cents; class D, 72 cents; class E, 62 cents.

Death Sentence Commuted.

MEMPHIS, Tenn., Aug. 10.—Governor Buchanan, in Nashville, last evening commuted the sentence of Colonel H. Clay King, who was to have been hanged next Friday for the murder of David H. Posten on March 15 last on the public streets in this city. Unusual pressure has been brought to bear upon the governor for the past few days. Senators Harrison and other leading politicians have made several calls upon him, and have succeeded in securing the desired commutation. The prisoner heard the news with but little interest.

Non-Union Man Beaten.

PITTSBURG, Aug. 10.—John Reams a non-union workman employed at the upper union mill was assaulted by two men while on his way to work this morning and badly beaten. His assailants were arrested and recognized as Edward Zimmerman, a striker and Thomas Zimmermann, a former employee. Reams' injuries are painful but not dangerous.

Murderer Escaped.

BALTIMORE, N. Y., Aug.—Martin Fox Jr. confined in county jail here for the murder of Henrietta Wilson in Saratoga last May, escaped this morning.

Tough Customer.

BRIDGEPORT, N. Y., Aug. 10.—Dr. T. J. Smith was called on Friday night last to examine David Bateman, who was suffering from a swollen eye. The doctor found that Bateman's eye had been turned inside out. He dressed it. Bateman told the doctor that his eye was all right when he went to bed on Thursday night, but when he awoke in the morning it was swollen. Dr. Smith then thought the man had been stung by a spider. After Dr. Smith's examination "Roachy" Ryan started to take Bateman in a wagon to his home in Port Norris, but the man raved so with pain that Ryan had difficulty in keeping him in the wagon. When he arrived at Newport Bateman jumped out of the wagon and ran off. He wandered to Nantuxet creek, which he swam, and traveled about five miles through the marshes to Cedar creek and then swam over to Jones' island, where he was found yesterday in an exhausted condition and was taken to his home. Upon close examination yesterday it was found that he had been struck over the eye with a club, and there were two knife wounds in his back, which, it is thought, will prove fatal. Local police will probably arrest the men whom Bateman was with on Thursday night, as it is now believed his injuries were received during a row that probably occurred then.

Champion Stakes.

NEW YORK, Aug. 10.—The ninth junior champion and the fourteenth champion stakes were decided at Mousmouth Park track yesterday afternoon. The field for both races was of a high quality, and numerous enough to make the sport an interesting character. The best of the 2-year-olds of the East were to go to the post for junior champion, and Garrison was not able to ride Sir Walter, there was considerable chance for a filly to win the stake for the first time. Since Wanda put it to the credit of Lordard I, the first year that the people may have a chance to see all the racing that is possible, the management arranged to have all the races, except two, for the 2-year-olds run over circular courses. This is a feature that strongly appeals to the holiday crowds as well as to satisfy nine-tenths of the regular racegoers, who like to see the whole of a race and all of the incidents. Over the circular courses they can tell something about the way in which the horses are handled, which is impossible when the first half of a race is run down in the Easton town. The champion stakes, one mile and one-half, was won by Lamplighter, Byrquet second, Loochatchie third; time, 2:32.

The Borden Murder.

FALL RIVER, Mass., Aug. 10.—Yesterday morning Bridget Sullivan a servant in the Borden family, was summoned to the central police station. She walked down in company with an officer and talked quite freely on the way. She looked very much worried and was quite pale as compared with her appearance last Thursday when seen first by a reporter. She told the officer that it was very hard to be watched so closely, and to have one's private affairs torn to pieces. She was willing, however, to have the police or any one else examine her every action since she arose Thursday until she was asked to go to the police station with the officer. She did not care to talk very much about the details of her family relations. She said she wanted to leave two or three weeks ago, but was obliged to remain by Mrs. Borden, of whom she spoke, however, kindly. She was taken at once into the city marshal's presence and also into the presence of District Attorney Knowles and Medical Examiner Dolan. These men, with Judge Blaisdel and two detectives, who are now handling the case, do not care to be quoted as having given any opinion on the merits of the present state of things, but they all agree that affairs are at a critical point and action may be taken at once. Miss Sullivan was brought before the men to undergo a thorough examination as to the facts before and after the murder, as far as she knew them.

Refused to Interfere.

SACRAMENTO, Calif., Aug. 10.—Governor Markham today issued the following decision in the matter of commutation of John McNulty sentenced to be hanged at San Francisco next Friday for the murder of John Collins. The governor says: "I have after mature deliberations determined not to interfere in the execution of said sentence."
