Colvig Won't Withdraw.

GRANT'S PASS, Or., Nov. 3.—(Hor.) Wm. M. Colvig, Democratic candidate for elector spoke here last night. He said, "when you go to the polls on November 8th to vote, there will still remain at least two candidates on the Democratic ticket, myself and Butler."

COLVIG WILL NOT RESIGN.

PORTLAND, Nov. 3.—The following telegram was received from Mr. Colvig late last evening:

GRANT'S PASS, Or., Nov. 3, 1892.—Evening Telegram: Deny the rumor that I have resigned as a candidate for elector. I will not under any circumstances.

The Oregon Pacific Ordered Sold.

CORVALLIS, Nov. 3.—The time having expired for the completion of the purchase of the Oregon Pacific railroad. Judge Fullerton convened court in this city yesterday, and after hearing argument, ordered a new sale of the road, and parties were given until the 17th inst. to prepare the formal order. It was also ordered that the previous purchases have the privilege of completing the former sale if done within 30 days.

THE ELECTORAL TICKET.

Democrats Counting the Chickens.

PORTLAND, Nov. 3.—It is almost certain that the Democratic electoral ticket will remain in the field. The candidates are still firm in their determination not to withdraw, and they are meeting with strong support. It is now thought that a campaign committee will send out a request to voters to ignore the Democratic ticket and vote for the populists. They figure that according to the result of the June election, the Republicans are in a minority by ten thousand votes, and allowing five thousand votes to the straight Democratic ticket, they can, by combining with the populists, carry the state by five thousand.

THE ELECTION.

Duty of U. S. Deputy Marshals.

WASHINGTON, D. C., Nov. 3.—Acting Attorney General Aldrich, in a statement touching the authority of the United States deputy marshals to supervise election, says all persons who attempt to interfere with them will bring themselves within the scope of the federal statutes, regardless of whether they are acting under state or municipal law the statement says attention.

of the State Department has been called to this matter through certain alleged instructions to police and state officers in Alabama, Arkansas and New York, with reference to their conduct toward United States marshals at the polls. It declares marshals are there as peace officers, and are instructed not to allow discrimination for or against either party, but to secure an honest vote and fair count. It denies the doctrine of supremacy of state over United States in the matter of elections.

Sent out for Effect on Voter.

INDIANAPOLIS, Ind., Nov. 3.—Attorney General Miller now here says: I do not think the circular sent out from Democratic headquarters in New York, counseling remittance to use the rooms of the United States marshals within 250 feet of polls, was meant in earnest, but that it is merely a bit of campaign literature sent out to have effect on voters before election day. He said marshals would only be sent where applied for and needed, and believed all would respect their authority.

Bonus Tickets to Be Distributed.

PALMYRA, N. Y., Nov. 3.—A regular bonus ballot factory was discovered in Wayne county. It was exposed to flood every county in the state with them. These electoral tickets were headed with the name of Henry W. Sage and Jesse

Wheeler, the rest being Democratic names. The balance of the ticket was headed with the name of Henry W. Sage, where it varied according to the state. It was proposed to mail these to Republicans through the state, with instructions for them to pass as purporting to be sent by Republican committee.

Mistake in Election Tickets.

CHARLESTON, S. C., Nov. 3.—It has been discovered today that a serious error has been made in printing the Democratic electoral tickets in this state, which will result in their being thrown out, unless corrected. Most of those heard from are one-sixteenth of an inch too long; some too small; some too large. The law says they must be 5 by 2 1/2 inches. Strenuous efforts are being made to remedy the error.

The Great Parade.

PORTLAND, Nov. 3.—Republicans are making extensive preparations for tonight's demonstration. The morning trains brought in a great number of Republicans from the interior of the state. They all express great satisfaction over fight amongst the Democrats on the question of fusion.

President's Acknowledgment.

WASHINGTON, Nov. 3.—The president yesterday requested the publication of the following:

"The expressions of sympathy with me and my family in our great sorrow from individuals, from societies, from church conventions, from public meetings, from political clubs and committees of all parties, and indeed from all the people, have been so tender and so full of respect and love for Mrs. Harrison that I reluctantly abandon the purpose of making a personal acknowledgment of each. We are grateful, very grateful, for this cup of good-will, and for your prayerful intercessions. May God give to each of you in every trial that grace and strength which you have asked for us."

Great Republican Parade.

BOSTON, Mass., Nov. 3.—[Special.]—The Republican demonstration here to-night for which the State managers have been preparing throughout the past month will undoubtedly surpass any like event in the political history of the State. Major Frank H. Briggs, of Boston, will be chief Marshal and fifty cities in the State will be represented in the line. More than 5,000 college students will be in line, including 1,300 from Harvard, 700 from the Institute of Technology, and large companies from Williams, Tufts and other colleges and Boston University. It is possible that 200 or 300 Yale men will join in the college division. The Boston marketmen will engage in the parade, mounted.

Outcome of the Sontag Trial.

FRESNO, Calif., Nov. 3.—The outcome of the Sontag trial does not seem to have stimulated the detectives and officials to make another attempt to capture the train robbers. It was stated here as a positive fact that Evans was in Sanger Friday evening last and spent the greater part of the night there. The person who gave this information is an officer, and though he would not say who told him he asserted that it came from a reliable source.

George Sontag, convicted of complicity in the Colles train robbery, was today sentenced to life imprisonment by Judge Holmes. Attorney Caldwell immediately gave notice of appeal.

Not to Be Withdrawn.

PORTLAND, Nov. 3.—Democratic State Central committee issued an address this afternoon, to electors of Oregon, saying that the Democratic electoral ticket would not be withdrawn but would remain in the field, and asking all favoring the election of Cleveland and Stevenson to rally to its support.

LAKESIDE, N. J., Nov. 3.—Edwin Booth the actor, left today for New York. He had to be supported by his son-in-law and daughter, from the hotel to the carriage.

Biographical Sketch of Lieut. Fred Schwatka.

Frederick Schwatka was born in Helena, Ill., September 29, 1840. He was appointed to West Point from Salem during the time Hon. Rufus Mallory was a member of congress, in June, 1857. After graduating at the United States military academy in 1861, he was appointed second lieutenant in the Third cavalry, and served on garrison and frontier duty until 1877. During the time he was stationed for several years in Arizona. Afterward he went to New York, and devoted some time in the study of law and medicine, in both of which branches he attained a high degree of proficiency. He was admitted to the bar of Nebraska in 1875, and received his medical degree at Bellevue hospital medical college, New York, in 1876.

HE SAILS FOR THE NORTH.

On hearing the story of Captain Thomas F. Barry, who, while on a whaling expedition in Repulse bay in 1874-75, was visited by Esquimaux who described strangers who had traveled through that region several days before, and who had buried papers in a cavern, where silver spoons and other relics had been found, Lieutenant Schwatka determined to search for traces of Sir John Franklin's party, and obtaining leave of absence, he fitted out an expedition.

On the 19th of June, 1878, accompanied by William H. Gilder as second in command, he sailed in the Eothen for King William's Land. The party returned on the 22d of September, 1880, having discovered and buried many of the skeletons of Sir John Franklin's party, and removed much of the mystery of its fate.

WHAT WAS DISCOVERED.

Lieutenant Schwatka discovered the grave of Lieutenant John Irving, third officer of the Terror, and, in addition to many interesting relics, a paper which was a copy of the Crozier record that was found in 1859, by Lieutenant William R. Hobson, of Leopold McClintock's expedition, and which contained two records, the latter, under date of April 25, 1848, stating the death of Sir John Franklin on June 7, 1847.

This expedition was also marked by the longest sledge journey on record—being 3251 statute miles—during which a branch of the Schwatzka river was discovered, which Lieutenant Schwatka named for President Hayes. Subsequently he explored the course of the Yukon river in Alaska, and rejoined his regiment in July, 1884.

For several years General Miles was in command of the department of the Columbia, with his headquarters at Vancouver, Wash. During a greater portion of that time, Lieutenant Schwatka resided at Vancouver. At the time of the rescue of the survivors of the unfortunate Jannette expedition, Lieutenant Schwatka was interviewed at much length in regard to his views of the cruise, which were telegraphed all over the country, and appeared in many of the large Eastern journals.

REMARKS FROM THE ARMY.

In January, 1885, Schwatka tendered his commission of first lieutenant of Third cavalry, to which he was appointed in March, 1879, and retired from the army. Since leaving the army deceased has been an extensive traveler, having visited Europe in the course of his scientific wanderings. In 1886 he was in command of the New York Times Alaskan exploring expedition and made a trip down the great Amazon to the mouth, for a distance of more than 1000 miles. The expedition was filled with dangers, privations and countless thrilling experiences.

Accounts of the great voyage down this river were written by Schwatka for the New York Times. A series of articles profusely illustrated also appeared in one of the leading magazines of the country. The discovery and naming of the famous "Jones river" (in honor of the founders of the New York Times) is still fresh in the memory of the public. The claim was made that the discovery was no new thing and there was no end of good-natured press comment over the matter.

TRAVELS, HONORS, MEDALS.

Of late years Schwatka has traveled considerably. He has made several trips to Alaska, and quite recently made a tour through Mexico in the interest of one of the leading journals of the country, writing a series of letters regarding his travels through the romantic land of the ancient Aztecs. He has also written a great number of syndicate letters on a great variety of subjects.

Lieutenant Schwatka has received the Roquette Arctic medal from the Geographical Society of Paris, and a medal from the Imperial Geographical Society of Russia, and was an honorary member of the geographical societies of Bremen, Geneva and Rome. He was the author of "Along Alaska's Great River," "Nimrod in the North," "The Children of the Cold," "Schwatka's Search," "The Franklin Search Under Lieutenant Schwatka."

NEW BOOKS AND MAGAZINES.

Whoever does not subscribe to the literary cockneyism of the present day is apt to be voted a disagreeable person. Yet cockneyism it is and remains. If the injurious impression created, by passing it off upon the people as "American literature" could be confined to the authors, the effect would not be so serious; but the demoralizing influences exerted upon a people, by feeding their mind upon so gross a delusion, and making a counterfeit so common that the genuine metal of letters is not any longer recognized, is serious indeed. Study of the classics has been derided and the superior value of "English as she is Spoken" at our freshwater colleges excited until the land swarms with mediocrity and advertising impostors who pose as the lights of literature. These writers greatly-puffed are as quickly snuffed and go out in oblivion, leaving the world they would illumine in greatest darkness, so far as any light coming from their transparent, yet densely opaque productions. The needy world cries where are our poets, novelists and essayists, and young persons of both sexes who number the pages of our periodicals cannot answer. They cannot tell us where to look for them. We look out upon a blank ocean of letters where no great ships stand against the horizon. Plenty of little pot-hunters near the shore, but not a vessel that we can go to sea in.

"The West from a Car Window" by Richard Harding Davis, is sent out in the Harpers' best style of book, and is destined to become a popular western hand book of travel.
