

CLEVELAND'S GUFF.

He was not Elected by the Politicians.

CHIEF MAGISTRATE ON THE PEOPLE.

He Will not be Dictated to by Anybody, Etc.

CHICAGO, Nov. 15.—A Washington special to a Republican paper says: That was an exciting, heart-breaking conversation, as far as certain Democratic leaders are concerned, that was held recently in Cleveland's residence in New York. The details are gradually breaking out from its auditors. Good plain English was spoken by the president-elect and he did not hesitate to emphasize the fact that he has been chosen chief magistrate by the people, not by the politicians. "I am under no obligations to Tammany hall or any other organization for my election," he said, "and I do not propose to be dictated to by anybody."

"Now that I am president it is my intention to be the head of this nation in reality and I will not permit any dictation as to my future actions." In course of same conference Cleveland set his face resolutely against an extra session of congress saying there need be no haste about revising the tariff before the regular session, which would begin in December, 1893.

Delmonico Banquet.

New York, Nov. 15.—The 124th annual banquet of the chamber of commerce will be held at Delmonico's this evening. Among the six hundred guests present will be President-elect Cleveland, who will make a speech; so will Chauncey M. Depew; Secretary Elkins will speak in answer to the toast of the president of the United States, President Harrison being unable to attend because of recent domestic affliction. Secretary Foster will speak about the financial question.

Smith Heresy Trial.

CINCINNATI, Ohio, Nov. 15.—The trial of Rev. Heresy Preserved Smith for Heresy was resumed this morning by the Cincinnati Presbytery. It is believed Prof. Smith's defense read yesterday will make serious inroads on the opposition and it is claimed while only three were avowed friends of Smith before trial began, there could not now be found in the Presbytery two-thirds to vote against him.

Paper Labeled.

LONDON, Nov. 15.—In an action for libel brought by the proprietor of a saloon against the Chronicle, and tried before Lord Coleridge on Saturday, a verdict for £400 was given against that paper. It appears that the authorities had refused to grant a license for the saloon, and in commenting on this fact the Chronicle called the place a brothel. In today's issue the paper boldly criticized the result of the trial in a leading article and scolded Lord Chief Justice Coleridge for his conduct in the case. It is thought that the surprising free comments will more than likely get the paper into further trouble.

To Be Buried In It.

LONDON, Nov. 15.—The Financial News says it thinks the long-expected boom in American railroad shares may come at any time. American speculators, it declares, have not yet grasped the potential sources of traffic expansion that will be afforded by the Columbian exposition. There is nothing extravagant in the estimate that \$250,000,000 of foreign money will be left in America as a harvest of the exposition. The Americans will be literally buried with money seeking investment.

Shot by a Carnegie Workman.

HOMESTEAD, Pa., Nov. 15.—Max Newman, a non-union workman at the Carnegie Mills, last night shot and killed a man supposed to be named Maynard, in a bunk house inside of the mill yard. Newman says the man assaulted him in his bunk, and believing him to be a striker, he shot him. Newman is held to await the action of the coroner's jury.

A Fiend Hanged.

LONDON, Nov. 14.—Thomas Neill, alias Cream, the murderer of Matilda Clover and several other unfortunate girls, was hanged at 9 o'clock this morning.

The Wyoming Legislature.

CHEYENNE, Wyo., Nov. 15.—The chairman of both committees claim the state legislature and it will take the official count to determine the result.

FINANCE BEFORE TARIFF.

Free Silver More Important than Free Trade.

SAN FRANCISCO, Nov. 15.—Senator Stewart, of Nevada, who is in this city, was asked by a reporter how he would stand on the subject of tariff reform in the United States senate. "The tariff," said the senator, "is a matter of small consequence compared with the financial question. I am for free silver, and as to the tariff, I stand where Lincoln stood as to slavery when he wrote that if the Union could be preserved without destroying slavery he was for preserving the Union that way, but if the Union could not be saved without the abolition of slavery, then he was for abolition."

"But suppose the tariff reform proposition comes up independently altogether of silver, how will you vote?" "On the merits of the proposition," replied the senator. "But for or against protection?" "Tariff legislation, even if wholesome in itself," replied Senator Stewart promptly, "is not adequate to relieve the state of things I have described. Until the silver question is settled, and it never will be until it is settled right, no party can remain in power more than four years." "Will you vote to remove the McKinley duties?" "Sir," said the senator, "I shall be a high tariff man or a low tariff man or for free trade, according as my position may affect silver. All other questions sink into insignificance beside the money question. I shall use my vote under all circumstances toward securing free coinage."

PENSION REQUIREMENTS.

Grave Financial Problem Involved in Payments.

WASHINGTON, Nov. 15.—A call will be issued soon for the meeting of the house committee on appropriations on Monday Nov. 28th. This will give the committee about a week's time in which to prepare some regular annual appropriation bills for the action of congress when it meets for the second session. It is the purpose to push rapidly all these measures for the maintenance of the government next year. Exceedingly heavy payments by the treasury department during the first quarter of the present fiscal year caused some dismay among members of the appropriation committee. For the first four months of the year these payments exceeded by \$16,000,000 the expenditure for the corresponding period of the preceding fiscal year, which means a total increase for the present year of \$48,000,000, while the appropriations for the year were only \$12,000,000 greater than the appropriations for last year. That means (if the estimates of the committee hold good) a deficiency on accounts of pensions of \$36,000,000 which will have to be met by congress at the next session, in addition to the appropriation for pensions for the next fiscal year of certainly not less than \$150,000,000, so the total appropriations that congress must make for pensions next session will aggregate not less than \$188,000,000.

Schooner Danielson Stranded.

MANHATTAN, Or., Nov. 15.—W. F. Stevens, proprietor of a saw mill at Sluslaw, who arrived yesterday on the steamer Chance, brings intelligence that the scow schooner S. Danielson was stranded on the north spit of Sluslaw bar, Friday afternoon. Captain Gruggles was endeavoring to sail and succeeded in crossing the bar, but got to the north of the channel and grounded. The Danielson is loaded with freight. A tug with a barge in tow went to her assistance on Saturday, but as the schooner was high and dry and out of danger it was thought best to leave her and the cargo alone, with the hope of getting her off at the next high tide. Stevens said the schooner could be floated, but it would be a difficult task.

Probably All Drowned.

TACOMA, Nov. 15.—Considerable anxiety was caused last evening by a dispatch stating that the Naptha launch Ruth was found in the straits beyond Port Townsend. The Ruth left here Sunday morning with Jacob Johnson and Geo. Hansen, her owners, both employees of the Pacific Naptha Launch works, who, with three friends, were going duck hunting near Olympia. It is supposed the small launch became unmanageable in the furious storm last night. It is feared the party is drowned.

Colored Bishop Dead.

LOUISVILLE, Ky., Nov. 15.—Bishop W. H. Miles, senior bishop of the colored Methodist church, America, died here, aged 65 years. He had preached over 40 years.

A Probi Killed.

RICHMOND, Va., Nov. 15.—Rev. J. B. Moffett, pastor of the Baptist church at North Danville and a recognized prohibition leader, who was shot by J. T. Clark, a lawyer and prominent Democrat, last Friday, is dead.

Ministers to Italy and Turkey.

WASHINGTON, D. C., Nov. 15.—The president today appointed Wm. Potter, of Pennsylvania, minister to Italy, and D. P. Thompson, of Portland, Oregon, minister to Turkey.

Mrs. Emerson Dead.

The following proclamation was issued by President Harrison on Friday, Nov. 4:

"The gifts of God to our people during the past year have been so abundant and so special, that the spirit of devout thanksgiving awaits not the call, but only the appointment of a day when it may have common expression. He has stayed pestilence at our doors. He has given us more love for civil institutions, in the creation of which his directing providence is so conspicuous. He has awakened a deeper reverence for the laws. He has widened our philanthropy by a call to succor distress in other lands. He has blessed our schools, and is bringing forward a patriotic and God-fearing generation to execute his great and benevolent designs in our country. He has given us great increase in material wealth and wide diffusion and contentment and comfort in the homes of our people. He has given his grace to the sorrowing. Now, therefore, I, Benjamin Harrison, president of the United States do call upon all our people to observe, as has been their wont, Thursday, the 24th day of the month, November, as a day of thanksgiving to God for his mercies and a supplication for his continued care and grace."

Eighteen Millions of Soldiers.

An official report to the French Chamber of Deputies shows that France has spent since the Franco-Prussian War nearly \$3,075,000,000 in creating and maintaining her army. That is the price of the present French army in time of peace. The country has paid this amount, not for fighting, but in order to be ready to fight. In addition to this expenditure of about \$150,000,000 a year on the average, France pays about \$200,000,000 annually as interest and amortization on the French public debt, while the military establishment involves the permanent maintenance of 500,000 men and 140,000 horses in a state of absolute uselessness, so far as industrial production is concerned. Were France able to dispense with this costly instrument of devastation and death she could save not only \$150,000,000 a year, but her wealth would be annually increased by the industry of all those idle men and horses to an extent representing perhaps from \$250,000,000 to \$500,000,000. Meantime both Germany and Austria are increasing their military expenditures; Italy is reluctant, even under pressure of financial distress, to reduce her disproportionate military establishment, and Russia, not withstanding enormous losses of revenue and extraordinary expenses attending the recent famine, finds money enough to support her immense standing armies. It is estimated that the nations of Europe spend considerably more than \$1,000,000,000 every twelve months in keeping ready to fight each other.
