GAME LAW.—Nov. 15th is the last day that China pheasants can be legally executed by gun or otherwise. The open season for killing grouse, pheasants, Mongolian pheasants, quail or partridges, closes at 12 o'clock tonight. After that the destruction of these birds will be punishable by a fine not exceeding \$300 or imprisonment in the county jail not to exceed three months. The Albany Democrat says: "The law should be rigidly enforced." The following from the Corvallis correspondent of the Portland Review shows plenty to be protected: Jim Taylor and Zep Jagged 27 China pheasants on Sunday and report seeing not less than 500 pheasants; but very wild, getting up from one to three hundred yards and flying to timber. The number of birds seen by the sportsmen is a good guarantee of the large crop left for seed, and if they can be protected after November 15th, there will be plenty of birds for next season. Several other good bags are reported from Sunday's shooting."

DEMOCRATS BUBBLE OVER.

Their Great Barbecue at Salem—The Salt River Crew.

In spite of showers and muddy roads there was a big turnout at the Salem Democracy's jolly-time over the election of Cleveland and Stephenson. At seven o'clock the masses began to assemble, and soon the streets were thronged. Promptly at the hour of march the torch bearers and bands began to move off from in front of Hotel Willamette. The bonfires blazed up, the rockets ascended, the Roman candles and colored lights flamed, the mortars boomed and the horns blew—a million noises great and small rent the air as Democracy began its march of victory through the capital city. There were horns of all sizes. Baby horns, long horns, Texas horns, fog horns, and one horn that to the distorted vision of Republicans seemed forty feet long and it gave forth sounds like Gabriel's trumpet will utter to the countless sinners that will awaken on the morning of resurrection day. It was a horrid time and one Democrat is reported to have blown in two hundred dollars on tin horns. The residences and stores of Democrats were pretty generally illuminated and TWO HUNDRED TRANSPARENCIES were in line. "Grandpa's Hat" on a large scale, "McKinley's Coffin" and other not new but well executed designs were borne by enthusiastic Democrats. All sorts of appropriate sentiments and designs were inscribed on the banner. Cleveland's well-known physiognomy was reproduced several times and not around of cheers. Ben Harrison was also the recipient of a grand applause from the Republicans on the sidewalks.

THE SALT RIVER BOAT was rigged up as an immense float, nearly forty feet long, and lettered with the compliments of the season. The following mottoes and suggestive emblems were painted on its sides and held aloft on banners by its guard of honor: "The old steamer Republican will for the second time in 30 years sail up Salt river, under the charge of the most magnetic captain of the age, Benjamin Harrison, First Mate, Whitelaw Reid; Steward in charge of spouses, Ben Butler; Barkeeper, L. P. Morton, Chambermaid, Mrs. Leese. Excursion organized Nov. 8th, 1892. Will sail March 4th, 1893. Music—Long Jones' band, to the air, 'Who will fill my Office now?' No stopover." The name of a prominent Salem Republican was given as local agent of the Salt River line and all who wished to sail up that disagreeable stream could call on him.

THE PROCESSION which was all huddled together about ten abreast at the start, got itself tangled out straight after marching a few blocks and extended for near a half mile in length, and it is estimated two thousand participated. The torch bearers, the tin horn brigade, the broom battalion and carriages were all well handled.

John Savage, Sr., was one of the conspicuously happy Democrats in line and wore a white hat. He was captain of the clean sweep brigade and wore a cockade consisting of a bantam rooster not larger than a hen canary, but with tail feathers flying and all his Democratic blood up. They do say that inside his hat Uncle John wears well executed lithographs of Harrison and Morton and that his hat has done duty four years ago.

The electric car lines did a big business all the evening, carrying from fifty to a hundred passengers at a clip, and often as many more could not get on. In all the occasion was a memorable one. At a

late hour the procession got around to the opera house and in all enjoyed themselves very much. One of the most significant banners bore the legend: "The East did it for Us!" which was strictly true. The Democrats did well in Salem last night in celebrating a victory won outside of Oregon.

After the parade all who could get in gathered at the opera house, where a programme was enacted. Mayor D'Arcy was elected chairman and president. Short speeches were made by Judge W. W. Page, of Portland; Judge J. J. Daly, of Dallas; Judge Wm. Galloway, of McMinnville; Judge B. F. Bonham, Dr. W. D. Jeffries, Hon. W. H. Holmes, Col. E. H. Flagg, Hon. Napoleon Davis and Leo Willis, Esq. Four years hence if Democratic policies are carried out, Republicans have the satisfaction of knowing that it will be their turn to paint the town red by blowing horns, burning powder and tramping the mud, while their Democratic friends will stand on the sidewalks and see them go by.

A LIFE OF COLUMBUS has been prepared by C. K. Adams, the president of Cornell university, for the "Makers of America" series, Dodd, Mead & Co., New York, publishers. The Little portrait of Columbus forms the frontispiece. The work is up to this writer's standard of earnest painstaking literary style, though there are infidelities of expression unbecoming to even a student's handbook of history.

There is a weakness imparted to the whole work whenever the author undertakes to emphasize facts, which if directly stated would impress the reader with all the importance that attaches to them. There is too much of this. The facts are not stated simply and left to tell the story but an effort is constantly being made to embellish them with language and surround them with conjecture, that obscures the information that should be conveyed in a more direct manner. It may be understood but it is not in good taste to say of Columbus that "he moved to Lisbon before 1478." When we say a family has "moved" we employ a colloquial expression that is out of place in a piece of literary work intended to be of a permanent character. To speak of the classics as "lying dormant" and then springing suddenly into life is an employment of an animated metaphor to the inanimate. The continuous employment of the editorial "we" is unbecoming and should be avoided. It implies a degree of judicial egotism not any longer allowable in the journalistic profession and certainly does not attach to the license of the historian. These are mere criticisms, of defects, but they mar the enjoyment of a subject dear to the hearts of all Americans and already embodied in the richest literary income and spices of writers like Irving and scores of others of the highest class. The letterpress and binding are very tasteful.

A STORY OF MR. BECKFORD.
