

THE WIZARD OF WALL STREET.

Compelled to Close His Final Accounts.

HIS NEXT DEAL NOT ON WALL STREET

But in the Great Clearing of the Unknown.

JAY GOULD DEAD.

Millions of Stock Affected by His Demise.

NEW YORK, Dec. 2.—Jay Gould died at 9:15 this morning. The direct cause of Mr. Gould's death, as stated at the house this morning, was pulmonary consumption. All the members of his family were present when the end came. The fact of his death was known before the opening of the Stock Exchange the effect on the market has been less marked than was expected. Missouri Pacific stocks declined only 1 1/2 to 54. Western Union only 1/2 to 85. Manhattan was elevated 1/2 to 128. Union Pacific 1/2 to 85 1/2. These were known particularly as Jay Gould properties to which he paid special attention.

NEW YORK, Dec. 2.—It has been determined that Jay Gould is suffering from consumption, and he is doubtless now in his last illness. Last winter he went to a more genial climate, and it was hoped until recently that he might be able this winter to get away from New York to some locality where the atmosphere is more bland than here. The development of his trouble has, however, prevented his contemplated removal, and Gould now lies at his Fifth avenue home in this city, growing weaker daily. His entire family are within reach of a hurried summons, and personal medical attendants in close attendance. The health of the great financier has many times, in years gone by, been subject to sensational and designing rumors. This writing, however, deals with no rumors, nor is it designed to arouse sensation. Gould is low with consumption. His life may be prolonged for some days, but his days are well numbered, and the limit of his living may be said now to be narrowed almost to hours.

GOULD UNCONSCIOUS.

NEW YORK, Dec. 2.—At midnight it was stated that Gould was unconscious. An hour later he was still in the same state.

WHAT A DIRECTOR SAYS.

J. T. Terry, one of the directors in several of the Gould properties, says Gould told him he had disposed of his holdings in Manhattan, Western Union and Missouri Pacific, three stocks in which he was especially interested, by putting them in trust so they could not be sold. It is believed that he has had his financial house in order for a long time. Prominent bankers believe his death will not have much effect on the market either way.

IN LONDON.

LONDON, Dec. 2.—The death of Jay Gould has had no marked effect on stocks here. The Union Pacific's decline fractionally but immediately recovered.

THE FUNERAL.

NEW YORK, Dec. 2.—The funeral will take place Monday, the hour is not yet fixed and will be held at the house. It will be conducted by Dr. Paxton, assisted by Chancellor McCracken, of University of New York, and Rev. Roderick Terry.

German Parliament.

BERLIN, Dec. 2.—During the debate on the budget, Dr. Buhl, the leader of the national liberals, said his party would vote for the demands of the government for money for military purposes so far as compatible with vital interests, but the army bill to its full extent was impracticable. In the course of his speech, Dr. Buhl complained of the inadequate share Germany had taken in the 400th anniversary of the discovery of America. Chancellor von Caprivi said Germany was worthily represented at the Columbus fete at Genoa and Spain. Herr Liebknecht, the socialist leader, in a speech urged that the militia system be established in Germany, and that the political morality be improved.

An Ohio Beast.

COLUMBUS, Dec. 2.—Jud Holland, a colored ex-convict, has been arrested here for killing a dozen fine cows within the past week. The killing was done with a knife, the animals being slashed in a most brutal, bestial way, somewhat after the manner of "Jack the Ripper."

CHIEF JUSTICE MAY RESIGN.

Additional Statistic from the Postal Service.

WASHINGTON, Dec. 2.—Reports were current some time ago to the effect that in the event of Mr. Cleveland's election a good-sized plum would be placed at his disposal for bestowal on some worthy partisan, by the resignation from the supreme bench of Chief Justice Fuller, and now that the election is over, the rumor is again gaining currency. They are based on the story that the chief justice finds his position something of an irksome one, and that the salary attached to it is not at all in proportion to his earning capability in the ordinary practice of his profession. From the fact, however, that the Fuller residence is now being entirely overhauled preparatory to being put in elegant condition for next year, it is not thought that the rumor has any substantial foundation, or that, if it had, the chief justice has changed his mind. So far as the financial end is concerned, it is not thought this will cut any figure, as the chief justice is fairly well fixed in this world's goods, and is, moreover, just now engaged in some real estate operations in Chicago that are likely to bring him large returns.

Mail Facts.

WASHINGTON, Dec. 2.—The annual report of Second Assistant Postmaster-General Bell for the year ending June 30, shows the total cost of the inland mail service was \$41,355,372; foreign mail service, \$806,145. Compared with last year there was an increase in the star service of 1215 routes, 5877 miles in length of route and \$196,061 in actual expenditure. The mail messenger service showed an increase of 204 routes, 5058 miles in length, and \$177,461 in cost. The railway postoffice clerks were increased 385 and \$411,610 in expenditure. Special facilities on trunk lines showed a decrease of \$93,807.

Cleveland's Appointments.

TACOMA, Wn., Dec. 2.—Hugh Wallace, National Democratic committee man for Washington who returned home from New York, denies that he is to be given a place in Cleveland's Cabinet, but says the Pacific coast will undoubtedly get one place in the cabinet. Mr. Wallace thinks it will be at least six months before Cleveland takes up federal appointments for Washington and Oregon.

Canadian Pacific Mail.

HALIFAX, N. S., Dec. 2.—The first English mail from China and Japan, via Vancouver, B. C., arrived here, and will be dispatched by the steamship Labrador Saturday. The first mail from England for China and Japan is expected by the steamer due Saturday, and will be dispatched Monday to make connection with the steamer leaving Vancouver December 12th.

Prohibition in the South.

COLUMBIA, S. C., Dec. 2.—The special house committee on prohibition bills reported favorably on that drafted by the prohibition state chairman. Matters are becoming decidedly warm on the prohibition question, and there is every prospect of a severe struggle.

To be Guarded.

TACOMA, Dec. 2.—Because of the recent attempts at train robbery on the Pacific coast division, the Northern Pacific company has stationed armed sentinels and detectives along the road to protect its property and passengers in case of attempted robberies. All suspicious characters are being shadowed.

Running on Time.

SAN FRANCISCO, Dec. 2.—Reports received at railroad headquarters yesterday morning indicate that trains are running on time. There are a few minor washouts on the Northern division, and one between Pleasanton and Livermore, which is not serious. It is raining south of Dunsmuir, and storming above that point. The weather is reported to have cleared in the Sierra Nevadas.

Murderer Indicted.

TAUNTON, Mass., Dec. 2.—Lizzie Borden has been indicted on three counts, on charge of murdering her father and mother, a wealthy prominent old couple at Fall River.

No French Cabinet.

PARIS, Dec. 2.—Brissan has abandoned his attempt to form a new ministry and the situation is more muddled than ever.

Bold Cracksmen.

CHICAGO, Dec. 2.—Six safes in one big office building, near police headquarters were blown open and robbed last night. No clue to perpetrators. It is thought not more than \$500 was secured.

WARRING ON SOCIAL EVILS.

The Mayor of Pittsburgh Addresses a Motley Assemblage.

PITTSBURGH, Dec. 2.—Never before in the history of Pittsburgh was such a scene witnessed as in the city hall yesterday. At least 150 women, inmates of disorderly houses, who were ordered to leave the city by tomorrow afternoon, gathered in the mayor's office. Mayor Gourley made a speech, in which he said, in part: "I am sorry for you women. I did not close you up for thirty-two months of my term for the reason I did not think it would help this evil. When ministers of the city, wives, mothers, sisters and brothers came to me, to insist on the law being lived up to, I had to issue the order. I take all the responsibility, and do not know what you can do. I have nothing to offer you. I think Mr. Brown's orders are too heavy. I do not believe in hurrying you out into the streets like dogs." "Some of these women live away from here. They have no money and no friends, and what are they to do?" "That I don't know," said the mayor, "but I will try and see what the ministers will do, and let you know by tomorrow afternoon." The women went down the street in a body, attracting a great deal of attention. The ministers of the city propose at once to take care of the women. The care of "the fallen" will be the sole subject of the discussion next Sunday, and active measures will be taken to provide homes for those who will lead moral lives. Hundreds of women left today for other cities.

CALL UPON A MINISTER.

Thursday evening twelve or fifteen colored prostitutes called at the residence of Rev. Dr. McCrary, of Third United Presbyterian church, and asked for protection. He had been a leader in the movement against the social evil and prominent in the Sunday closing crusade. He told the women he could do nothing for them. While he was talking a large crowd gathered about the house and indulged in catcalls. The women then began to sing, "Nearer My God to Thee," but the sound of an approaching patrol wagon caused the crowd to disperse.

ROTHSCHILD'S SCHEME.

The Way Clear for the American Plan.

BRUSSELS, Dec. 2.—The scheme for the solution of monetary problem, submitted to the international monetary conference by Rothschild, was rejected by the committee to which it was referred on votes of delegates from France, Italy, Belgium, Norway, Sweden and Russia. The first objection was made to the plan from delegates of nations belonging to the latin union. They disapproved the proposal that 43 pence be fixed as maximum purchase price of silver. This figure was consequently withdrawn in favor of a higher one, but this concession failed to reconcile them to the position. The vote stood 7 to 6. The American delegates regard the position cheerfully. The way is now cleared for a full discussion of their bimetallic plans, in accordance with their original program. After submission of report of committee, the Americans announced that they are not ready to discuss it. Adjourned till Tuesday.

Jumped the Track.

TACOMA, Dec. 2.—An electric car jumped the track while going down a steep grade at Tacoma yesterday, throwing several passengers to the ground, among them Captain James O'Brien, formerly of the whaleback steamer Wetmore, who had his left shoulder blade broken, beside receiving internal injuries. He was taken to the hospital, and later removed to the Sisters' hospital. Capt. O'Brien's experience on board the whaleback Wetmore, coupled with this and several on the sound, make the chapter of his accidents quite lengthy.

Released.

ELLENBURG, Wash., Dec. 2.—Zachery and Humphrey, the two men arrested on Colville reservation last Monday on suspicion of being two of the Roslyn bank robbers, had an examination here. None of the witnesses were able to identify them, though Zachery admitted that he was between Oregon and Colville with a band of horses at the time of the robbery. Both men returned to Colville on this evening's train.

Suicide.

NEW YORK, Dec. 2.—J. Ross Faulkner, a student at Bellevue Medical college, and son of Senator Faulkner, committed suicide by poison this morning.

CRIMINAL NEWS.

The Streater Boy Cannot Fight—Outlaws Surrender.

MERIDIAN, Miss., Dec. 2.—The noted Kemper county outlaws, Tom and Walter Tolbert, for whom a posse has been searching for a month, have been finally captured. Tom was discovered in Neshoba county yesterday, and was wounded in a half a dozen places, but managed to escape. Later realizing the necessity of attention for his wounds, he surrendered with his younger brother Walter. Tom will be sent to the Jackson penitentiary to serve out a life sentence. Walter will be taken to Kemper county to stand trial for the murder of Tom Cole.

Shot By a Burglar.

OAKLAND, Dec. 2.—Frederick Gartner was shot by a burglar yesterday. He was awakened by a noise, and went out with a gun. The burglar retreated till he got in a corner between two buildings, and then fired his revolver. The bullet struck Gartner in the jaw. Gartner replied with two barrels of his gun, and it is thought, wounded the burglar, who bolted over a fence and escaped. Gartner's wound is serious.

In No Condition.

CHICAGO, Dec. 2.—The 10-round match between Jack McAuliffe and Billy Meyer, which was to have taken place at the Second Regiment armory on Saturday of next week, is likely to be declared off today, owing to the "Streater Boy's" condition. He has never recovered from the punishment he received at the hands of McAuliffe at New Orleans, and of late especially his health has been very poor. Recently he was compelled to undergo an operation on his left eye, and until within a few days it was thought that his sight might be entirely lost. Slugging was to have been prohibited in the forthcoming match, but the "Streater Boy" is no shape even for a friendly bout.

INDIAN CURRENCY COM.

The Gold Bugs' Demands in the East.

LONDON, Dec. 2.—The Indian currency commission will resume its sittings early in January, whether the monetary conference has or has not by that time been brought to a close. Members of the commission are certain to have by January some definite idea of what the issues of the Brussels meeting are to be and how they may affect currency in India. The Associated Press has already reported that the Indian commission has had under consideration. The proposal is to declare a gold standard for India. There is no doubt as to the fact that certain strong adherents of the single standard tried to snatch the vote from the commission in favor of a gold standard for India. Some members who were fully cognizant of the momentous consequences of such a decision yet adhere to it, desiring that the English delegates should be armed with it when going to Brussels as a weapon of defense or offense against the bimetallicists. These tactics of "bluff and bounce" were not approved by the majority of the commission, who justly thought the Brussels delegation would accurately gauge the sham decision or reported recommendation. Ultimately the commission would recommend whatever the government, will suggest the temporary suspension of silver coinage if the viceroy's council should decide that to be advisable. The commission has been taking evidence in camera from the Anglo-Indian bankers, manufacturers and tea-planters. Most of them favor doing nothing, allowing business and currency values to find a level under the existing laws, and of those who spoke of the evil arising from the unlimited coinage of silver in India the principal ones simply advocated that the government of India shall have power to suspend at its discretion the coinage of silver.

Governor Flower Indicted.

LONG ISLAND, Dec. 2.—It is announced that Governor Flower and his sister, Mrs. Schley, and the administrators of Union college and Grapely estates, are indicted by the grand jury for maintaining nuisances. The governor and others own large blocks of property, principally swamp land and cess pools.

Strange Result.

GUTHRIE, O. T., Dec. 2.—The official count of the vote in Oklahoma shows both houses of the legislature a tie politically.

PACIFIC STEAMSHIP NEWS.

A Vessel Held at Tacoma—New Mail Line.

TACOMA, Dec. 2.—The Northern Pacific steamer Victoria arrived from Japan and China, but was not permitted to land her cargo or passengers. Deputy Collector Berry refused to enter the vessel without the certificate of United States Quarantine officer Conover, who lives at Port Townsend. Collector Wasson arrived at 6 p. m. on the City of Seattle, and sustained Berry's ruling, even refusing to permit the landing of the United States mails, of which the vessel carried eleven sacks. The Victoria put into Port Townsend at 10 p. m. Thursday, and remained nine hours waiting for the health officer, but none came. It is claimed that the weather was too rough to permit it. The steamer then came on here, leaving Port Townsend at 7 a. m. The quarantine officer has been telegraphed for, and is expected here early Friday morning. The Victoria has 2,000 tons of cargo for this port, including 600 bales of silk for New York, said to arrive, and time is very important. It is claimed by the officers of the ship that three previous vessels of the line did not stop at Port Townsend, and no objection was made, and also that the ship has a clean bill of health from Victoria, her last port. The ship has eight cabin and twenty-nine steerage passengers.

The Briggs Case.

NEW YORK, Dec. 2.—In the Briggs case yesterday, after a long argument, the question of voting on the items separately was put and carried. Moderator Bliss called upon the defendant to plead guilty or not guilty. Briggs insisted, before answering, that all evidence against him be read. The moderator ruled, however, he must plead at once. "I am not guilty," answered Mr. Briggs. Colonel McCook then formally opened the case against Dr. Briggs. He offered in evidence the scriptures, the standards of the Presbyterian church, Dr. Briggs' books, etc. Then the defendant set a trap for McCook, into which he stepped with haste. "You offer the holy scriptures," said Briggs, but to which version do you refer? "King James' version," innocently replied the Colonel. "Then your evidence is unlawful, for the Presbyterian standard of authority is not the translation of King James, but the original version," retorted Dr. Briggs. A titter followed this sally, which Mr. Robinson augmented by exclaiming, "We are making ourselves the laughing stock of the galleries." Colonel McCook yielded to Dr. Briggs any advantage which might accrue to him in consequence of the discrepancies between the two versions. It was then decided Dr. Bliss should next submit the evidence, and an adjournment was taken until Monday.

SANSALVADOR EARTHQUAKE Part of an Island Splits Off, Sinks out of Sight. SAN FRANCISCO, Dec. 2.—The steamer city of Panama brings news of an earthquake in San Salvador October 18. Signs of activity were noticed about the crater of Conchagua volcano, near La Union in gulf of Fonseca. At 10 o'clock that night came a violent earthquake and five thousand inhabitants of La Union fled to the beach. Shock after shock struck the city and all old buildings are tumbled in ruins. The great stone cathedral is reduced to a formless heap. Fifty or sixty other buildings are completely wrecked. Twenty-four persons were injured. One third of the island of Conchagua in the gulf of Fonseca, seven miles from La Union, split off by the shock and suddenly sank out of sight.
