CARTER STILL IN BONDS.

Habeas Corpus Proceedings Before Judge Hubbard—Held by Judge Edes.

When a criminal gets into the hands of Salem's Chief of Police Harry Minto, he seldom gets out unless he proves his innocence. That seems to be the fate of R. C. Carter, alias Rose. Recorder Edes committed him to jail for ten days to await arrival of a sheriff from Missouri to take him in custody.

BEFORE HUBBARD
The demurrer of defence was argued to a late hour Saturday night by Messrs. Sears and Ford for Carter and Messrs. D'Arcy and Bingham for state. The court overruled demurrer, remanded Carter to keeping of Sheriff Knight and continued the hearing upon the writ to 1 p. m. today. The chances seem to be against Mr. Carter securing his liberty.

did not arrive this morning as expected. He telegraphed that he would start Thursday or Friday and as he is a new man in office, taking this case one day after being sworn in, he has not kept the officers here posted as to his whereabouts.

The battle for time to allow the sheriff to get here was again taken up before Judge Hubbard. Defense had not their return to the writ ready, and the case was continued to 9 a. m. Tuesday.

THE NEW CHARTER

Proposed Amendments Prepared and Ready for Action.
City Attorney Bingham has completed the revision of the Salem city charter. A new instrument has been prepared throughout and will be submitted to the informal meeting of the city council tonight. The amendments incorporated are virtually agreed upon by all parties interested and there will be little or no opposition.

THE AMENDMENTS
proposed are intended to guard the interests of all in matter of street and sewer improvements and yet deal fairly with the demands of progress and needs of a growing city. The office of the city assessor is created, limiting his time to 60 days at \$2.50 a day. The business of a recorder's office has grown so that that official has really not the time to make the assessment and for several years the work has been done by another and paid for by the city. The city boundaries are not changed but are left as they now are. One important reform is the requirement that all claims against the city must be itemized and verified under oath before the recorder, without expense to the claimant.

THE FIFTEEN YEAR PLAN
of making street and sewer improvements is adopted. For the first ten years only interest is to be paid at 6 per cent. annually on the improvement made, assessed to the property improved and interest paid with taxes. At the end of ten years the improvement is to be paid for in five annual payments. No improvement can be made without advertising what the proposed improvement is to be, and ten days is allowed after that to file a remonstrance, objection on part of two thirds of property owners defeating the improvement and it cannot be taken up again for six months thereafter. These are all the principal changes proposed.
