**FOR STARVING AND BEATING.**  
**A Horse, Father and Son are Sent to the County Jail.**

A case of cruelty to animals has been successfully prosecuted by Deputy District Attorney Condit of this city for which George Zwicker and his son George, a young man, were today incarcerated in the county jail.

Several days since Zwicker bought an old house on Court street and began hauling it away with a poor old horse hitched to a big single wagon. The animal was then overloaded and beaten so that complaints were made to the city recorder and the Salem police. The abuse of the animal continued after they got it home, the animal being beaten by the boy after it laid down and could not get up for which the boy was fined \$20 and costs.

On the trial it appeared that the owner had not sufficiently fed the horse, buying only one sack of oats all winter, and he was fined \$20 and costs, both going to jail for ten days.

Deputy Sheriff Cooper made the arrests yesterday, and there are liable to be other arrests in this vicinity for inhuman treatment of animals.

#### FIRE TRAPS IN CHICAGO.

World's Fair Visitors Warred Against Them.

#### BUILDINGS THAT LIE DOWN OVER NIGHT.

Falling Like the Leaves in Autumn at Valambrosa.

Dr. Richard Cartwright of Salem, who has been spending several months at Chicago hearing lectures, and who has undoubtedly been a visitor at the world's fair grounds, sends the JOURNAL the following letter, received yesterday, which will prove of great interest to all intending to visit the world's fair:

#### DR. CARTWRIGHT'S LETTER.

I send you a marked copy of an evening paper, which I think you would be doing your readers a great good by publishing some extracts from. Tell the people not to go to those new hotels near the world's fair grounds. They are advertised as being brick buildings but are only light frame structures, with a very light layer of brick around them. One caught fire this week and in fifteen minutes from the time the fire was discovered was entirely gutted, and that with no furniture in it. Had several would have gone with the building. Escape is absolutely impossible. I do not think there will be much trouble in finding rooms in other parts of the city, and even though it may be troublesome in getting to the grounds, it will pay in the end. But what I wish particularly to say is, don't go to those new temporary structures.

#### THE FIRETRAP HOTELS.

We copy from the article referred to in the Chicago Evening Post of April 7th:  
The Plymouth Hotel, at Seventy-second street and Stony Island avenue, collapsed last night. The building was one of the largest in that district and was almost completed. In its fall it crushed a one-story structure which was to be used for restaurant purposes and would have been ready for occupancy in a few days.

Both buildings were owned by William Searls, of Plymouth, Ind., and were valued at \$25,000. The slight wind that blew at midnight was the cause of the accident, the construction being too frail to resist the pressure of wind and rain. Today a pile of debris marked the site of these proposed world's fair buildings and the whole is a total wreck.

#### FLIMSY STRUCTURE.

The hotel was one of those light honey-comb structures that have sprung during the winter months. It was a three-story frame building containing a hundred and sixty-five rooms, offices and parlors.

The workmen had just put the roof on the place and it was expected the shell would be opened about May 1st.

This is the second of these hotels that has fallen within the last forty-eight hours, one at Sixty-first street and Stony Island avenue collapsing yesterday.

In both cases loss of life was narrowly averted.

The watchman, D. Bohlenhurst, of the Plymouth, had just left the building last night when it fell without a moment's warning. To use the watchman's words, "it just came down."

It is said the two hotel buildings that have just fallen are not the only dangerous structures in that district. Severe winds are predicted for this locality and the condition of many of the frail buildings in the world's fair district has occasioned much alarm.

The falling of the Plymouth and the Clarkdale simply indicates the utter failure of the building department to supervise this work and it is feared more serious disasters will occur when many of these temporary hotels are put to use.

Building Commissioner O'Neill says he is fully aware of the condition of many of the structures in the vicinity of the world's fair.

**A Fireproof Electric Wire.**  
A wire is being introduced which possesses such fire resisting qualities that the most extreme fire tests to which it has been subjected have failed to produce any visible effects upon it. At a recent demonstration several sample boards were prepared, each having arranged upon it samples of various well known electrical wires, one sample upon each board being the new wire. All the samples had the same sized conductor and were carefully wired together into a circuit, so as to allow of their being tested in comparison and under the same conditions.

These sample boards represented 16 leading makes of insulated wires, several of them being claimed by their makers to be fireproof. A powerful electric current was then applied and maintained until the conductor was first brought to a red heat, then a white heat and in some cases melted. Under this intense heat every one of the samples except the new wire was entirely destroyed, in several instances setting fire to the board, but in no case did sufficient heat escape through the new wire to discolor the board beneath it.—New York Telegram.
