

MITCHELL AND BOURNE.

In the opinion of a large number of people the time had arrived when it was proper to hold up the Oregon legislature. A repetition of the style of proceedings for several years—unlimited clerkships, endless jinkets and stam investigations, packed appropriation bills, boodle legislation for new offices and commissions, \$1000 to merely revise a house journal,—had to be put a stop to. The people's interest required this. It has been held up if at all, in the interest of a new deal and better methods. It took sand to hold it up. Mr. Bourne has not been deficient in that quality.

Mr. Mitchell's methods of holding up the legislature were just opposite of this. His leaders were the old regime, some of the salient features of which are above referred to. His leaders have offered some reform measures and made some demonstrations of retrenchment. But his selection of Senator Brownell, who has been the chief instrument of jobbery and extravagance in the senate so far as his leader shows that a Mitchell organization of the legislature would have been fatal to all retrenchment and reforms. The record of the Mitchell leaders in the senate proves this.

Mitchell cannot understand men like Bourne. A Republican leader compares Mitchell to Napoleon in this respect. The latter lamented that he had found out the high qualities of General Moresco too late. It seems probable that Senator Mitchell will have to lament, in a similar manner, that he discovered Mr. Bourne's qualities too late. Mitchell may be a good judge of barnacles, but he never could comprehend a man incapable of falsehood or treachery. That is the difference between him and a man like Bourne. Bourne works with men of his own type. So does Mitchell. Men must be judged by their associates.

JOHN SMITH FOR SENATOR.

As Senator Mitchell has defeated his ambition to succeed himself, THE JOURNAL proposes that a plain John Smith be elected to represent the people of Oregon. It is not necessary that we send to Washington a special representative of the banks or the corporations or the gold mines or silver mines, or any other trust or combination.

John Smith is one of the plain common people. He does not believe in repudiating debts contracted on a bimetallic basis and making them payable in gold. He does not believe in repudiating debts contracted payable in coin and paying them in irredeemable paper.

Our John Smith is not a contractionist or a repudiator, but a man who believes in honest payment of honestly contracted debts according to the terms of the contract. He is not a bourbon democrat nor a red-flag anarchist, nor a boodle politician of any kind. He will simply go to Washington if he can be elected without the use of money, and sleep in a dry goods box if he cannot afford a better bedroom, at the salary and mileage an Oregon senator gets.

He will use no railroad passes, or deadhead his way in any other manner, and while he will insist on equal rights to all and special privileges to none (including manufacturers, corporations, and persons of his own sex,) he will insist that all obey the laws of our country.

He will enter no secret caucuses, societies or combinations to accomplish results in public affairs. In short John Smith is a plain, independent, American citizen.

Any police officer in Oregon City, hereafter caught in a saloon theater or other place of amusement, good or bad, except in the performance of his duty or for drinking any kind of intoxicating liquor or engage in any game in any public house. No police officer shall solicit or receive pay from private parties of engage in any business, on penalty of being immediately fired out of the force.

WOMEN AND MORALS.

Woman suffrage has met with a defeat in Oklahoma, which is distinctly honorable to its leaders. A bill to extend the franchise to women was beaten in the territorial legislature a few days ago chiefly because of a widespread belief that the women, if they got the ballot, would immediately wipe out the infamous divorce laws which now disgrace the territory. Could there be a higher tribute to the moral influence of woman's work in politics than this proceeding virtually implies? It is practically a confession of fear that woman, if she were permitted to vote, would labor for morality, for social reform and for laws that would make Oklahoma a fit place of residence for respectable families. The leaders of the suffrage can well afford to stand squarely on the record they have made in the territory. Their defeat is one that presents a distinguished testimony to the integrity and vigor of their cause.

STATE NEWS.

Spokane has a mining corporation composed entirely of the gentler sex known as the Women's Northwest Mining and Investment Company.

Henry Hagood of Dallas died Wednesday of a gripe, at the age of 82 years. He came to Oregon in 1852, and settled in Polk county, where he lived until his death, a highly respected and well-to-do citizen.

Russel Jones, of The Dalls was sentenced to serve out a fine of \$25, for killing deer out of season, and a Chinese, Sing Chang, to serve 30 days for the larceny of an umbrella.

The warehouse of Oregon Central & Eastern Railway, in Lyons Linn county, was broken into a few nights ago and a quantity of merchandise, amounting to about \$75, being the property of Gibson Myers, was taken.

John Williams and Jim Waters, two Indians, while fishing for sturgeon in the Columbia river, at the Narrows, three miles above The Dalles where the current is very swift, were drowned. The boat was upset and drowned the men while a 9 year old boy made his way to the shore by the aid of the oars.

The Newburg Pressed Brick Company is laying a track from the Southern Pacific a mile south to the brickyards. White clay will be shipped from near Willamina, to be mixed with a red clay here, for making a chocolate-colored brick. The same clay is used for making a white brick.

Robert C. Percival, of Monmouth died. He was born in Old Franklin Howard county, Mo., February 9, 1822 and in six more days would have been 75 years of age. He went to California in 1849 and came to Oregon in 1854. He was an old and respected citizen of Polk county, having lived here 30 or more years.

State Superintendent Irwin has reversed the decision of County Superintendent Waite, in the Civil Bend, Douglas county, school district case, setting aside Waite's division of the district. In his decision the superintendent holds that a legal voter in a school district means both the father and mother of children as well as taxpayers, and that the Civil Bend district therefore contains 58 legal voters.

E. P. Thorp, editor of the Cottage Grove Leader, died suddenly Wednesday morning. Mr. Thorp had not been well for some time, and remarked to a friend on the way home last evening that he did not know whether he would live to get home or not. He expired while walking from his home to his office, which is about one-half a mile from his home. He was found on the sidewalk by some small children.

A called meeting of the Yamhill County Horticultural Society was held at Newburg, at which a number of the leading fruitgrowers of the county were present. Articles of incorporation were adopted for the formation of a co-operative association. The plan contemplates a joint stock company, each member to hold one share of stock of a par value of \$10. The business management is delegated to three members, to be chosen by nine directors.

SENATORS

From Three Western States.

The Plain Platform of Hon. George Turner.

George Turner of Spokane, elected to succeed Watson C. Squire as senator for Washington, is a silver Republican. He received the caucus nomination of the fusion majority and polled sixty-eight votes on the joint ballot—eleven more than enough to elect.

In his speech of acceptance Senator-elect Turner said: "I accept the office of senator from the state of Washington as a member of the fusion organization, known as the People's party, which was formed in 1896, and is composed of silver Republicans, Democrats and Populists. As a member of this party, and its representative, I accept the honor and trust conferred upon me."

"My course in the senate shall be in advocacy of the principles of the People's party as I understand them, and as represented by these three elements. I favor the free and unlimited coinage of silver, government ownership of railroads and other lines of transportation, and the issuance by the government, exclusively, of the paper money which the needs of the people require."

In an interview Senator-elect Turner said that he would not act with the Republicans in the organization of the senate.

George Turner was born in Edina, Knox county, Mo., in 1850. He received his education in the common schools. In 1876 President Grant appointed him marshal for Alabama, which office he held for four years. From 1880 to 1884 he practiced law in Montgomery, and on July 4, 1884, President Arthur appointed him associate justice of the Territorial supreme court of Washington. He resigned in 1888 and has practiced law and engaged in mining in Spokane ever since.

It is a fact that a number of the Republicans in the legislature desired to vote for a Populist for senator, to defeat Turner, but were held back by a protesting minority of their number. They were offered in turn Cline, Daniels and Winsor, each with from 42 to 44 votes, but they hesitated till opportunity was gone. The move was in the interest of Senator Wilson, who hopes for re-election two years hence, and did not want a Spokane man chosen now.

UTAH'S SENATOR-ELECT. Joseph L. Rawlins, of Salt Lake City, was born in Salt Lake county, Utah, March 28, 1850; lived upon a farm until 18 years of age; completed a classical course in the university of Indiana, but having gone to Utah, did not return for graduation; was professor in the university of Deseret, in Salt Lake City, Utah, for two years, until 1875; was admitted to the bar in that year and followed the profession of law until his election as delegate in 1892; in politics has always been a democrat; was elected to the 53d congress as delegate, on the democratic ticket, Rawlins was defeated by Cannon in turn, however, for the 54th congress, in 1894, Rawlins has always been identified with the democratic party of Utah, and is an advocate of the free coinage of silver. He was a delegate to the last democratic national convention, and was a member of the committee on resolutions. He is a member of the law firm of Rawlins and Critchlow, in Salt Lake City.

IDAHO'S SENATOR-ELECT. Henry Helffeld, senator-elect from Idaho, was born at St. Louis, Mo., January 12, 1859. At the age of 13, in 1873, with his father's family, he removed to Nemehaw county, Kansas, and engaged in farming. He was educated in the public schools of Missouri and Kansas. In 1880 he removed to Pomeroy, Wash., and was employed one year at that place in a flouring mill; then he went to Sprague, Wash., and worked in the car shops. Fourteen years ago he purchased a farm in Nez Perces county, Idaho, 12 miles from Lewiston, on the Rimrock, where he has since resided, and to which he has added until he owns a section of the county and one of the finest orchards in that section. Twelve years ago he was married to Miss Annie Jacobs, of Uniontown, Wash., and the issue of this marriage

is six children, five of whom are living. Two years ago Mr. Helffeld was elected by the Democrats and Populists of Nez Perces and Latah counties to the state senate. Last year he was re-elected to the same office by the People's Democratic party of Nez Perces county.

FOUR PROSPERITY ITEMS. (From the Chester Illinois Herald.) Prosperity is coming to those who get a political plum. It looks as though the democratic "county savers" who bolted the Chicago ticket, will not be overburdened with appointments.
