

IS FLAX EXHAUSTIVE?

Is flax the exhaustive crop some would have us believe?

We have put this question to Dr. Thornton and he answers positively: "No it is not!" It has been demonstrated by careful scientific investigation conducted at the Minnesota Agricultural Experiment station, for several years that flax is not the exhaustive crop generally supposed. (In Minn. Expt. Station Bulletin No. 13 and 40.)

In Holland and Belgium where the farmers are thorough in all the details of agricultural work—and in fact in every thing else they take in hand—if the farmer is short of fertilizers he will plow his land 10 inches deep, harrow and cross-harrow, and work until he gets the ground clean and in fine tilth, as if for sowing onions and will sow flax he will be sure of a good crop, and after the flax is removed sow fall wheat and harvest 45 to 60 bushels without one atom of fertilizers! Now if flax was the exhaustive crop it is ignorantly supposed to be would such a result be obtained?

What then has given flax this bad name? It is because two crops of flax cannot be produced successfully in succession—Why? Because the debris, or waste from one crop of flax remaining on the land is poisonous to the succeeding crop of flax until it has had time to be decomposed though not to other vegetation. Consequently a longer or shorter interval between two crops of flax on the same land is found to be necessary.

It has been demonstrated by the above mentioned experiments that flax does not remove from the land more fertilizing material than a fair crop of wheat, oats, barley, potatoes, corn or beets, and one crop of clover turned under will replace more nitrogen than is removed by two crops of flax! Is that a sign of exhaustiveness of the flax crop? But—and mark that but—if flax is sown thinly on foul land giving encouragement to the weeds—the weeds are the true robbers and remove more fertility than the flax.

While corn and beets or mangels are gross feeders and can appropriate their food from coarse mineral ingredients, flax is a dainty lady and requires its food prepared by nature's skillful cookery.

Again while wheat, oats and the other grain crops have a root system consisting of thousands or fine fibrous roots penetrating to the soil near the surface. Flax has a single tap root with very few fibrous feeders which goes down to the deeper strata and receive its nourishment therefrom.

We will receive a description of the Minnesota experiments upon the subject for a future article.
