Morgan Cuban Resolutions Cause a Warm Discussion-- No More Jingoism.

WASHINGTON, May 20.—Another striking debate on Cuba occurred in the senate. It was of the give and take order, with sharp parliamentary fencing. The main speeches were made by Foraker, Cannon, Lindsay and Hoar. It was the first speech of any length made by Foraker since he entered the senate, and in addition to this the Ohio senator is one of the Cuban sub-committee of the committee on foreign relations. He spoke in favor of the reference of the resolution to the committee, but declared his purpose of supporting the resolution recognizing Cuban belligerency when it should be reported by the committee.

Cannon was bitter in his denunciation of Spanish atrocities, characterizing the captain-general of Cuba as "that mad-dog" Weyler.

Lindsay declared that, if the information furnished by United States consuls was so striking as to subject them to the danger of assassination if their names were disclosed, it was time to send warships to Cuba and to terminate all diplomatic relations with that country.

It was developed in the course of a colloquy between Foraker Morgan and Vest, that the state department had withheld the name of the United States consuls, reporting on the serious condition of affairs in Cuba, because it might lead to their massacre. Vest declared that this presented the most serious phase of the subject, as it was time to protect our officials with warships, if their personal liberty was threatened for making reports to their government.

No action on resolution was taken, Morgan said he hoped to secure a vote on Hale's motion to refer. He desired to do this, he said in order that the Cuban resolution might not antagonize the tariff bill on Monday.

THE RESOLUTION.

Hoar moved that when the senate adjourns it be until Monday, as many senators wished to go to Monticello, Morgan said such a motion should not be urged when a question of terrible consequence was pressing. He said as a member of the sub-committee which sought information regarding conditions in Cuba, he had refused to accept consular information at the hands of the executive with the injunction of secrecy imposed. Two other members of the committee received the information, but would not consent to receive information which they could not impart to other members of the senate, explaining he said, that the injunctions of secrecy applied only to the names of the consuls. In reply to a question from White Morgan said both the president and secretary of state had imposed this condition.

The motion to adjourn until Monday was agreed to.

Vest asked, in view of the fact that there was fear of danger to the consuls in giving their names, if the government had sent any gunboats to Cuba for their protection, No one replied.

Foraker said another reason for not making known the sources of information was the fear that publication might cut off the information. Every scrap of information at the department's command with the names of the authors should now be sent to the senate as private information, to be considered in executive session. The injunction of secrecy applied only to giving information to the general public.

Hoar said he wanted an early vote. He wanted the resolution out of the way of the tariff.

Gallinger said the Cuban resolution had been before the senate forty-nine days and yet there was complaint made by its opponents that they had not had time to present their views. He thought the senate made a mistake in agreeing to adjourn until Monday.

Cannon said parties may come and go but jingoism may go on for ever, as

long as such a mad dog as Weyler was at large. Weyler, he characterized as a ravisher of women, an assassin of men and a crucifier of children. He said the senate should be a temple of liberty, but instead he would have belied from the utterances here that he was in the Spanish cortex.

Senator Foraker stated that in April, 1896, Secretary of State Olney offered Spain the mediation of the United States to bring the Cuban war to a close. Spain refused the offer. The reply of Spain contained the statement that no measures looking to the peace of the island could be considered until the rebels had been subdued.

Hoar asked if the tender of the United States was on the basis of securing independence for Cuba. Foraker replied that it was distinctly on the basis of Cuba remaining under the Spanish government.

It was evident, he said, that money changers were in the temple. He entreated the United States to learn to stand alone politically, financially and internationally. To bid for European capital was to invite further enslavement. Cannon believed it to be the duty of the United States to establish a protectorate over the Cuban islands. Cannon said he did not share the solicitude of Hoar, as to the safety of Americans in case the resolution would pass. He expressed the opinion that the resolution would pass and neither the tariff nor anything else would be allowed to prevent it.

Lindsay of Kentucky, favored the resolution expressing the opinion that if the United States had declared for belligerency a year ago it would have had the effect of lessening the horror of the Cuban war. This recognition would pass and neither the tariff nor anything else would be allowed to prevent it.
