but the game will be called unless the

DIED VERY SUDDENLY.

Heart Disease Causes Death to Another
Marion County Resident.

Mrs. Mary E., wife of H. C. Bell
died very suddenly at the family
home five miles south of Salem at 2 a.
m. this morning. Heart disease is
attributed as the cause of the sudden
and unexpected death of Mrs. Bell.

The deceased retired last evening at
the usual hour in apparent good
health and spirits but awoke her hus-
band at 2 a. m. this morning com-
plaining that she was sick at the
stomach but before a light could be
produced and help rendered, death
claimed another victim. The im-
mediate cause of her death is supposed
to have been heart failure.

Mrs. Bell leaves besides her bereaved
husband, four children to mourn her
death. Funeral services will proba-
bly be held in the German Evangelical
church, corner of Liberty and Center
streets at 2 p. m. Wednesday. The
remains will be interred in Lee Mission
cemetery.

STATE HOUSE NEWS.

John Riggs, of St. Helens was
brought to the asylum today. He is
46 years old.

The Star Lumber Co., the Oregon

H. George Stanford, of New York,
is authorized by the Croatian na-
tional committee to prepare for the
Colonization of 30,000 Christians from
Croatia, in this country. The gov-
ernment is informed that the people of
Oregon are at liberty to contribute
funds to put before the Croatians
literature setting forth advantages of
the state.

LAWN PARTY.

In Honor of the Twentieth Wedding
Anniversary.

Monday evening a social gathering

cold turn of the weather the desired
out-door entertainment was thwarted.
As it was the friends were received
on the lawns, where the excellent
asylum orchestra discoursed classical
music to the gratification of all.

Under the massive oaks were strung
myriads of Japanese lanterns, the il-
lumination of which lent a special
charm to the place. Fountains and
borders of growing flowers also con-
tributed their part to the beauty of
the surroundings. After most cordial
greetings all around and a general
enjoyment of the outside, the vast
party was invited in, when all man-
ner of entertainment was provided. In
the reception hall above those so in-
clined were offered opportunity for
dancing to the fine music, while in
the various parlors and offices the
guests were scattered about enjoying
lively conversation and all manner of
delightful entertainment.

A sumptuous luncheon served
in the course of the evening, was en-
joyed to the fullest by all. A bevy
of Salem's handsomest young women
served the gay company with rare ef-
fect.

Few of the guests were aware of the
real occasion for this brilliant event,
until shortly before taking their de-
parture, when it became generally
known that it was in honor of the
twentieth anniversary of the mar-
riage of Dr. and Mrs. Williamson.
Thereupon this most popular couple
was showered with the heartiest con-
gratulations, and most generous
wishes for numerous and happy re-
turns of the same. Few parties have
been so happily entertained as this
and seldom has been the privilege of
guests to so thoroughly appreciate a
cordial hospitality.

Crops.

Lower temperature prevailed dur-
ing the past week than during the
preceding. Rain fell Sunday over the
southern portion, which amounted to
less than .10 of an inch. The mean
temperature for the week was 62 de-
grees. The day temperature aver-
aged 72 degrees, and the night 52 de-
grees; the highest during the week
was 82 degrees on Wednesday, and the
lowest was 44 degrees on Friday.

The weather was favorable to the
growth of vegetation. Winter wheat is
in boot; it is from 24 to 36 inches high
has a good color, and is promising.
Spring wheat is going well; barley has
headed. Oats look well; those sown
late want rain. The grain in the
coast sections and in the Willamette
Valley was never more promising.
The first cutting of alfalfa has com-
menced in the southern counties.
Clover is generally in bloom and will
be ready to cut by June 10th. Hops
are not uniformly in good condition;
in some yards they are fine, in others
the growth is irregular. A few hops
have appeared. Potatoes planted
early have tops from 6 to 10 inches in
height. Flax for fibre, is making
good growth and has an excellent
color. Cut worms are reported to be
doing damage in the onion fields of
Washington county.

The great fruit crop, indicated by
the profusion of blossom, will not this
year be realized. Fruit is dropping.
The petite prune is almost gone. The
Italian and Silver prunes now promise
to be about a one-half crop; other
varieties a very fair crop. Bartlett
pears and apples will make a fair crop.
Cherries will be a poor crop. Straw-
berries are ripe and are a fair crop.
Quinces have dropped their bloom
and the fruit is well set.

Funeral services were conducted
from Olinger and Rigdon's Court
street undertaking parlors at 2 o'clock

the deceased.

Deceased leaves three brothers, re-
siding in Salem, a son residing in
Washington and a daughter in Ana-
costa, D. C.
