OREGON POLITICALLY

Opening Gun of the Campaign Was Fired.

AT MACLEAY WEDNESDAY EVE.

The Hayseed Candidates Make a Good Impression.

MACLEAY, April 21.—The opening gun of the campaign in Marion county was fired here Wednesday night, when the Macleay Union Bi-metallic club held a rousing political meeting. There was a splendid audience present, including a large attendance of ladies and young people. Great enthusiasm prevailed. There was an appropriate literary program carried out as usual. It was a regular war meeting in behalf of Cuba freedom from the start, and the patriotic sentiments of the speakers were received with great cheering. The temper of the meeting disclosed the fact that the American people without party division favor the independence and liberation of Cuba and are heartily in sympathy with the aggressive policy of the American congress.

CANDIDATES PRESENT.

Candidates on the ticket, of the Union party, were present as follows: Hon. L. C. Griffith for state senator, F. A. Myers for representative, K. L. Hibbard for county clerk, Frank Durbin for sheriff, C. L. Simeral for treasurer and C. Marsh for county commissioner. The gentlemen were all called out to make short speeches and made a very favorable impression. They put themselves squarely on record in harmony with the sentiments of their platform. Macleay precinct, which has heretofore been a Republican stronghold, will leave the Gold Standard party a very small margin of votes. Hon. E. Hofer, the hayseed orator of THE CAPITAL JOURNAL, was present and delivered the main speech for the evening. For an hour and a half he reviewed the vital issues of the campaign. He eulogized the Union county and legislative ticket and referred briefly to some of the candidates on the state ticket. The mention of Hon. Will R. King for governor, and Hon. Harrison R. Kincaid for secretary of state elicited great applause.

Discussing the money question, the speaker showed up the Gage policy disowned by many Republicans. Col. Hofer showed that for eighty years prior to 1873 there had been practical and substantial bimetallicism and actual free coinage of silver. The coinage and bullion value of the two metals at a ratio of about 15 to 1 had varied during that time only fluctuated a few per cent, and the price level of all staple products in the markets of the world had been maintained during that period. Since the demonetization of silver in 1873 the level of prices had been disturbed and values of products and property had been destroyed. Republicans who really wanted to restore prices should be willing to restore bimetallicism. Mr. Hofer challenged any gold standard orator to refute his historical statements as to the maintenance of the level of prices up to 1873. Unless Republicans could refute those historical facts it was their duty to vote for bimetallicism if they really favored restoration of values.

STATE ISSUES.
The speaker did not refer to Mr. Geer other than as an amiable exponent of the gold standard theory. He commented on the fact that two of the most important places on the Republican state ticket had been filled with Republican county officials from counties where there had been very recently large defalcations by Re-

publican county treasurers, and that these treasurers had not been convicted and the tax-payers had not recovered their money. Pointing to Mr. King Hibbard, the Union candidate for county clerk, Mr. Hofer said that if he were elected and would for three years certify to the correctness of semi-annual statements from the county treasurer, when in reality there was a defalcation covered up in official reports, he would pledge the Union party that it would not nominate Mr. Hibbard for secretary of state.

The entire meeting was an earnest demonstration of a determination on the part of the people to secure substantial reforms in their county and state government. The speakers were hospitably entertained at the home of Judge and Mrs. John B. Waldo.

JOURNAL X-RAYS.
The Statesman's criticism of Mr. Kincaid's decision neither suggests its errors, nor points out the law. Able, is it not?
There were a good many heads swelled with their political importance, that have resumed their normal condition since the political conventions have come and gone.
Some of our aspirants for office, who were at Astoria, expecting "lightning to strike them," must be sorely disappointed that their aspirations turned out to be only a flash "in the pan."
One or two Republicans, accustomed to a sinecure office, such as pretended services at the asylum, think they will be able very soon to revive the sinecure and renew their old job. Well, we will see; but we wonder whether their services will be gratuitous.
The Spanish people will not go to war with our country. They will overthrow their monarchy before they will sacrifice three or four hundred thousand of the best blood and chivalry of Spain, to say naught of wasting millions of treasure.
The whole land echoes and reverberates with the booming of cannon and the strains of martial music. But this does not drown the merry tune the gubernatorial bee is buzzing in the bonnet of the sage of the Waldo hills.
The same old Republican administration is reigning at the court house. Five of the court house crowd were re-nominated and the Statue of Justice still adorns the tower. The Statesman's suggestion was not acted upon.
Did the Mitchell push mean those ratification speeches for sarcasm, or was it simply idiocy? It was certainly perfunctory.
Congress acted patriotically; McKinley failed.

The Middle-Roaders wanted them filed in such form that the regular Peoples party nominations could not have got onto the ticket at all. It was not so much the desire of the Middle-Roaders to get their own ticket on, but the solicitude to keep other nominations off that troubled the secretary.
