Getting Ready to Push the Spring Campaign

Club Meetings in North Salem—Central Committee Meeting at City Hall

The Populist club of North Salem held a meeting at the Exchange warehouse in North Salem Thursday afternoon, for the purpose of electing delegates to the meeting of the county central committee, called for today at the city hall in Salem.

R. R. Ryan presided over the meeting, and T. J. Clark acted as secretary. The delegates elected were R. R. Ryan, T. J. Clark and G. Wright.

The coming campaign was discussed and a platform was adopted favoring municipal, county, state and national ownership of all public utilities, including transportation and communications, together with the initiative, referendum and the imperative mandate; the issue of all money by the general government, without the intervention of banks, a full legal tender for all debts both public and private is also demanded.

Resolutions were also adopted endorsing the Omaha and Cincinnati platforms and declaring for "no more fusion with Democrats or Republicans on their platforms." A club of 20 members was organized.

The central committee met in the police court room at the city hall this forenoon, and have been hard at work ever since with a short intermission for dinner.

Geo. Weeks presides over the meeting and J. M. Payne acts as secretary. About twenty-five delegates are present. Among the prominent Populists present, besides Chairman Weeks and Secretary Payne, are R. R. Ryan, B. J. Sharp, Mr. Swank of Aumville, Prof. Jory, G. W. Jory and others.

Chairman were appointed for the different precincts this afternoon. What other business had been transacted is not available at the time of going to press.

An unmuzzled but really inoffensive representative of the press, incautiously strolled into the meeting after dinner, and his presence caused a somewhat lively discussion, at the conclusion of which he was without a dissenting vote invited to stay and take the proceedings of the meeting for publication, leaving out the details of the discussions indulged in, an invitation which other duties prevented him from accepting.

Boy Arrested.

The Disorder at the S. P. Passenger Depot Must Cease.

Eugene Johns, aged about 12 years, was arrested this morning on complaint of the night operator at the S. P. passenger depot, on a charge of violating ordinance No. 353, which forbids climbing on and off railroad trains. There has been much complaint of the actions of a number of youngsters who make a practice of collecting at the depot and conducting themselves in a very disorderly manner. They jump on and off the moving trains, and the railroad men are kept in a state of nervous tension in expectation of the serious accident which would inevitably result were these practices allowed to continue. Passengers waiting for the train are excessively annoyed by the profane and often indecent language and actions of the crowd of boys.

The matter has now come to a point where the city authorities propose to take a hand and put a stop to these practices, and the boys will be obliged to keep within the bounds of order and decency.

Foreign Advances Indicate a Much Firmer Tone.

O. H. G. A. office in Salem Classifying Samples—Many Third Class—Pres. Jones in Washington.

Jas. Winstanley, in charge of the Salem office of the O. H. G. A. received a telegram last evening from President Jones, who is now in Washington, and who wires that the market in the east is firmer.

President Jones will next be heard from at Chicago where he will stop on his way home.

Mr. Winstanley has several offers for lots of association hops which he has taken under advisement.

With the assistance of Mr. Carmichael, the hop buyer, the samples of hops in the association office are being classified.

Out of 8,982 bales already classified by sample there are 2,473 bales of first-class; 2830 bales second-class; 3334 bales of third-class; and 355 bales of an intermediate quality between second and third.

Mr. Winstanley is ready to receive and consider offers for many of these lots.

New York state reports indicate that a few hops are changing hands at prices ranging from 7 to 10 1/2 cents, but there is little movement and no pressure from either buyers or sellers.

Reports from foreign markets all indicate a decidedly firmer tone. From several points the meat of the reports is as follows:

Nuremberg: The firmness previously noted is well maintained, and the upward movement is making steady progress. Hops graded as secondary at the opening of the season have now been advanced to the first class, and sell at corresponding prices.

Alsace: Demand is active.

Belgium: The tendency toward higher prices is well supported.

Borough: Trade in the Borough is still maintained, and a decided tendency towards improved values is evidenced.

A similar tone is also noticeable in other Continental centers. The demand for all qualities continues very active and higher prices are generally obtainable.

Lupulin in Mark Lane Express.

An increased demand has been felt during the past week both for home consumption and for shipment to the continent; and in the absence of choice parcels of hops, good medium and even lower class English growths are now inquired for. The advanced values are fully maintained, and in many cases growers are refusing to sell at present rates, or are advancing their limits in anticipation of better business at the commencement of the New Year.

Therefore, I would again urge upon planters that their opportunity, so long waited for, is on the verge of realization, and if they wisely take advantage of it, they will be able to assume command of the market, in which they have too long been oppressed. It is not improbable

ARDMORE, L. T., Jan. 19.—This is the day set for the hanging of Charles S. Bias, colored, for the murder of George Wright, colored, in Feb. 1898. Bias was convicted at the November term, 1898, and appealed the case, and the civil court of appeals affirmed the decision of the lower court. Marshal Hanner was directed to keep Bias in custody until today, and then hang him. Unless President McKinley interferes at the last moment, this will be the first legal execution under the jurisdiction of the United States laws in the Chickasaw nation.

SAN FRANCISCO, Jan. 19.—Through the influence of Consul Ho Yow, the Chinese Six Companies, of this city, have agreed to assist the police in terminating the highbinder war, which has been raging in Chinatown for some time past. Today the Six Companies subscribed \$17,500, which will be offered as a reward for the apprehension of the murderers. Chief of police Biggs will guarantee the members of the Six Companies protection from the vengeance of the highbinders for the action they have taken.

Execution in Chickasaw Nation.

ARDMORE, L. T., Jan. 19.—This is the day set for the hanging of Charles S. Bias, colored, for the murder of George Wright, colored, in Feb. 1898. Bias was convicted at the November term, 1898, and appealed the case, and the civil court of appeals affirmed the decision of the lower court. Marshal Hanner was directed to keep Bias in custody until today, and then hang him. Unless President McKinley interferes at the last moment, this will be the first legal execution under the jurisdiction of the United States laws in the Chickasaw nation.
