WHEAT VS COWS.

Farmers of the Willamette Valley Would Better Turn Their Attention to the Latter.

A few years ago, when wheat in the Willamette valley was worth \$1 per bushel, it was probably the most profitable crop to be raised; but now that wheat land in some sections yields so large a crop as in former years, and the price is often less than 50 cents a bushel, the farmers of Oregon must adapt themselves to the changed conditions. They may learn a profitable lesson from the experience of their fellow producers of the Eastern states.

Years ago, when the bulk of the wheat produced in the United States was grown in or near the states of New York and Ohio, and when it was worth near \$1.50 per bushel, it was a profitable crop for the farmers in those eastern states. But as the railroads were built west, and the great prairie, with its newer and richer lands was brought into cultivation, wheat was grown in larger quantities and at a price that made wheat-growing unprofitable in the older states where the land had become poor from years of continual cropping.

These changed conditions induced farmers to engage largely in dairying. First cheese factories and then creameries were erected, and the finest herds of cows were kept. In a few years the impoverished farms were rich in soil, and growing large crops of clover and corn to fill silos and provide green food for the cows during the long winters.

Dairying proved profitable. New York state gilt edged yellow butter and the richest of cheese became in demand, and millions of dollars' worth have been exported to other countries.

Farmers who are competent to judge claim that the Willamette valley is one of the best dairying sections in the country; yet there is hardly a cheese factory or creamery within reach of Salem, and much of the butter and cheese we eat is brought here from other countries, and occasionally from other states.

There is, however, one cheese maker in this vicinity, but he finds it difficult to obtain as much milk as he would like to use. This is Mr. Schubinger whose factory is situated on the Asylum farm road three miles from Salem. He has had large experience in Germany as well as in this country, and he uses all the milk he can buy in making fancy cheese for the market. Mr. Schubinger is unable to supply the demand for his cheese, as he can only secure the milk from thirty cows, while he is prepared to buy all that three hundred or more could produce. He pays as much for milk as do the cheese factories in eastern states where the cost of production is much greater than here, and will go after the milk, thus saving the farmer the expense of delivery.

Some idea of the amount of milk to be obtained from a good cow may be gathered from the following record: At the late Agricultural show held at London Canada—the dairy cow that won first prize was a Holstein 9 years old, and was milked each day of the fair.

The first day she gave 74 pounds, the second day 72 pounds, the product of the first two milkings tested 4.5 per cent of butter fat, the product of the next milking tested 4.8 and the last milking 4.3 per cent butter fat. This cow's previous unofficial record credits her with her best 14,000 pounds of milk in ten months.

This matter is well worth the serious consideration of the Willamette Valley farmer. If a good cow will produce in a year four tons of milk that will sell for \$80, ten such cows would yield the owner \$800, a sum sufficient to make him independent of the price of wheat, and the crop will grow each year. The small farm well worked will grow enough clover, corn and other feed to sustain a small herd of cows, and these will produce an income sufficient to make a prosperous and happy home.
