"BILLY" BUNDSCUH IN TROUBLE.

Runs Wild in a Portland-Oregon City Car and Terrorizes Passengers.

W. B. Bundschuh, who formerly as a moulder worked in the penitentiary stove foundry, and is well known in Salem, created quite an excitement in one of the Portland-Oregon City electric line a few evenings ago by threatening to kill the conductor and blow the whole car to smithereens. Bundschuh had the appearance and demeanor of a determined man, and the conductor, Everett Bilyeu, had done nothing to offend him or to arouse his ire. When he uttered his threats in a loud tone of voice, alarming all the passengers in the car, he made at the same time a motion to draw a revolver from his pocket. The conductor, assisted by several citizens, overpowered and disarmed him, stopped the car at Grand Avenue and Hawthorne, and sent a messenger to telephone to the police station.

Before the patrol wagon arrived, Bundschuh, by the exercise of his frenzied strength, broke from the citizens holding him, and started on a run, followed by his former captors. The police officers, arriving about that time, joined in the chase, and caught him after a five blocks' run.

Bundschuh was desperate, and fought until the last. He was taken to the police station and charged with threatening to kill.

It is evident that he is again suffering from the mental trouble which has before caused his temporary detention in the asylum.

PROSPECTS ARE BRIGHT.

Burlington's New Western Line.

The extension of the Chicago Burlington & Quincy to the North Platte River region was opened for traffic to-day.

The new road extends from Denver to the North Platte River, and from there to Brush, Col. This will make a great difference in railway distances from Denver to points in the Northwest. It shortens the railroad distance from Denver to Deadwood about one-third.

Foot Badly Burned.

The young son of Mark S. Skiff had misfortune to severely burn one of his feet by stepping into an open fire. The little fellow was playing about while in camp at Ocean Park and accidentally stepped into the hot embers severely burning the bottom of one foot. Dr. Robertson, fortunately arrived the next day and administered relief and the little fellow will soon be about but will have a sore foot for sometime.

New Suit.

Mrs. Harriett Patterson, has commenced suit in Department No. 1, of the circuit court against John Patterson and M. L. Chamberlain to recover the sum of \$209.80 alleged to be due on a note for \$230.20 dated June 20, 1892, given to the Capital National Bank and assigned to plaintiff. \$40 attorney fees are also asked for. Bonham & Martin are attorneys for plaintiff.

Placed Under Bonds.

O. P. Beardsley appeared before Justice of the Peace O'Donald, Tuesday at 3 p. m. to answer to the charge of threatening to kill B. I. Ferguson. He waived examination and was placed under \$300 bonds to keep the peace and await the action of the circuit court. He furnished the bonds and went his way.

PRICE OF PICKING.

Butteville Hop Grower Says Growers Are Not Likely to Pay Forty Cents.

Editor Capital Journal.

In your Saturday's edition I notice an interview relative to the Hop situation that contains so many errors, that I hope you will correct them when pointed out to you. You say, or rather the person you interview says, "that all hop yards are looking fine." Any hop grower will tell you that the vine appears strong but the "hop berry" is not forming at all well, and the crop will in all probability not be a large one, but no doubt of very fine quality. Not one grower in the Butteville, Aurora, Champeo, Hubbard or adjoining hop sections is willing to pay more than 35 cents per box this year. At that figure the pickers get more than the grower does.

The regular price for a series of years has not been 40 cents as your authority claims, and for his information I will give the price for a series of years and the average, 1894, 30c; 1895, 35c; 1896, 25c; 1897, 35c; 1898 35c; 1899, 40c. Average for six years 33 1/2c.

The meeting held at Butteville was not an Oregon Hop Growers' association meeting. It was a meeting of The Hop Growers' Fire Relief association, and representative Hop Growers were present from practically every hop growing section in this end of the valley—Not one grower present was willing to pay more than 35 cents per box this season, and indeed why should the grower pay more?

At 35 cents per box children can earn \$1 to \$2 per day and adults from \$1.50 to \$2.50. Harvest hands work harder and longer hours for much less wages. Some families earn more than in the hopfields during the short season than they do the balance of the year. Last year the growers paid 40 cents per box. Most of them sold their hops at from 3 to 10 cents per pound, losing heavily, at that time the indication before picking pointed to about 15 cents per pound for hops. The mistake made in paying so much for picking was therefore natural. This year (now) dealers are offering to contract from 9 to 10 cents per pound for a choice hop, which means about 6 to 8 cents for good prime. Now with these prices before us it is common business sense to pay it all out for picking, leaving us nothing for our own work, money invested, etc?

The Hop Growers of North Yamhill are paying, so I am informed, 75c @ 80c per 100 pounds. Green hops weigh about 43 lbs per box this is about 33 1/2 cents per box. Silverton has set the price for that locality at 33 1/2c per box. Advice from California are that picking began in some yards Aug. 13 @ 80 to 85c per 100, about 35 cents per box. I do not pretend to speak for Independence, Eugene, Dallas, etc, yet from advices from some of the prominent growers they assure us that not over 35c will be paid.

There are freaks among the hop growers and such may see a profit ahead and pay 40 cents for picking. But when such prices are paid the grower has either a poor yard or he pays it with certain conditions attached, that really leave the picker less than 35c per box if picked in the usual manner.

Now one word in regard to the Employment Agents. We have had some experience with them. They bleed both the grower and the picker. Usually charging a sum ranging from \$1.00 to \$5 per picker, and agreeing to place the picker in the finest hop yard in the state, a yard in which they can earn \$5.00 per day easily, board and lodging free. During one year there were several thousands of these dupes stranded on the river banks, waiting for hops to grow. Discouraged and cursing the bogus employment officers, these people had to find jobs as best they could. The better way is for the family who wishes to pick hops, to write to hop growers in the locality they choose to go, say, about the 20th of August, if everything is satisfactory, they need give themselves no more trouble until the grower advises them by mail that his hops will be ready to pick at a stated time. He meets them at the nearest landing—hauls their belongings to and from his yard, and treats them fairly in every way. A jolly good time is usually had in the fields. It is not all work by any means. To my knowledge the picker never existed who was not benefitted by the outing among the hops.

HOP PROSPECTS.

English Crows Will Be Light and Pacific Coast Will Have Superior Quality.

Latest reports from the hop yards of England indicate that the crop there will be far from a full one. The best reports come from Mid Kent, where prospects are said to be improving. Vermin and mould have decreased and well cultivated grounds promise a fair crop in yards that have been well cultivated and sprayed, though neglected yards will not turn out much.

Reports from the principal districts of Sussex show that where the hops are well cultivated, and where washing has been repeated over and over again, the improvement in the bine is considerable, but even in the best grounds there is

still a lot of vermin. Unwashed and badly cultivated plantations are going from bad to worse and a black blight seems imminent. The prolonged drought and great heat are proving too much for such pieces.

Reports from other hop-growing sections of England indicate conditions much like those in Sussex, though in many places even the best yards will not give a full crop and neglected yards will be a failure. On the whole the English crop will probably be considerably short.

Reports from California are that the crop will be light but of superior quality, and the same may be said of the Oregon crop. A reliable authority at Eugene writes: "The crop in this county will be lighter than usual, but the quality will be fine."

IMPROVING RAPIDLY.

Dr. Ransom of Turner Recovering From His Wound. Boy Was Not to Blame.

Dr. J. W. Ransom, of Turner, who was severely wounded at Crescent Lake by accidentally being shot by his son while out hunting, was in the city today. The Dr. says that the boy was not to blame about the accident. They had been hunting along the banks of a creek and the doctor was on one side while his son was on the other and they were both following down stream in the same direction. The stream took a sharp bend and the doctor crossed the creek to the same side that his son was on without notifying his son of the position he had taken. In a short time they were within fifty yards of each other and the son heard a noise in the woods and laying down upon the ground he saw the dog and, thinking it was a deer laying down shot at it. The ball struck the father in the left shoulder and went through his shoulder blade and passed on through his right arm.

The wounded man was taken in to camp and in a short time they started for Eugene a distance of about 100 miles and the party drove all night. Reaching Eugene medical service was obtained and the doctor came to his home at Turner and has improved sufficiently to be able to come to Salem where he will have the physician examine the wound and see if it is healing all right. Dr. Ransom is known to be a good physician and a highly respected gentleman and we are glad to see him improve so rapidly.

Two Petitions.

Peter Shields has petitioned the county court asking to be discharged as guardian of the person and estate of Bridget Shields, and making a statement substantially as follows: That said Bridget Shields, wife of the petitioner, is confined in the Oregon insane asylum and is incurably insane; that at the time of her commitment she had in her possession \$290 1/2 which belonged to the petitioner, which was taken possession of by the superintendent of the asylum; that petitioner through a misapprehension had himself appointed guardian of the person and estate of said Bridget Shields. He now asks to be discharged as said guardian, and that the money be turned over to him as his individual property. The petition will be heard Sept. 5.

In the matter of the guardianship of Mary Helen Mize, a minor, Stella Mize, the mother, petitions the court for an order requiring John Bayne, guardian of said minor to pay petitioner \$10 per month out of the estate of said minor for support of said minor; also the sum of \$25.00 advanced by petitioner to pay charges of John Moir former guardian of said minor.
