### MEETS DIAZ AT EL PASO

### In Conclusion Will Make a Tour Through New England

WASHINGTON, March 21.—The President's proposed western trip is attracting much attention in states through which he is to pass and invitations from various cities and towns which hope to entertain him along the route are daily arriving at the White House.

New Orleans will probably be the first stop after the party leaves Washington. It is the present intention to leave Washington April 30. Secretary Cortelyou has been working on the itinerary, but practically nothing of a definite character has been decided upon.

Expectation is that the meeting with President Diaz of Mexico will be arranged at El Paso. At San Francisco the party will stop a week in connection with events attending the launching of the Battleship Ohio. On the return trip over the Northern route, the party will visit Yellowstone Park. After the President returns from his western trip he is going to New England.

### Independence Will Be Ready to Perform on This Side

BOSTON, March 21.—Thomas W. Lawson would like to race the Independence in the Clyde regatta on June 7 and 8, when Sir Thomas Lipton's Shamrock II will sail against the finest yachts in England. The yachting committee of the Glasgow Exposition intend asking the leading American clubs to take part and are especially anxious to get the Independence to participate.

Mr. Lawson said last night in regard to the matter that he would be glad to take the boat across but there was no probability of her being sufficiently tried out in time to attempt the trip to the other side. Continuing, he said:

"From the present outlook Independence will not be launched until the first part of May and it will take at least two weeks to put her in trim for racing after she takes the water. Three weeks would be required to cross the ocean under jury rig and considerable time would be necessary in order to re-rig for racing after the Clyde was reached."

New York, March 21.—It is not likely that any New York yachtsmen will accept the committee's invitation. A leading member of the New York Yacht Club said last night:

"There is so much interest in the race for the America's cup that the general disposition is to remain near the ground on which the matter will be decided."

"At any other time many Americans would be glad to make the trip but in this instance it would be a hurried race there and back with no time to spare and owners of crack racers like to stop over and fraternize with members of foreign clubs when they reach the other side of the pond."

## WOMAN KIDNAPED

### Disappeared on the Chicago Lake Front

### PERSONAL EFFECTS ARE DISCOVERED

### The Lake is Dragged But the Body Has Not Yet Been Found.

CHICAGO, March 21.—A woman's mackintosh, hat, a pair of gloves and a letter signed "May Comstock" and addressed to Sarah L. Wright, 740 Park Avenue, were found on the lake front at Sixty Third street. The police learned from Sarah Wright that Miss Comstock boarded with Mrs. Freeman, 240 North Union street. At the latter house it was learned that Miss Comstock was a daughter of John Comstock, of Benton Harbor, Mich., a wealthy retired fruit grower, formerly of Florida and California and that she came here to study music. Tuesday afternoon Miss Comstock left her boarding house for the American Conservatory of Music, where she appeared and took her music lesson, but when she went away from there at four o'clock she left behind her umbrella and violin.

Park Policeman Richards reports that he saw a woman enveloped in a black mackintosh walk on the lake front late that afternoon, but paid no particular attention to her, as many persons stroll along the beach daily at this point.

The police believe the girl has drowned herself and the lake was dragged between Sixtieth and Fifty-sixth streets, but no body was recovered. A strong current sets out into the lake at this point and if the girl has committed suicide, her body has probably been carried out into deep water.

The father of the girl reached Chicago last night. He is unwilling to accept the suicide theory that the police have formed from the finding of the outer garments of the girl. Mr. Comstock has an idea that his daughter was kidnaped and he will not credit any other theory.

Miss Comstock was taking a special course on the violin. She was an accomplished musician for her years and aspired to perfection in her art. Her father encouraged her ambition. He was impatient to have her advance rapidly and expected to send her to Paris to complete her musical education.
