OFFER WAS REFUSED

Superintendent Lee Tendered
Mrs. Waggoner \$300

For the Delivery of Merrill's
Body--To Contest Reward

Mrs. Mary Waggoner, of Lewis county, Washington, who found and delivered Convict Merrill's body to the penitentiary authorities, was offered \$300 by Superintendent Lee to reimburse her for her expenses and as a reward for the delivery of the body. The offer was rejected by Mrs. Waggoner, who has filed in the governor's office a written claim for the \$1500 reward. Any further proceeding by Mrs. Waggoner to recover the reward will depend upon Governor Geer.

When Merrill's body had been delivered to Mrs. Waggoner, after the coroner's inquest, she purchased a metal casket, that was plainly trimmed, into which the remains were placed, after a neat burial robe had been provided. In this way the murdered outlaw received a decent burial. Sheriff Degeeler and Mrs. Waggoner left this morning for Chehalis. When seen at the railroad station Mrs. Waggoner said:

"The prison management and I could not agree on terms of settlement for the delivery of Merrill's body. Superintendent Lee made me an offer of \$300 to reimburse me for my expenses and trouble, but I refused to accept it. In finding and delivering the body to the penitentiary officials at Salem, my expense items alone aggregated over \$200, and, in view of the circumstances, I do not think the tender made by Superintendent Lee is deserving of serious consideration. I am still of the belief that I am entitled to the reward of \$1500, and shall continue to make that contention. I have filed with the governor a formal claim for the \$1500 reward money. I shall wait and see what action Governor Geer takes before taking further steps to enforce the payment of the reward."

"It has been stated that I was black-berrying with my son, when I discovered the body of Merrill. This is incorrect, as is also the report that I am a widow. I was passing down the road to a neighbor's when I was attracted by the scent of a decomposed body, and located the remains. I also have a husband."

Mrs. Waggoner seems hopeful of realizing more than the \$300 that has been offered, and it is understood that Sheriff Degeeler, of Lewis county, is standing loyally by Mrs. Waggoner in her contest for the reward money.

THE SPOTTED GAYUSE CRAZE.

The Calico Equines Are in Demand
for Eastern Children.

The calico craze of the Western hills is becoming quite fashionable in the East, and the demand for spotted bronchos is rapidly increasing. With the cessation of war and the consequent diminution of demand for cavalry mounts, the Western range horse grower saw his business slipping from him, but if fashion takes up the calico craze along with ping-pong, there is yet a hope. The cayuse is not a valuable animal, so far as price goes, and lucky is he indeed who can secure \$30 for one of them in this country, yet in the Eastern markets it is claimed they spring skyward in monetary worth, and bring from \$50 to \$75, in ration of their spots.

It is estimated that on the ranges of Eastern Washington and Oregon there are 20,000 cayuses at the present time. Coffin & Company, of Portland, Ore., are gathering them in for Eastern shipment, as a speculation, and visits are being made to all sections of the inland empire to select the most attractive animals. The cayuse craze has its main hold upon the children, and an Indian pony is just the thing for the children to ride to school or go driving with in the park. For attractive pinto ponies they are, therefore, content to pay a large price.

The fact that the cayuse breeds on the range and maintains himself from the day he is born, makes his growth and profit to the stockman, and at the age of three or four years he can be gathered in and sold on the first day his owner ever saw him, he has fulfilled his mission on the stock farms of the West. What he may do after he reaches the East is quite another matter--Walla Walla Union.

The Big Daily and the Little Daily. There has been more or less discussion recently as to the crowding out of the small daily papers by the dailies published in the big cities. Some of the publishers of the former class of papers profess to be greatly alarmed over the prospect.

The Aspen, (Col.) Times, however, is not one of these. In a recent editorial it said: "Some people think, or say they do, that the day is rapidly nearing us when the big city daily, with its pages of literature every day, will crowd out the smaller papers, and leave them stranded on the shoals of ruin and disaster. We do not see any signs of that time approaching. On the contrary, we do see the promise of a fuller and more complete use of the local newspaper."

The great city dailies may be divided into two classes. The first is the subsidized and respectable paper. Its object is financial. Money and nothing else is what it is after. It is afraid to say that its soul is its own. Its aim is to conciliate continually and to flatter all the time. It wants to please everybody. It does all within its power to keep patronage. No plan is too small, no scheme too low for it. The other kind is the yellow journal. This is the paper that goes to extremes, and were it not for the absence of all opinion in the subsidized press there would be no room for the wild-eyed newspapers, which cater to the degraded, and which attack all government.

JOURNAL HAD A SCOOP

Not Denied That Men Tried to
Scale Prison Walls

Exposure Doubtless Results
in Greater Precautions

The Journal story of two men trying to get over the Oregon state prison wall Tuesday night was eagerly read, and the papers were scarce soon after the public got hold of the story. The story was justified as it put some of the prison forces on their guard.

The prison officials were surprised at the story getting out, and some of the guards were questioned closely to ascertain how the information had leaked out. But no one knew. The Journal had managed a great news scoop without getting a word of information from the prison management, or from any guard, and the mystery as to how news gets out is still unsolved. If it has the effect of preventing a general delivery it has served its purpose.

Portland Paper Hears a Rumor.

The following was sent from Salem yesterday to a Portland paper: There was a vague rumor on the streets today that an attempt was made by two men to enter the penitentiary last Tuesday evening. Inquiry at the prison fails to bring either confirmation or denial. It is known that the story had currency among the prison employees, but no one seemed to talk of the matter very seriously.

In order to remove one of the means of protection which aided Tracy and Merrill in their escape, the prison authorities have hauled out of the prison yard the big piles of moulding boxes which were stacked in long rows around the stove foundry shops. The prison yard will be cleared as far as possible of all material which might afford a hiding place and protection for a convict or other person seeking to secrete himself inside the yard.

About a week ago one additional guard was placed on duty in the shop yard, so there are now three men on guard there at night. Before the outbreak one man guarded the yard at night.

The Journal prints the story of Mrs. Waggoner's refusing to take \$300 for delivering Merrill's body, which will probably surprise many persons. Public sentiment generally favors liberal treatment of Mrs. Waggoner.

If those Portland detectives had found Merrill's body they would have pulled the state's leg for several thousand. But Mrs. Waggoner is a woman, a stranger, and has no political pull.

Umatilla Lands to Be Sold at Auction.

South of Athena, on the opposite side of the big Umatilla Indian reservation, lie 90,000 acres which are affected by the Moody law, recently passed in Congress. They are the last of the unallotted or unsold lands of the reservation. President Roosevelt affixed his signature to the bill, and it is now a law. The date has not been set, but these lands will be offered for sale at auction before a great time.

Twelve years ago this land was appraised by a government board and values fixed at from \$1.25 to \$25 an acre, according to the various grades between scrub sheep range and good agricultural soil. The fact that the Moody law allows squatters a 90 days' prior right to purchase the land they have squatted on at the appraised value has caused quite a rush of these individuals. Land values have advanced considerably over the appraised value of 12 years ago, and these men will make considerable money by selling out immediately. There has been no trouble over squatters' rights yet, and probably will be none, such as was experienced at the Fort Hall opening.

The valuable agricultural lands have practically all been located by squatters, and much of the better class of range land which shows farming possibilities has also been squatted on. The great bulk of the 90,000 acres, however, will be placed on sale, but is useful only as sheep or steer pasture. In fact, the squatters on this kind of land are said to be mostly in the employ of stockmen. The squatters on the best agricultural lands will have a bonanza in buying at the appraised value, as some of these have been cultivated for several years, and are equally fertile and valuable with the high-priced lands owned by the Umatilla Indians, and leased annually at a high rental to reservation farmers, who grow immense crops of wheat. The scrub land is worth perhaps twice as much as the appraised value, and constitutes an excellent speculation for a squatter.

When all the Umatillas, Walla Wallas and Cayuses were allotted holdings from the larger tract measured out for them by the United States government, a considerable tract was left. Much of this was sold shortly after. Those 90,000 acres always remained unallotted. They are now to be taken from the man who has been cultivating them without having a clear title or having to pay taxes, and from the stockman, who has been using them for a range, and sold. A big rush is anticipated when the day of auction comes.
