GRAND LARCENY HEARING

Three Lads Charged With Theft of \$3800

Have Preliminary Examination in Justice Court

The case of the State vs. Roy Ramsby, Clyde Ramsby and H. F. Purdy, jointly charged with the larceny of \$3800 from Mrs. Isabella Ewing, of Hubbard, was called before Justice Horgan at 10 o'clock this morning. The case was vigorously contested, both sides sparring on the slightest legal technicality. The court room was filled with curious spectators, among whom were several young women.

Deputy District Attorney J. H. McNary conducted the prosecution, while L. J. Adams, of Silverton, and John A. Carson, of this city, presented the Ramsby boys. L. H. McMahon appearing for Purdy. The decorum of the audience during the hearing was very poor, in spite of Justice Horgan's efforts to maintain order. The amount of "ragging" that was indulged in by the opposing counsel rivaled that usually experienced at a college football game, and the conduct of the counsel for the defense in the cross-examination, which may have been aggravated, certainly did not promote the demeanor of the crowd.

Some of the principal witnesses for the state showed a decided unwillingness to tell what they knew of the case. They were really a detriment to the prosecution. In fact a number of them seemed to be seriously affected with an aggravated attack of forgetfulness concerning all facts in connection with the case that might prove damaging to the defendants.

The taking of testimony for the state was concluded at 12:30 o'clock, and counsel for the Ramsby boys announced that they desired to introduce no testimony, and asked for an adjournment until 7 o'clock this evening, when a motion to dismiss the charge will be argued. At that time McMahon expects to examine a number of witnesses in defense of his client, H. F. Purdy, whom, it is alleged, is one of the principal parties to the theft.

The testimony. Frank Lamb, who lives near Silverton, was the first witness called by the state. Had known Ramsby boys about eight years. Did not know Purdy. Last March had a talk with Roy Ramsby near Silverton, when Ramsby told him that he and Purdy had taken the \$3800 that was reported to have been stolen. I doubted his story, but he took me and showed me the bucket in which it had been buried. Ramsby said they found the money in a yard. Bucket was under the barn of Dr. Davis. Had another conversation with Ramsby at a later date at Scotts Mills in June, when he told me he feared he was going to get into trouble over the stealing of the money. Ramsby never said to whom the money belonged, but said Purdy went with him when he got the money.

Carson conducted the cross-examination, and elicited the fact that both the witness and Ramsby had been drinking, and were more or less intoxicated. Had poor recollection of conversation with Ramsby in March. Ramsby told him that the people of the neighborhood were accusing him and companions of taking the money.

On re-direct examination by McNary, witness testified that Ramsby told him that if he (Lamb) did not believe that he stole the money, he could take him to the Davis barn and show him the pail in which the money was taken. Carson objected most positively to the question, which was answered before the objection had been stated. Court sustained the objection, and, at the request of Carson, struck the answer from the records.

Arthur Chandler, of Silverton, for whom Roy Ramsby worked in a hop yard last fall, related a conversation had with Ramsby. The young man told witnesses—about September 1st—that he had been told by Purdy of some buried money 'down the line,' and was given an invitation to take a hand in taking the money, but he did not know that he would participate.

On cross-examination witness stated that Ramsby further told him that he did not think he would take part in the proposed theft.

Mrs. Isabella Ewing, the woman from whom the money was stolen, testified concerning death of her husband last September. I had \$3800 in gold coin buried in a bucket under a box in a woodshed. Witness identified the recovered as the receipt in which the money was hid. Money was stolen about November 2d. First missed the money on the morning of November 6th. Part of the money had been buried there for over a year. Young Purdy frequently came to the house to visit his uncle. He came several times when the money was buried there. Woodshed was always open. Did not know that Purdy had any knowledge of the burial of the money on the premises. Did not know the Ramsby boys.

McMahon conducted the cross-examination of Mrs. Ewing, and brought out the fact that Ewing had, prior to his death, given Purdy's father \$2900, but witness stated that did not prejudice her against her great-nephew.

Mrs. Ewing testified that she herself buried the money, all of it \$3800. The money, \$2500 in amount, was taken out of the Woodburn bank in 1901. It had been given me about two months before, when I buried it. Mr. Ewing was aged 84 at the time, and was sick, but not so ill but what he knew what he was doing. Purdy had been to house after money had been buried. Do not know that Mr. Ewing ever told Purdy where the money was, or that Purdy knew that any money was buried there. At the time Ewing gave me the money it had been buried, he having transferred its possession to me. Husband left no will. Last time Purdy was on place to my knowledge was about three months before husband died.

O. A. Lee, who lives on the Davis farm, at Silverton, testified to the finding on the farm of the bucket. Purdy worked for Dr. Davis on the farm, prior to my taking possession of the premises on April 1st. The witness was not cross-examined.

Miss Maggie Coleman said she had been acquainted with Clyde Ramsby, with whom she kept company, for some time. Testified that in Silverton, last January, Ramsby (Clyde) asked if she had heard anything about the three boys being charged with stealing money. Did not remember what the Ramsby told me at the time. But when shown a written statement and affidavit that she gave the district attorney, the mind of the witness was refreshed, and she said that Clyde told me that Purdy and Roy Ramsby came to him (Clyde) and asked him if he wanted to make a stack of twenties. He told me they went, but did not state that they got the money. Witness became forgetful again, and after a fifteen minutes' heated controversy between opposing counsel, she continued: "He told me he was to stay at home and do the chores while they went for the money." Witness further testified that Clyde told her the man that had the money had died, and the money belonged to some relative of Purdy's. The witness seemed an unwilling party for the state, and it was only by strict questioning of the witness that the testimony was adduced.

tion of the date set by your honor for the presentation of claims, I will recommend that they be received, and treated as are the other claims of like nature.

In reference to the interest-bearing certificates of deposit nearly all of the parties presenting claims for such are claiming interest upon said certificates upon date of issuance. The certificates vary in length of time, some being only for a few months, others being for one year.

With the exception of the variations and corrections mentioned herein, the claims, as presented and reported by me June 9, 1932, agree with the books of Gilbert Bros.

The total amount of claims presented, including those after date set for presentation, amount to \$106,852.98. This is exclusive of most of the interest upon the interest-bearing certificates of deposit.

The amount of cash in my hands July 1, 1932, was \$10,111.30.

The claims of Lawrence and Mac Hofer, Ralph Matthews, Ernest Bean, Marguerite Wilson and E. A. Arrington, herewith, CLAUD GATCH, Receiver.

Receiver Gatch was seen by a Journal reporter, and while he declined to give any statement as to what the bank is liable to pay out, he was inclined to be cheerful about the matter. It is suggested by such as have had reasonable opportunity to learn, that the creditors will probably receive somewhere from 50 to 70 per cent of their claims.

The report shows the aggregate claims to be \$106,852.98, while the cash on hand is \$10,111.30. Of course there are other assets, and most of the preferred claims have been settled with collateral.

JANES RETURNS HOME

Believes Tracy is Still in Washington

Preacher Who Saw Tracy the Day Before the Break

J. T. Janes, first warden at the state penitentiary, who has just returned from a trip to Seattle, says there is not the slightest question in his mind but the convict Tracy is still in the vicinity of Seattle, and that his capture will yet be accomplished by the firm believes. Sheriff Cuddehe, of Seattle, and the officers of Tacoma are of the same mind, and Mr. Janes reports that a quiet and systematic search is being made for the murderer. Besides a large number of men who are guarding the mountains on either side of the supposed hiding place of Tracy, a number of detectives are working on the case.

It was reported at the time Mr. Janes left Salem, when his destination was not known to other than the prison officials, that he had been called to some point in Washington for the purpose of identifying some person that had been placed under arrest for Tracy, or that another dead body had been found that also required his services for identification purposes. But these surmises were all without foundation. It is learned that Mr. Janes was called to Seattle for consultation with the officers that are prominently continuing the search for the fugitive convict.

Rev. A. S. Orne, a traveling missionary who saw Tracy in the prison Sunday before the break, will be remembered as having visited this city about the time of the break from the prison. An exchange has the following account of Rev. Orne's visit to the Oregon penitentiary:

Rev. A. S. Orne, who has been touring the country in a gospel wagon for the past six or seven years, and doing much good work among the inmates of prisons, jails and other institutions of that character, was in town today, looking up his old friends. Mr. Orne is well known in this city and state. He formerly held pastorate in Box and Wentworth, and at the conclusion of the latter he entered the evangelistic field, and inaugurated his work among the inmates of the jails and almshouses in this state. About ten years ago he went to Syracuse, N. Y., where he outfitted his gospel wagon. Since that time he has traveled over 40,000 miles, has used up eight horses and five mules, as well as two wagons. In the time he has visited 42 states and territories.

Mr. Orne has many interesting experiences to relate, and the signed documents which he carries with him tell of the good which he has accomplished. He was in the Salem, Oregon, penitentiary the week before Tracy made his escape. Of him Mr. Orne says: "Following my address to the prisoners I was accorded the privilege of going among them, and I met Tracy, and had a talk with him. He was a nice looking fellow, quiet in demeanor. He did not look like a desperado, and I am confident that the spirit of bravado which he has shown in his fight for liberty was put on after he left the institution."

"On the other hand, Merrill, whom I also met, was a typical criminal, and I should look for him to do such deeds as have been accomplished during the flight, instead of the other man. I am confident Tracy is not the right name for the much-sought-for man, and I am also sure the authorities will never capture him alive."

The three bicyclists who have terrorized Salem, Colburg and other small towns in the valley, arrived in Eugene yesterday, and were found to be peaceable citizens en route for Southern Oregon. Down at Salem they thought it was Tracy and a gang who would try to break into the penitentiary to prevent such a catastrophe extra guards were placed around the penitentiary, policemen and citizens of that city being warned to keep away, or run the risk of being shot. When the men arrived in Eugene, a life insurance agent, always ready for business, sought out the man he thought was Tracy, and wanted to write him a policy, because he considered him the best risk in the country. He was disappointed to find the man just an ordinary risk, and not Tracy at all.

TEACHER VERSUS DRUGGIST

Martha Claims David Had Agreed to Marry Her

She Appraises Her Injured Feelings at \$6750

Martha Wilson, a school teacher of the Stayton neighborhood, has brought suit for breach of promise against David B. Smith, a druggist of Stayton. Judgment is asked for general and special damages in the sum of \$6750. Kainer & Slater, of this city, are the attorneys for the plaintiff.

In her complaint she alleges that on December 27, 1931, herself and the defendant became engaged, and that it was mutually agreed that they should be married during the summer or fall of 1932. But the defendant, it is alleged, did not wait for the time to expire, but on July 6th notified the plaintiff that he would not at any time marry her. This gross unfaithfulness, and on the part of her alleged lover, and the further fact that he is reported to be engaged to marry another young woman of the neighborhood, naturally made the fair plaintiff indignant, and she was determined that it is but right that her alleged heartless sweetheart should compensate her for her injured feelings and the mental anguish she has experienced since he notified her that he would not be hers.

In consequence she demands general damages to the amount of \$2000. In the complaint the disappointed school teacher alleges that, with the prospect of becoming married, in fulfillment of the agreement between herself and defendant, she failed and neglected to make any contract for teaching school for the school year of 1932-33. In this relation she claims her services are of the reasonable value of \$40 per month, and on this account she prefers a claim of \$250. The refusal of the defendant to live up to his part of the contract has resulted, so the plaintiff asserts, in injury to her health, and great mental anguish, for which she seeks to recover \$500. The case will come up for trial before Judge Burnett at the October term of the Marion county circuit court.
