AFTER LONG PURSUIT

How Sheriff Withers, of Lane, Captured Heaton.

Alleged Murderer of Junction City Saloon Man

The following account of the capture by Sheriff Withers, of Lane county, of Bert Heaton, the alleged murderer of Ben Tracy, the Junction City saloon man, has been published: "Probably the best piece of detective work that has been accomplished by an Oregon sheriff was the capture of Bert Heaton, alleged murderer of Benton Tracy, of Junction City. The credit for the discovery and capture of this man is entirely due to Sheriff W. W. Withers, of Lane county, who is noted for his persistence in following criminals and skill in locating them.

"To begin with Withers had not the slightest clue to work on. The murder was committed in a saloon in Junction City, shortly after midnight, May 20th. The sheriff went to the scene as soon as possible, but could find no clue, except that a gambler had been in town a few days before, but on that morning could not be found. He had registered at the hotel on arrival as Bert Ray. While in Junction City he had spent much of his time about the saloon, and it was evident that he had little money, and had been playing in hard luck. Stories regarding the man were conflicting, but the sheriff soon concluded that he was the man he wanted. But he could obtain no satisfactory description, and was working in the dark.

"Without making known his plans, Withers went down the valley, searching through all the important towns, and spending a couple of nights in Portland. Finding nothing in this direction, he returned to Eugene, and soon thereafter started south. He worked from place to place, keeping his keen eyes and ears open for the slightest clue upon which to work. Finally he thought he found a slight hint indicating that the man probably hailed from California, and gathered points from various sources which led him to guess that his quarry had been at Kewick, not far from Redding. He telegraphed the constable there that he had a warrant for a certain man, describing him as best he could, and asked him to arrest the man if he could be found.

"Luckily the man was known there, but could not be found by the officer. Then Withers obtained a picture of Ray and started with renewed energy on the hunt. He went to Redding about June 20th, and found that his man had been there a short time before, but had disappeared, and nobody knew in what direction he had learned the man's true name was Bert Heaton. He now had the picture and now had the name, but the slightest knowledge of the direction in which to proceed.

"Sheriff Withers next went to San Francisco, but finding nothing returned to Sacramento and thence back to Redding and Kewick. Still he had no idea which way to look, but started eastward along the railroad, stopping at Truckee, Reno, Carson City and other towns. Then he went down through southwestern Nevada, across the desert, and visited the new mining camps in that region. Finding nothing, he returned to Reno, and started his search eastward. Soon after leaving Reno he gained what he thought to be a clue. This he followed from place to place, and he was satisfied he was following the correct trail. Finally, on the morning of July 18th, he saw his man on the streets in Wells, Nevada, and at once felt repaid for his chase.

"Seeing his quarry, he did not rush upon him, but followed him until he entered a barber shop. Then to make more certain he stopped and interrogated a barber near by, and was thoroughly convinced he had the right man located. Heaton took a seat in the barber chair, and the barber proceeded to lather his face for a shave. Just then Withers created consternation in the shop by stepping in and thrusting a pistol in the face of the man in the chair, at the same time grasping him in such a manner as to prevent him from using the weapon in his pocket. The prisoner took the matter philosophically, and in a few days Withers had him securely locked in a cell in the Lane county jail.

"In this case, as is his custom, Mr. Withers has done his own work. He called nobody to his assistance, and made known to no one what he was doing. He is entitled to the sole credit for the success of his chase, starting with nothing, and in so short a time landing his man."

Interesting Controversy Over Musical Instrument

City Officers Have Taken Charge of Property

There is an interesting controversy on in Salem over the ownership and possession of a fine piano. The difference of opinion exists between a local music dealer and an alleged contracting purchaser. Both sides have engaged lawyers, and a real interesting legal scrap is probable before the controversy is finally adjusted.

One day this week the music dealer, who figures in the case, concluded a deal for the sale of a piano. The terms of the agreement are not known. During the day he sent the instrument to the home of the supposed purchaser. The next morning another drayman drove up to the dealer's place of business and was in the act of unloading the identical piano on the cement pavement in front of the music store, when the dealer remonstrated. The drayman was not looking for a piano either, so he asked permission from the proprietor of another store to leave the boxed piano on the walk in front of his store for a few minutes. The request was granted, and when the instrument was deposited on the cement walk, the teamster drove away with a pleasant smile of satisfaction of having at least disposed of the instrument that he never did intend to return and get.

The orphan piano remained on the walk until late in the afternoon, to the objection of pedestrians and the aggravation of the merchant, a view of whose wares in the show window was obscured by the large box. Finally his patience became exhausted, and he complained to the city authorities who, upon failing to find anybody that would claim the instrument, loaded it into a dray and had it taken to the city hall, where it will probably remain for safe keeping until it can be learned whose piano it is.

The annual report of George Bethers, county superintendent of schools in Lincoln county, has been filed with State Superintendent Ackerman. It shows a slight increase in school population, this year's census showing 1230, as against 1225 one year ago. The number of legal voters in the county has decreased from 823 a year ago to 855 at the present time. The receipts for the year were \$11,568.61, and the disbursements were \$10,162.19, showing a big increase over the preceding year, when the receipts were only \$8305.32, and the expenditures were \$6825.11. The average monthly salary paid male teachers has decreased in a year from \$40 to \$36.60, while a slight increase is noted in the wages paid female teachers, who this year received an average monthly salary of \$25.93, as against \$25.51 a year ago.
