The following account of the golden wedding anniversary of Mr. and Mrs. Joseph Cooke, pioneer residents of this city, appeared in a recent issue of the *San Francisco Chronicle*.

"Mr. and Mrs. Joseph Cooke celebrated their golden wedding Monday evening, August 4th, at their residence, 1760 Howard street. Mr. Cooke is a descendant of Francis Cooke, who came over to America in the Mayflower. He was born in Jefferson county, N. Y., in 1825; moved to Ohio, where he was educated in Oberlin college, and emigrated to Oregon in 1851, settling in Salem. He was married in 1852, in Portland, Or., to Miss Isabella Walker, a native of Meriden county, Conn. The couple lived in Salem over 40 years, and came to this city six years ago.

"For the reception the residence of Mr. and Mrs. Cooke was cheerfully decorated, and the ladies of the Third Congregational church prepared the supper, which was a feature of the occasion. Many beautiful presents came from relatives and friends. Musical numbers were contributed by Mr. and Mrs. Gaylord Cooke, Will Hyde, Professor W. J. Neldig, of Stanford University; Dr. George Bushnell and Robert Collier.

How Lithuanians Play Dice.

A peculiar dice game is indulged in by the gambling element of Lithuania in Baltimore.

Gathering about the dice tables in the saloons kept by their fellow countrymen they quickly lose all interest in everything outside of that which is transpiring upon the cloth before them. As they sit or stand about the tables the careworn features of old men contrast strongly with the rosy cheeks of the youths. The eagerness with which the players seek the numbers upon the falling pieces is worthy of its intensity. Comparatively small sums are placed upon the game, and side bets run from 5 cents to \$1.

Although resembling in the manner in which it is operated the high dice game as played by the Anglo-Saxons, in the dice of the Lithuanians, instead of numbering from 1 to 6, run from 1 to 10, the numbering of the six sides being 1, 2, 3, 4, 5, 10. The game is played with four pieces, and a possible 40 is the point striven for instead of 24, which is high mark in the similar American game.—Baltimore Sun.

TRACY WORKED FOR HIM

Notorious Criminal Was Employed by Farmer

In State of Washington in the Year 1896

B. F. Curtis, of Marshall Junction, for whom Outlaw Tracy worked several years ago, was in the city yesterday and talked interestingly of his acquaintance with the bandit, says a Spokane paper. Mr. Curtis said:

"It was about the last of May, 1896, that Tracy came to my house and asked for work. He said he didn't want to work very hard, as he was only waiting for some important mail, and merely wanted to hang about the place, and do odd jobs until he got his mail.

"When I asked him what his name was he wrote it out for me. He spelled it S-e-v-e-r-e. I asked him how he pronounced it, and he said I could pronounce it any way I saw fit. Afterward, however, he told my daughter he pronounced the name Severna.

He acted suspiciously.

"When I told Tracy that we sent a man to the postoffice for our mail every day, he said that wouldn't do; that he had to get his mail himself. That made me rather suspicious, but I said nothing about it. He worked helping me set the engine in my mill, and also worked out my road tax for me. Every day he would go to the postoffice for his mail.

"So far as I know he never received but one letter while he was at my house. That letter he showed to my daughter, after tearing the signature off. He said it was from a widow woman who lived near Snohomish.

The letter was addressed to 'Dear Billy,' and urged him to come back. The writer said she couldn't live without him. He told my daughter, however, that he didn't care for the woman any more.

"After staying at my house for about 12 days he said that inasmuch as he had not received the mail he was looking for he would have to leave. I never heard of him until this tragedy came up, and I saw his picture in the papers. I recognized the picture at once, and was doubly sure when the papers said his right name was Severns.

Believed Him a Murderer.

"The day he left my house he tried to sell my boy a gold ornament. He also showed the boy a considerable quantity of other jewelry. The boy didn't tell me about it until after the man had gone. The papers had been full of the mysterious murder of a jewelry peddler on the Sound a few weeks before the man came to my house, and that led me to believe that my workman was the man.

"Tracy was a good mannered man, and was able to work. He had considerable skill and intelligence as a workman, but possessed some of the instincts of the hobo. He wouldn't work if he could get out of it. He seemed to like to do chores around the house and help the women, but he kept out of hard work when he could.

"Today I saw a picture of him that was taken in the morgue at Davenport. I recognized it even better than I did the pictures in the newspapers. I haven't the slightest doubt of the man's identity, and neither has my family. I didn't take much stock in the story that the man was unfamiliar with this section of the country. I think he knew all about it; but he had been away from here several years, and did not know how rapidly the Big Bend country, through which he tried to escape, had settled up."

FINISHED EXPERTING RECORDS

Examination of Accounts of County Officers

Will Be Finished This Evening By Clark & Buchanan

He will then be joined by Mr. Clark, and together they will leave for Baker and Union counties, in Eastern Oregon, where they have the contract for making an expert examination of the records of those counties.

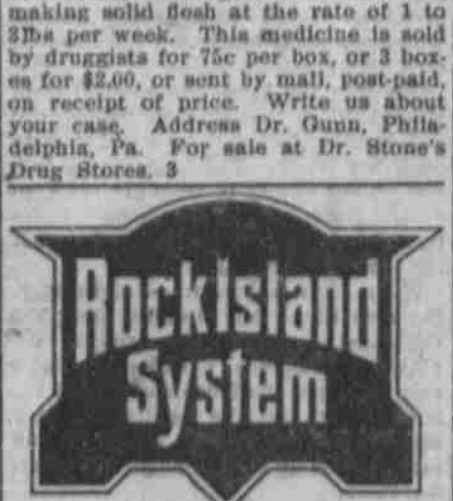
