To Be Laid Tuesday Morning

The laying of the corner stone and dedication of "Mitchell Hall," at the Chemawa Indian Training School, alias U. S. Indian School, alias Harrison Institute, but officially known in the department of the interior as Salem Indian School Tuesday morning at 9 o'clock will be a great event, locally. There will be a large delegation from Salem, who will drive down with teams and go via the 8 o'clock train—Albany local—and return on the 11 o'clock train.

At Chemawa Tuesday.

A dispatch received from Mr. Hermann this morning says he was unavoidably detained at Roseburg, and in consequence will not arrive here until the morning train Tuesday. We are requested to state also, that the fare to Chemawa, round trip tickets, will be 25 cents. The railroad company will have cars enough for the accommodation of all desiring to attend the exercises.

Headquarters at Eugene.

Eugene has been selected as headquarters for the Democratic campaign. Chairman Sam White will proceed to that town within 10 days, and there abide until the returns come in next June. Richard W. Montague, of Portland, is secretary of the campaign, but will not act in person, as he remains in Portland. Chairman White has appointed John E. Lathrop as assistant secretary and press agent for the campaign, and Lathrop will accompany White to Eugene. This means the congressional fight will be conducted from the Democratic camp by the same people who managed the state campaign last year. Direction of the campaign is left in the hands of Chairman White, as it was last spring, and the congressional committees will have charge of their respective counties, acting in conjunction with the county central com-

mittees. By this method the Democrats can pick up their party machinery where it was laid away a year ago, and thus give them a well organized corps of workers in every county in the district.

Sick in San Francisco.

Assistant Superintendent Campbell, of the Salem Indian School, has received the sad news that among the victims of the typhoid epidemic at Stanford University is his son, Donald. Mrs. Campbell has gone to be at his bedside, and finds the young man with friends at San Francisco. She telegraphed this morning: "Donald has typhoid. No immediate danger. Doing nicely."

Mr. Hermann will attend the meeting of the Young Men's Republican Club in Salem Tuesday evening, where he will be given a cordial welcome by the Marion county stalwarts.

Will Race In Ireland

Garden City, April 20.—J. Moore, of Cleveland, and Percy Owens, of New York, have been chosen, with Alexander Winton, to represent America in the world's championship automobile race in Ireland, July 2d. They were chosen as the result of a race run early this morning, starting at 5 o'clock. Owens made five miles in 5 minutes and 25 seconds, the fastest mile in 1 minute and 2 seconds. Moore's time is not announced.

Cumberland, Md., April 20.—There is considerable excitement over the discovery of silver in Frostburg. The find was made while opening some Be-clay banks. Professor Rutledge, geologist of the Johns Hopkins university, has visited the mine and assayed the ore, and he declares paying quantities exist. The mine is in the heart of the coal regions.

Must Be High-toned

Indianapolis, April 20.—President Parry, of the Manufacturers' Association, arrived here yesterday. He says he has no desire to oppress the workers of the country. No assault was made on orderly trades unionism. If the unions want to carry on a contest on high-toned and lawful lines, the employers of the country would be glad to meet them on that basis. He says the country could then resolve themselves into a vast, industrial army, and there would be no hitch in our advance toward a complete commercial supremacy. But we do not propose to have the United States placed in the clutches of that dreary, obstinate, vicious sort of trades unionism which has England by the throat. Hanna certainly made a true expression when he said the trades unions of this country need Americanizing.

The movement in this country today, continued Parry, is in the hands of foreigners of strong socialistic and anarchistic tendencies, and their leaders are doing everything in their power to start a rebellion against the United States government.

Frankfort, Ky., April 20.—The cross-examination of Howard this morning has so far failed to elicit any lateral contradictions.

Engineer On Trial

New York, April 20.—Locomotive Engineer Wisker, who was in charge of the engine of the White Plains local train, which collided with the New Haven local in February, 1902, when 17 were killed, was brought up for trial for manslaughter in the second degree before the criminal branch of the supreme court this morning. He looks ill and emaciated.

And Stocks Went up

New York, April 20.—Securities stock took a jump from 94½ to 98 immediately when the news of the St. Paul suspension of the injunction permitting May dividends was announced. Wall street was surprised.

William Hearn, as administrator of the estate of Harritt Mangan, deceased, respondent, vs. Rachael Lottitt, appellant; from Multnomah county; Alfred F. Sears, Jr., judge; reversed and remanded; opinion by Justice Bean.

State of Oregon, respondent, vs. Frank McCann, appellant; from Josephine county; H. K. Hanna, judge; affirmed; opinion by Chief Justice Moore.

A RICH FIND OF COYOTE

Queer Product Found by Baker City Miners

Repeal of the Scalp Bounty Destroyed its Value

An amusing but almost serious incident occurred near here this afternoon, while a party of prospectors were inspecting an old mine in the hopes of its rehabilitation. The boys were making an effort to determine whether any values existed in the old property, and while doing so underwent an experience they do not care to repeat.

Early this morning William Lummis, of Baker City; Kanaka Sam and John Younger, of Sparta, started out to inspect the old mine, which lies a short distance from here on the Powder river slope. They had to go down a shaft 60 feet and then traverse several cross-cut tunnels. Lummis and Sam went below, Younger stayed at the mouth of the shaft to aid his companions in their descent and look out for danger. Reaching the bottom of the shaft Lummis led the way into one of the tunnels, and shortly ran up against a nest of six young coyotes, with the mother beast presiding. A fight began at once, the old coyote making a pass at Lummis with her paws, striking him on his Elk's badge, which saved his life. The Kanaka ran from the shaft, and just then the candles went out, as the infuriated coyote grabbed Lummis about the abdomen. After a short struggle he escaped her clutches, and the animal ran out, and by some means reached the mouth of the shaft, where she was shot by Younger. All three men returned with whole skins, but badly shaken up over their experience.—Baker City Democrat.

GREELEY'S REVENGE.

Outcome of the Editor's Tiff With Elizabeth Cady Stanton.

The late Elizabeth Cady Stanton was particularly apt at retort, and one of her swift parries of a thrust delivered by Horace Greeley against her favorite doctrine of woman suffrage is historic. "Madam," said Horace one day during the civil war, "the ballot and the bullet go together. If you want to vote, are you ready to fight?"

"Certainly, sir," she responded, "I'm ready to fight, just as you are fighting, through a substitute."

Notwithstanding their differences of opinion, Mrs. Stanton and Greeley were personally friendly until the New York constitutional convention of 1868. A woman suffrage clause was strenuously pressed upon that body and as vigorously opposed by Mr. Greeley. One day, after the Tribune editor had made some particularly rasping remarks upon the subject, George William Curtis rose and said:

"I have the honor, Mr. Chairman, to present a petition in favor of the woman suffrage amendment signed by Mrs. Horace Greeley and 300 other ladies."

Greeley was furious and rightly ascribed the appearance of the memorial at that moment to Mrs. Stanton.

"Why did you not put my wife's maiden name on that petition and call

her Mary 'Cissney' Greeley?" demanded the next time they met. "Because," said Mrs. Stanton, "I wanted all the world to know the Horace Greeley's wife protested against her husband's report on the suffrage amendment."

"All right," retorted the editor, "Hereafter you shall always be spoken of as the Tribune's Mrs. Henry B. Stanton." And so it was to the time of her death, although the name of Elizabeth Cady Stanton was known to hundreds of thousands who could not identify the woman by the appellation under which the Tribune, for revenge, tried to obscure her fame.—Pittsburg.

POLITENESS IN JAPAN.

Even "Giving Notice" Is Made a Lesson of Compliments.

Politeness distinguishes the relations between hostesses and male visitors in Japan. It is so inexpressible in Japanese, even the ceremony of "giving notice" is turned into an occasion of compliments. There are no vulgar threats or sulking or recriminations or sulks or "muzzling back." A man will never tell his mistress that he is dissatisfied or has had some unpleasant place offered her. That would be a pardonably rude. Instead she is for a few days' leave of absence. It is willingly granted, for Japanese men have no settled time for their holidays.

At the end of the given time the mistress will begin to wonder what has come of the girl. She is not left wondering long. A letter arrives containing the most polite and humble thanks and giving an excuse but the real reason is that she is too weak for service. Sometimes it will be that she is found herself too weak for service, that illness at home detains her. Whatever it may be, the plea is never tested, but accepted as final and a servant engaged. Then, after a few weeks have passed, very likely a taking a fresh place, the old servant will turn up one day, express thanks for past kindnesses and regret at not returning in time, will take arrears of wages and her bundles disappear forever.
