Cannery Getting an Immense Pack of Early Cherries

Southern Editors Will be Given Samples of the Salem Fruit Products Tomorrow

The Salem cannery is putting up an immense pack of early cherries. The supply of strawberries fell off the past two days, and there is some complaint of members of the Union selling cannery stock to the retail trade.

Shipments to Portland are falling off, and next week will pretty near close out the shipping business.

The weather forecast for Sunday is fair and warmer, and the later cherries will be hurried along under favorable conditions, with not much prospect of rain. The showers predicted for Friday did not come off, and the skies indicate settled weather.

An editorial excursion goes through Salem Sunday afternoon, and President Thielson, of the Push Club, has appointed a committee to meet the editors before arrival at Salem, while on their departure they will be presented with two crates of the finest Salem strawberries, and two crates of the finest cherries, which have been ordered from the Fruit Union.

The Salem Fruit Growers' Union have planned for a picnic, to be held next Saturday, June 27th, at the Lincoln school grounds, in South Salem. Noah Welch, Andrew Varrier and Grove Hensley are appointed a committee on program. It has been suggested that a social reunion would be a nice way for all members of the Union to meet and get acquainted, have a picnic dinner, and short program from 1 to 2 o'clock, and have plenty of time to do their trading and get home early in the evening. Details will be made known next week.

She Passes Away at the Salem Hospital

Former City Superintendent of Schools, Literary Devotee and Club Worker

One of the most prominent club women and worker in all fields for the advancement of women is dead.

Mrs. Serella Miller, wife of Col. R. A. Miller, of Oregon City, passed away at the Salem Hospital, at 11:30 o'clock Friday night. She was operated upon Thursday morning and was unable to withstand the shock. She lingered between life and death until last night, when, at the hour named above, she quietly passed away. Yesterday morning she began to fail rapidly, and her relatives were summoned, a number of whom were at her bedside when the end came.

Mrs. Miller was a daughter of Mr. and Mrs. L. C. Griffith, of the Waldo Hills, and was born in Marion county, in 1859. Besides a husband, father and mother, she leaves four sisters and three brothers, Mrs. G. A. Peoples, of Weston; Mrs. A. W. Giesy, Mrs. L. H. McMahon, Miss Jennie Griffith, Dr. L. F. Griffith, Dr. J. C. Griffith and Carl Griffith, to mourn her untimely death.

Mrs. Miller was for several years city superintendent of the Salem schools, and had a wide circle of friends, who will be grieved to learn of her death.

The funeral service will be held at the First M. E. church tomorrow, Sunday morning, at 11 o'clock. Mrs. Hallie Parrish-Hingee will sing. After the services at the church, the body will be taken to the cemetery near the Griffith homestead for burial. It was Mrs. Miller's request, just prior to her death, that Prof. Hawley conduct these services and deliver the memorial address.

A friend pays her this tribute: In her, the estate of womanhood found full justification. Hers was the noble life, full of usefulness and beauty. In the activities that engaged her attention she was the leading spirit, honored and revered. She was the first president of the Native Daughters of Oregon, a prominent member of the Order of Eastern Star, and for many years city superintendent of the Salem schools. Many other places of distinction she held also. In later years, she was known because of a wise and scholarly knowledge of Shakespeare, and for a sound interpretation of his profound meanings. Sweet graces of speech and courtesy distinguished her strong personality. Having joined the Methodist church of this city at about the age of 18, she remained an earnest Christian. All who knew her will lament her loss with a grief that will abide the years. Grateful for the sorrowing heart is the memory of her goodness. No doubt marks the solemn hour. Of her now the greatest certainty exists. A character so strong, and individually so wholesome, a student so earnest, a life so useful, and a piety so sincere, can find full development only in the greater kingdom of God.

Question of Queen Solved Monday at Midnight

Baby Show, Automobile Race, Prominent Officials Who will Preside and Other Features

As is the case with all enterprises like the Salem Carnival, the rush and volume of work, the great detail incident to such affairs comes to the surface during the last few days. The Carnival committee has thoroughly attended to all of its preparations and is in a position to dispose of nearly all of the prominent features of the preparatory work so that they will be ready for the rush of business that may come next week. The grounds have been laid out and fenced, the band stand is receiving adornment at the hands of the painters, and by next Wednesday all of the business details of the Carnival will have been completed. The question of Queen will be solved by midnight Monday, and it is expected that Sunday and Monday's vote will be something huge. The reservation made by the friends of the various candidates will be brought forth on Monday and result in an immense vote. The committee will then know just who the honor has fallen to, when the final preparations for her costume, reception and coronation will be undertaken.

The Salem Carnival, aside from the Salem beauty who will preside as sovereign queen, will be notably distinguished by the people who contribute to its inaugural. The festivals will open under the happiest possible auspices, and nothing will be wanting but some delightful June weather, which is just as probable as anything else. There is a notable look of determination and of pride observed on the faces of many of the young mothers of Salem. Just now, induced no doubt by the fact of their possessing likely candidates for the honors at the baby show. This event will be one of the best and loveliest of the week. The judges are all bachelors, and consequently disinterested. All who have consented to act as judges have bought long distance tickets and will leave the city on the night train to be gone from Salem until the disappointment shall have exhausted itself.

The races provided for, as between automobiles, motor-cycles and bicycles, is creating marked interest throughout the city, and the three events will probably be made the most notable of the week. The chauffeurs in the automobile race have not yet been named. The general prices of admission to the Carnival shows will be 10 cents in each instance, except in case of the glass blowers' establishment, where it will be 15 cents, the additional five cents being compensated for by the souvenir given to every visitor.

The Wilson avenue site, where the Carnival will be held, will present a lively and interesting sight. The ground to be covered by tents and other auxiliaries of the festival, aggregating 19,000 square feet, and running from State street to Court through the avenues. There will be nine tents, the largest of which is 100x210 feet, the lesser tents being of the ticket department.

Manager Bureau of the ticket department will make thorough arrangements to control the situation, and handle the patrons of the fair courteously and comfortably.

The committee will police the grounds day and night, and will maintain good order at all hazards. Every convenience will be supplied for the public, and nothing will be left undone to make the Carnival a general success. All applications for space or privileges of any sort should be made to the general manager, N. J. Judah, or to Manager M. L. Meyers, and no delay should be allowed in the prosecution along these lines. One happy feature of the Carnival, as it is located, is the momentary car service to be had at the gates. Manager Springer will provide a special Carnival schedule that will give quick and constant car service to people from all parts of the city, day and night, and his company will also see that nothing is wanting in the way of brilliant electrical effects, when the sun shall have ceased to furnish light.

Found in
the Columbia

Carson, Skamania County, Wash., June 20.—Sheriff John T. Tott and P. E. Mitchell, justice of the peace, were notified Thursday morning that the bodies of a woman and a boy had been found cast ashore at Carson Landing on the Columbia river. The bodies showed signs of having been in the water for at least three or four days, and were somewhat mutilated. This leads to the belief that they are the remains of victims of the Hoppner disaster, carried away with the current, which is flowing rapidly at this time. Should this theory prove correct, then it is possible that many other bodies will be cast ashore in the near future. In order to reach this place the bodies had to float nearly 100 miles. Reports of bodies washing ashore at various places along the river are coming here, but they cannot be confirmed.

MEETING

Christian Missionary Convention Began Friday

The Attendance is Very Large and a Profitable Assembly is Assured

Turner, Or., June 19.—(Special to Salem Journal).—The Oregon Christian Missionary Convention opened its sessions today at 9:30 a. m. with the program of the Ministerial Association. The attendance is large for the first day, and new campers are continually arriving. The grounds are as fully occupied as on previous occasions at the opening. The ministerial program opened at 9:30 a. m. with a praise and prayer service conducted by A. R. Davis, of Indianapolis, Ind., and W. L. McIlvaine, of Eugene, Or., respectively.

Geo. C. Ritchey, of Salem, vice-president, presided over the morning session. The following committees were appointed: Press, Harry Benton, of Elgin; Clark Bower, of Albany; Marion Green, of Eugene. Nominating, J. S. McCallum, of Eugene; Allyn Esson, of Portland; J. B. Holmes, of Albany. Program, Prof. D. C. Kellem, of Eugene; G. S. O. Humbert, of Corvallis, and W. L. McIlvaine, of Eugene.

After the singing of a song, J. B. Holmes, of Albany, was called to the chair, and Geo. C. Ritchey addressed the convention on the important subject of "Ministerial Relief." Then followed an address by J. H. Holmes on "The Divorce Problem." These addresses were earnest and were strong in argument for the respective subjects, and both were well received by the convention. After a short session of song, the audience was delighted to hear the noted evangelist, Allen Wilson, of Indianapolis, Ind. Mr. Wilson spoke very fervently and pleasantly from the text Matt. 22:42: "What think ye of Christ, whose Son is He?" The morning session adjourned with prayer by J. S. McCallum.

Dr. J. F. Ghormley, of Portland, president, arrived on the noon train, and presided over the afternoon and evening sessions. Beginning with a song service, an interesting session was held until 3:30 p. m. and prayer by C. A. Sims, of Athena. The afternoon was given to the very important subject of Intemperance. W. A. Wood, of Eugene, who arrived too late to read his paper on "The Pastor's Relation to Partisan Prohibition" or "The Prohibition Party," had forwarded his excellent paper, which was read by G. S. O. Humbert, of Corvallis. C. A. Sims discussed the paper and the prohibition question in a general way. J. F. Jout, of Centralia, Wash., former Anti-Saloon League Secretary of Oregon, addressed the convention. He spoke frankly and declared himself as opposed to the prohibition party, but in favor of prohibition. The address was spoken kindly, and received in the same spirit by the assembled convention, who were mostly Prohibitionists. This address brought out several short talks in favor of the prohibition party, and it was plain that Rev. Tott was alone, or nearly so, in his attitude on the prohibition question. This discussion, while warm and earnest, was all in the spirit of Christ, and in kindest consideration of all. The evening service was opened with songs and prayer, and the audience was treated to another excellent sermon by Evangelist Wilson, who will deliver two sermons each day. The Ministerial Association continue their sessions throughout Saturday.
