GOOD FOR THE CROPS

Ideal Weather for Both Field and Orchard

Conditions Much Better Than a Month Ago and Valley Crops Will be up to Average

U. S. Department of Agriculture, Climate and Crop Bulletin of the Weather Bureau, Oregon Section, for the week ending July 14th:

General Summary.

The weather during the past week was favorable for the growing crops, as well as for haying, except that it was too cool for corn, and this crop is making slow advancement. Haying is now general, and notwithstanding considerable clover was damaged by the rains of the previous week, the hay crop bids fair to be an average one. Pastures are good, except in some southern sections, where the ranges are drying up and feed is becoming short.

Fall wheat continues to ripen nicely and in some few localities its harvest has begun. The crop is lighter than usual in southern Oregon and in the Grand Ronde valley; it is below the average in the Columbia river counties east of the Cascade mountains, but much better than anticipated a month ago. In the Willamette valley it promises to be as good, if not better, than the average.

Spring wheat continues to improve, and it is heading and filling nicely; the straw, as a rule, is rather short, but the heads are of good size and the berry promises to be plump and of a good quality.

Oats are doing splendidly and the crop will be above the average. Barley has a good color and the outlook is favorable for average yields.

Hops, potatoes, onions, sugar beets and garden peas have made good progress during the week, and but few complaints are made of damage being done by vermin or other pests.

Fruit continues doing nicely; prunes and pears are especially promising; apples are variable; in some localities the late varieties are reported good and the early varieties poor, while in other sections good crops are indicated for both early and late varieties. A few correspondents report only a half crop of both early and late apples, but, judging from all reports, it is believed the crop, as a whole, will fall but slightly below the average.

Willamette Valley.

Gresham Multnomah county.—First and last part of week rainy; fine and warm middle of week; hay cutting in progress; rain did a little damage to heavy clover; grain looking fine.

Rainier, Columbia.—Weather unfavorable for cutting hay; clover ready to cut; timothy beginning to bloom, crop from fair to good; early planted potatoes in bloom and promising; grain excellent, but the last heavy rains lodged wheat oats and peas badly; pears and apples dropped badly; early cherries a failure; late cherries will be ripe in about two weeks; black aphids infesting all cherry trees; raspberries, blackberries, strawberries and currants ripe; of good size and plentiful; pasture good; stock in good condition.

Tualatin, Washington.—Clover cutting in progress; fall wheat has been damaged some by the aphids; there is some blight on the onions.

Stafford, Clackamas.—Week was favorable to growing crops, especially potatoes and garden truck; clover was slightly damaged by the excessive rains the fore part of the week, but the past four days have been ideal for the making hay, which promises to yield well.

Darton, Yamhill.—Weather warmer; haying is in progress, the crop will be above average; spring grain is heading and looks well; corn is growing rapidly; potatoes and vegetables are making good growth; prunes, Bartlett pears and winter apples will be an average crop; early apples and peaches will be short; pastures good and stock looking well.

Folk.—Crops much improved by recent rains and warm weather; haying in progress; some clover hay has been damaged by the rains; spring sown wheat and oats are nearly up to average; potatoes and gardens are very flourishing; apple crop not quite so good as was expected; much fruit has fallen; prunes excellent.

Wells, Benton.—Week warm and favorable; fall wheat is filling well and yield promises to be up to average; prospect good for crop of oats; haying is well under way; clover damaged by

rain to a considerable extent; fruit promising.

Liberty, Marion.—Week warm and favorable; a great deal of hay cut; some hay injured by rains last week; grain is looking good and promises good yields; stock is doing fairly well; gardens making good growth; prunes promising large crop; corn growing well.

Crawfordsville, Marion.—Week warm and favorable for haying; crop doing well; cherry crop about gone; yields poor; chest and clover good crop; oats very good; pastures good.

Goldson, Lane.—Heavy local rains unfavorable for hay making.

GRINDS OUT A GRIST

Circuit Court is Right Down to Business

Hoenighaus who Passed a Worthless Check, Pleads Guilty and Went to the Pen Today

In the circuit court last evening the jury in the case of the State of Oregon vs. Clayton Bradley, on the charge of pointing a gun at B. Southwick, retired at 4 o'clock, and in a few minutes returned into court with a verdict of acquittal.

The case of J. W. Ransom & Son vs. E. M. McGinnis, an action to recover on a note given in payment of a carriage, was called at 4 o'clock. The parties are from Turner, and McGinnis and the McFarlane boys bought a carriage from P. A. Wiggins, giving a note in payment for a balance due, paying a part of the purchase price in cash. Later they returned the carriage. Mr. Wiggins turned the note over to E. M. Croisan, for whom he acted as agent, and Mr. Croisan, in turn, sold it to Ransom & Son, who sued McGinnis in the justice court. McGinnis secured a verdict, when plaintiffs appealed to the circuit court. The case was tried yesterday before the following jurors:

J. A. Pooler, Sam Helmsroth, R. H. Coshaw, Jerome Morley, Oliver Jory, H. A. Hinkle, G. A. Nye, H. A. Johnson, R. A. Crossan, L. M. Hicks, M. G. Minier, A. G. Jerman.

At 7:30 last evening the case was submitted to the jury, with instructions to return a sealed verdict, and at 9:30 o'clock a verdict was reached, which was delivered to the court this morning, finding for the defendant.

S. B. Hoenighaus, arraigned yesterday on an information charging him with obtaining money under false pretenses, by giving a worthless check to J. Conner, of the Hotel Willamette, came into court this morning, pleaded guilty to the charge, and, waiving time, was sentenced to the penitentiary for one year. He will be taken to prison this afternoon by Sheriff Colbath.

Emil Beler, the German, who pointed a rifle at Sanford Hammack, near Clear Lake, on last Friday evening, was arraigned yesterday afternoon, pleaded not guilty, and his trial will be set for some day this week.

The case of G. D. Trotter, plaintiff, vs. the Town of Stayton, defendant, is on trial in the circuit court this afternoon, before the following named jurors, and the case will take up the entire day:

T. M. Hicks, R. F. Cooley, James Winstanley, W. J. R. Jones, O. G. Savage, M. Cooley, R. D. Teter, M. J. Petzel, J. A. Pooler, G. A. Nye, W. H. Black, H. H. Spalding.

A large number of the citizens of Stayton are on hand to testify in the case, which is an action for damages, brought by the plaintiff against the town for unlawfully arresting and fining him for improving his property, when they claimed a part of it for streets.

One order was made by the court, as follows:

P. L. Frazier and J. M. Long, plaintiffs, vs. the Western Union Telegraph Co., defendant, damages; plaintiffs' motion to make answer more definite, and demurrer to part of answer filed.

Restored to Citizenship.

Governor Chamberlain today granted a restoration to citizenship of Joseph N. Barber, convicted of forgery in Baker county, and sentenced to serve two years in the penitentiary, which term of service he completed on June 29, 1933. Barber's restoration is based on good conduct while a prisoner, and his previous good record. Many prominent citizens, especially those of Baker county, petitioned the governor to grant the restoration, and give the young man an opportunity to make himself a name and place among good citizens.

The Linemens Strike Here

The strike of the linemen of the local telephone exchange has thus far caused very little embarrassment to Manager W. H. Dancy. Last Thursday his four linemen went out, leaving him without a man, but Bert Waller, one of the men, returned to work on the following day, and a new linemen was secured from Portland, and the two have been able to do all the

work required of them. Thus far the strike has been a very peaceful one in Salem, and it is supposed it will remain so until the tie-up is settled. Mr. Dancy says he can secure all the help he needs, and would put on more men if he needed them, but, under existing circumstances, he finds it unnecessary to add to the force at this time.

In some of the larger cities the strike has caused serious embarrassment, but this condition is one that is not expected to reach the smaller places, where a comparatively small force is employed by the telephone company.

Politicians and Mormons

Denver, Colo., July 14.—The local pulpits of Denver were Sunday occupied by visiting clergymen, delegates to the Christian Endeavor convention. Rev. R. J. Campbell, of London, preached at the Central Presbyterian church, and thousands who wished to hear him were turned away for lack of standing room. During the afternoon large meetings for men and women and boys and girls were held in the largest churches. A temperance rally was held at the People's Tabernacle.

Rev. A. K. Wright, of Boise, Idaho, created a sensation at a meeting at Trinity church by denouncing Mormonism, and declaring that the political leaders of Idaho and Utah and some other states had formed alliances with the Mormon church. He predicted that there would soon be seen a following of Mormons in the United States senate.

Shamrock's New Shirt Waist

EUGENE GETS WARM

Papers Give Roast to Umpire McCormack

Dis-interested Parties Recognize the Fact That he is Doing Good Work, Stopping Back Talk

The Eugene Guard in umpiring the matter between its team and Umpire McCormack, does not seem to take that impartial, fair-minded position it demands of the latter. This is the way it dishes up the Saturday and Sunday games:

The general result of the Willamette valley league games for Saturday and Sunday puts Eugene to second place with a clean margin. The margin should have been greater. Saturday's game at Albany was a partisan contest on the part of the umpire. He was unreasonable in all his decisions, and would not allow common questions to be asked him by the players of the Eugene team.

The great Jaw McCormack, of the Salem town, was this illustrious individual, and the manner of doing was almost the cause of his undoing. When the Sunday game was called there was a bunch of a hundred Eugene men, strong-muscled and determined to see that things were done on the square, watching the umpire for foul dealing, but behold! he saw them there, and gave the boys a fair deal.

At yesterday's game there was not the slightest disposition to act smart on his part. There would have been "something doing every minute" and most of it would have been the umpire.

How It Was Saturday.

The 12-inning game Saturday was a spectacle. On the occasion of a raw decision, Tim Shanahan asked the umpire if he meant the decision. "You get out of the game, and if you say any more, get out of the grounds," was his answer.

"We'll win this game under protest," said Somers to the Albany first baseman. The umpire thought it was something about him, so he benched Somers. He even ordered him to get out of the grand stand and sit with the players. At this jolly Somers tipped his hat, and McCormack said: "That's an insult. You can get out of the grounds." And Somers was denied the privilege of seeing the game.

With two of the best men out, Eugene held out for 12 innings. The game was protested, and Eugene has good chances to win.

Yesterday the contest in Albany was a pretty one. The presence of a crowd from Eugene made the umpire

Baseball Protests.
