THE BASEBALL SEASON.

Salem closes a successful baseball season, and the local management is to be congratulated on getting Salem into the list of baseball towns.

The winning of the pennant is a secondary matter, from a public standpoint, compared to the reputation of having a live community, and no American city the size of Salem is alive without baseball.

The Salem league closes the season with 900 worth of property, with the Western Oregon championship in their belt, and some money on hand. This is good business management.

The Salem team has always kept up to the demands of the game—of the teams they had to meet. Men were secured as players far in advance of their being needed, and thus the team played with great confidence.

For next year a longer season will probably be planned. This year's work was experimental. Salem had no team to start with, no players, no baseball enthusiasm, and no experience. All this has been gained.

Next season Salem will be in a stronger league. Probably the best towns in the state will unite with a Portland team, and while amateur baseball will not pay at Portland, the Portland team in the Oregon league can be played outside of Portland all the time to advantage.

Three games a week will be found to work better than two. A Friday game could be made to meet expenses. Additional interest would be created, and there would be larger crowds on Saturday and Sunday.

The Journal believes that it would be still better if the Sunday game could be cut out, but the general public demands the Sunday game. Too many people get no day off during the week, and want Sunday recreation.

ONE-DOLLAR WHEAT.

Wheat went up 10 cents in Chicago from the 26th of June to the 26th of July. The other day it went up two cents more.

There is a possibility of one-dollar wheat at Chicago before another month rolls around. There is a general appearance of a short crop. Of course that will never affect this section of the country. The everlasting creak on the wheat grower here is too tight and long-standing.

The clash in Western Oregon not only extends to controlling the market price, but the milling trust and warehouse trust have their grifts.

The wheat farming business is on the wane in Western Oregon, and growing clover and dairying are in the ascendancy.

Hog raising and converting clover crops into manure, after feeding them down with hogs, is a better thing than wheat under existing conditions.

The farmers in Western Oregon would be justified in raising no more wheat than they need for bread and seed. Raise more corn and clover.

Nevertheless, the country is interested in one-dollar wheat. It means great wealth for the nation's producers in the grain belt.

Foreign immigrants that will clear the land of stumps and grub out the roots is what Oregon needs. The average American immigrant will not do such work. He wants light, fancy farming and such immigration will not develop the rough lands and brushy hills of Oregon. It is not worth advertising for, so far as developing the state is concerned. The lands of Oregon need an hundred thousand European immigrants, with about 10,000 Chinese thrown in for fillers, in spite of all the howling of political demagogues.

SALEM TRADES UNIONS

Asked to Take up the Fight on Telephone Company

The Pacific States Telephone and Telegraph Company has by the Electrical Workers' Union (indorsed by the Central Union and Federated Trades Council) been declared unfair.

We ask you to help us by refusing to patronize the Pacific States Telephone and Telegraph Company, as the management of this company has always shown itself antagonistic to organized labor and an oppressor of the wage-worker.
