

PAYING FIFTY CENTS

Large Firm Believes They Will Get Cleaner Work

Reports From Several Counties and Market in New York and London Strong

The picking of this year's crop of hops is now under way in many yards in the valley, and will have commenced in all before the end of the week. Pickers have gone out from this city by hundreds and the camps at the several yards are beginning to assume a lively appearance, filled with a happy crowd, composed largely of families who are out, not only to earn money for the winter's needs, but to enjoy an outing as well.

The price of picking was, a few weeks ago, fixed at 40 cents per box in yards where the crop was a heavy one, and at 50 cents where the yield was light. Some of the larger growers, however, have raised to 50 cents per box, and it is believed that all of them will pay this price. H. J. Ottenheimer, who has 200 acres of splendid hops in Marion and Polk counties, announced yesterday that he would pay 50 cents, but that he would require good, clean work to be done. His crop will be a heavy one, and as his yards have been twice sprayed, there is no sign of lice or mould. He reports that pickers are plentiful and that the Oregon crop, estimated at from 75,000 to 80,000 bales, promises to be one of the most valuable ever produced in this state.

The Eugene Guard reports the sale of a crop of hops there on Saturday, as follows: "F. E. Dunn today purchased the heavy crop of Fuggio hops, the early variety, consisting of 35 bales, or about 7000 pounds, for 22 cents per pound. If this price keeps up the hop growers will have another prosperous year."

The Brownsville Times says of the hop picking near that place:

"The appearance of lice has caused some of the growers to commence picking a little earlier than they would otherwise have done. Louis Bond will commence picking in the Hausman yard next Monday; Jos. Hume will begin Wednesday; Moyer & Milligan will commence on Thursday. The price of picking has not been definitely settled as yet."

The Waterville (N. Y.) Times and Hop Reporter of August 21st says of local conditions in that hop district:

"We regret that we cannot say that lice have left the yards and that the vine generally looks clean and fresh. While this is true of some yards, since the hard rain of Wednesday, there are still others that do not get free from the vermin. Some of them have turned black and honey dew is quite prevalent. While there are a few yards this way, it is a source of encouragement that the majority are not thus affected. They may have a few lice, but the damage thus far is slight. With favorable weather a good many good quality hops will be picked. There have been no sales since Parks Terry sold his growth of 25 bales at 20 cents. Some of the growers of the early varieties are getting ready to begin picking next week."

The N. Y. Journal and Bulletin of August 20th says of the market:

"The first bale of 1903 New York State hops was received in the city on Wednesday. The quality was choice, and it was sold to the Bernheim & Schwartz Brewing company of New York City at 20 cents. The hops were shipped from Sherburne, N. Y. London cable advices report a firm and advancing market for Pacific Coast hops, and reported a sale of Oregon hops in transit to that market at a price showing an advance of 25 cents over the lowest figure touched on the recent decline. Continental markets continued to be reported as holding firm."

names are linked with the early history of Jacksonville and the Rogue River valley has passed away. James Cluggage McCully, death took place Monday at Fort Klamath, was a representative of a family who were well known in the pioneer days of Southern Oregon. His father, Dr. James W. McCully, and mother, Jane Mason McCully, came to Jacksonville in June, 1852. Dr. McCully at once identified himself with the progress of the town and in 1856 built the two-story brick building on Oregon street, which is now owned by the Odd Fellows. He afterward went to the Willamette valley, where he became prominent in operating steamboat lines, and died in Salem several years ago. Mrs. McCully was prominent in the social life and activities of this place from the early days to her death in June, 1899. Her life was commemorated by many acts of generosity and her charitable disposition.—Jacksonville Sentinel.

HALSEY IS REBUILDING

Recovering From the Effects of the Disastrous Fire Recently

From H. W. Ternan, who was down from Halsey today, we learn that the business men of that place are not asleep and that in a very short time that town will be in a better condition than it was before the fire. A joint stock company has been organized and will erect a two-story frame building on the old McCully corner, 5x85 feet in size. The two rooms below will be occupied by McCully, with his stock of general merchandise, and J. A. Cross, with a hardware stock. Upstairs there will be a hall and offices.

Caleb Gray is putting up a one-story building on the Gray corner. One of the two rooms fronting next the depot will be occupied by McWilliams, general merchandise, and the other by Ed. Ward, with confectionery and notions. Another room in the rear and fronting on the side street will be occupied as a butcher shop by T. P. Patton. The second floor will be a hall.

Another building, 20x40, is going up opposite Ternan's on Second street. It is being built by Debby Howell, and will be a restaurant.

Jonas Davis is building a two-story house on the east side of the railroad track, near the hotel, which he will conduct as a boarding house.—Albany Democrat.

G., are hereby ordered to report in the armory fully armed and equipped Thursday, September 3, at 6 o'clock a. m., for the purpose of leaving for camp at Gearhart park.

Each man will provide himself with sufficient toilet articles to insure comfort and cleanliness, a change of underwear and two pairs of socks.

An extra pair of stout black shoes may be taken, in case shoes issued by war department have not been worn a sufficient length of time to be easy on the feet.

Men will not be excused from attendance at camp, except in case of sickness or urgent necessity, and then only at the discretion of the commanding officer.

Excuses must be presented to commanding officer at the armory on or before September 2d to be of any use to men presenting them.

SALEM BUSINESS MAN DIES

Senior Member of a Former Well Known Plumbing Firm

Clement W. Knox, for many years a highly-respected business man of this city, died at Cascadia, Linn county, at 4 o'clock yesterday morning, after an illness of eight months, of consumption, caused by lead poisoning, aged 39 years.

Mr. Knox was a native of Peru, Maine, where he lived until 13 years ago, when he came to Oregon, locating in this city. He was a plumber by trade, and engaged in that work here, soon forming a partnership with Charles A. Murphy, and the two were associated in business until last winter, when Mr. Murphy retired, selling out to Mr. Knox. Soon after the health of the latter failed and he in turn sold the business, since which time he has visited several health resorts in the hopes of finding relief. About three weeks ago he went to Cascadia, growing gradually weaker until he passed away as indicated above. Immediately after death ensued, Mrs. Knox had the remains wrapped in blankets, there being no undertaker there, and engaging a team, brought the body to Salem, driving through to this city and reaching home about 9 o'clock last night.

Mr. Knox leaves a wife and one daughter, aged about 14 years. He was a member of Central Lodge, No. 18, Knights of Pythias, a past chancellor and a past grand representative; he also held membership in Central Temple, No. 11, Rathbone Sisters, and Oregon Cedar Camp, No. 5246, Modern Woodmen of America, in which order he held a benefit certificate for \$2000. He also held a policy in the Endowment rank of the Knights of Pythias for \$2000.

The funeral will be held at some hour tomorrow, not yet decided upon, and the Knights of Pythias will have charge of the services over the remains. **Knights Attention.**
