

THIEF IN BROAD DAY-LIGHT

Effort Made to Break into the Damon Store Yesterday

Young Man Seen While in Act of Removing a Window in the Rear of the Store Room

Effort was made yesterday afternoon, in broad daylight, to enter the store of Damon Bros., by the light of the moon, and the attempt was unsuccessful. About 4 p. m. yesterday afternoon, Mrs. Mattie Hutchins, who runs the store, heard a noise coming from the rear of the building that attracted her attention. Looking out through an upstairs window, she caught sight of a youth, scarcely more than twenty years of age, engaged in breaking the glass of the window on the north side of the rear door of the store. She at once notified A. O. Damon by telephone, but when that gentleman arrived the bird had flown, having evidently abandoned his attempt to enter the store after breaking through the window, as he was probably frightened away.

The store has four times been burglarized, and always through the rear windows or doors. At no time has anything been taken beyond what was in the till or cash register, and it is supposed to be the work of boys who were only after a little money.

The young man who was seen trying to effect an entrance in broad daylight yesterday afternoon, was clad in a gray suit and wore a cap. He was scarcely 16 years old, and he seemed to be carrying a lone hand at the game. The people who saw him are satisfied they will recognize him again, and it is therefore likely that he will be in the hands of the authorities within the next few days, when a term in the penitentiary will probably be his reward.

When the Damon store was burglarized before it was always done at night, but during the past six months a clerk has slept in the store, and this seems to have been known to the festive youth, who was after the money supposed to have been in the till, for he doubtless thought to find it easier sailing in broad daylight Sunday afternoon, than would be the case at night.

According to that king of logic Uncle Sam, who owns several billions, is not in debt because he has ample resources to meet the indebtedness. Nobody has claimed that Marion county was insolvent, but the records show that she was in debt to the tune of about \$75,000, and the records show that that debt has been wiped out. O. W. DUNBAR DEAD

Well Known Newspaper Man Died at Pendleton Friday

O. W. Dunbar, the editor of the Daily Guide, died at his home on Garden street this morning at 11 o'clock, after an illness of four months' duration, of Bright's disease and dropsy.

Mr. Dunbar was born in the Waldo Hills on the 6th day of March, 56 years ago. He spent his early days in the Willamette valley, and while a young man went to California, where he worked on the San Francisco Call. He remained with that paper several years, when he returned to this state and began the publication of a paper in Astoria, which he continued for 14 years. While he was editor of that paper Sam Simpson, the well known Oregon poet, was a member of the staff and became a personal friend of the editor.

After leaving Astoria Mr. Dunbar went to Skagway, Alaska, where he edited a paper for five years. Upon leaving Skagway Mr. Dunbar came to Pendleton and in November, 1902, commenced the publication of the Pendletonian, which was afterwards merged into the Daily Guide.

The deceased was of a prominent family: one brother, W. R. Dunbar, being register of the land office at Vancouver, Wash., for a number of years. He died March 24, 1903 of the same disease that claimed his brother. Another brother is R. O. Dunbar, one of the supreme judges of the state of Washington, who is suffering from the effects of a severe fall received a few days ago, and telegraphs he cannot come to his brother's funeral. He leaves to survive him a wife and one daughter, Miss Agnes Dunbar, well known as an elocutionist. The funeral arrangements have not yet been made.
