He Made a Delinquent Deacon's Optic Sore

Walla Walla, Wash., May 21.—A slug over the left eye is what Deacon William Pinkerton got Wednesday at Athena, Or., when he argued with Rev. W. H. H. Moore, pastor of the Athena Baptist church, that the latter had no more salary coming to him.

Mr. Moore was about to leave for Iowa with his wife and three children, and had been paid off. He claimed more money, and, meeting his deacon on the streets, a heated discussion ensued, culminating in the blow from which Pinkerton now wears a discolored optic.

The deacon is 70 years old. Mr. Moore is 40, and reputed to have a nasty temper. He left Wednesday night for Iowa. The occurrence is generally regretted here.

END OF BISHOP FIGHT

Resolution Asking Several Protestant Denominations to Unite

Los Angeles, May 21.—James R. Day, chancellor of the Syracuse University, was elected on the 14th ballot, in the face of the "higher criticism" fight. He was the eighth and last bishop to be elected. The total vote was 696; necessary to elect 464. Day received 474 votes after the second withdrawal, and got the Chautauqua salute and shouts.

The list of bishops thus far chosen is as follows:

Joseph F. Berry, of Chicago; Henry F. Spelmeyer, of Newark, N. J.; William E. McDowell, of New York; Jas. W. Bashford, of Delaware, Ohio; William Burt, of Rome, Italy; Luther B. Wilson, of Baltimore, and Thomas B. Neely, of Philadelphia.

Will United the Churches.

Washington, May 21.—At today's session of the general conference of the Methodist Protestant church consolidation with the Methodist Episcopalians, as well as United Brethren and Congregationalists was advocated. A resolution was asked to the Los Angeles conference asking consideration.

RUSSIAN CRUISER BLOWN UP

General Kuropatkin has thoroughly reinforced that place, and intends to await the Japanese and engage them in battle there.

Successful Russian Sortie.

St. Petersburg, May 21.—It is reported today that the Japanese were repulsed in the rear of Port Arthur. General Stoessel sallied out to protect a train bringing ammunition, and a skirmish with the Japanese followed. The Japanese loss was heavy. The train arrived safely.

One authority claims that Stoessel's sortie caused casualties of 1000 Japs, and the Russians 150.

Lively Skirmish Near Kinchow.

St. Petersburg, May 21.—It is reported that General Tak engaged two Japanese divisions near Kinchow today. The Russian casualties were seven officers, including General Nadeyin, wounded and 150 men killed and wounded.

Kuropatkin Reports Skirmish.

St. Petersburg, May 21.—General Kuropatkin reports that in a skirmish at Feng Huang Cheng the Japanese were driven off, and only two Cosacks were wounded.

WILL MOVE TO HELENA.

Carlisle Indian School Comes to Montana.

Helena, Mont., May 21.—The Carlisle Indian school, located at Carlisle, Pa., is to be removed to Helena. Agents of the department of the interior have recommended the Helena site, and a definite proposition has been submitted to local men, who have taken the project up, and secured options on the land required, and these were tendered to the government, thus, with the settlement of formalities, the school will be removed here.

The land selected and approved by the government agents is located six miles north of Helena and consists of about 7000 acres, together with the buildings of the Montana Wesleyan university, chief of which is a four-story brick structure.

The university has been re-established in the city, and the trustees made a very low price to the government for their interests. The landowners in that vicinity also transfer their land at a nominal figure.

One of the chief reasons for removing the school to Helena has been the expense in transporting pupils of Western reservations to and from Carlisle. Another is that the conditions of farm work here are similar to those of the Indian lands. The government will erect two more buildings similar to the main college structure, and work will begin this year.
