THREATS HURT NO ONE.

The threat of the Woodburn editor

to bring out some scandalous facts

of Judge Scott's record as county

judge did not materialize.

His last paper is silent about Judge

Scott and the only opportunity for the

Woodburn editor to do his duty by the public is this week.

What the people of Woodburn will think of an editor who will wait until the night before election to expose official wrongdoing in so important an office as county judge, remains to be seen.

There could not possibly be a more cowardly policy adopted by the publisher of a newspaper than to insinuate that there was something rotten in a county judge's record and then refuse to give it to the public.

If this county had to have a Democratic county judge, the people could not get a better or cleaner Democrat than Judge Corby. He was elected as a Prohibition Mayor and then re-elected without opposition.

But his policy of building roads entirely by taxation and his opposition to the voluntary subscription plan ought to defeat him as a matter of public policy.

Under the law precincts can levy as high as ten mills for road purposes, but not a precinct has resorted to that method of raising road funds, and it is safe to gamble none will.

A five or ten mills additional tax on Woodburn would almost bankrupt a majority of the property owners of that city, and that is what Corby advocates if he advocates anything.

Like free trade, that theory may be a correct plan of road building but it would be ruinous to the people of our county. Scott's plan of allowing the people who are most directly interested to subscribe and then adding to their fund by the county is rational and practical.

This is the real issue between Scott and Corby and it is not personal or to be flected by threats of the Woodburn editor, who ought not threaten anyone, but should be thankful to remain in obscurity.

Threats and abuse heaped upon the editor of The Journal will not elect Mayor Corby to the office of county judge, and should not defeat the present county court.

Judge Scott and Commissioner Needham should be elected for a second term as nearly unanimous as possible for their splendid work, even if they have not risen to the Woodburn editor's high ideals of public service.

THE GRANGE AND THE AGRICULTURAL COLLEGE.

The intimation of the State Grange is clearly that there is not enough done for Agriculture at the State Agricultural college.

Besides the Master of the State Grange there is but one farmer on the Board of Regents of the State Agricultural college, and he is an apple-grower.

The Board of Regents is composed of nine members appointed by the governor, besides the president of the college, and the State Board of Education.

Of course the Master of the State Grange is expected to be a farmer, to get that position. He is made Regent by law, not appointed.

The President of the Agricultural college can hardly be expected to be a farmer, as few farmers in Oregon have a college education.

The State Board of Education, composed of the Governor, Secretary of State and Supt. of Public Instruction, cannot be expected to be farmers.

There are plenty of farmers who know enough to fill those offices but they are not sharp enough to get nominated or elected.

So out of the 13 members of the Board of Regents, besides the Master

of the State Grange, there is but one farmer and he is manager of a commercial apple orchard.

Following are the Regents appointed by Republican and Democratic governors: W. E. Yates, lawyer and politician; J. R. Daly, surveyor and politician; B. F. Irvine, editor and politician; J. T. Apperson, capitalist and politician; W. P. Keady, promoter and politician; J. K. Weatherford, lawyer and politician; J. M. Church, banker and politician; W. W. Cotton, corporation attorney; J. D. Otwell, fruit grower.

The Grange instead of finding fault with the college should attack the evil at the fountain head, and demand more actual farmers and tillers of the soil on the Board of Regents of the Agricultural college.

How can mere lawyers and politicians and bankers be expected to run a farmer's college? It is preposterous and the Grangers should not expect such impossibilities as drawing blood from turnips.

No one would expect a Board of Regents composed entirely of farmers to conduct a literary institution or a business college, nor vice versa.

STORMING THE CHURCHES.

As usual many of the churches are opening their doors for the Local Option crusade.

While that party denies it, the whole machinery and organization of the Prohibition party backs this alleged Local Option campaign.

So far as it is the determination of a public policy of dealing with the liquor traffic, backed by a political party it is politics pure and simple.

The office-seekers and politicians of the other parties recognize the Local Option crusade as politics, and systematically avoid committing themselves or getting on either side of it.

But the Prohibition orators, and the moral-wave reformers who are always ready to jump into the pulpits, are storming the churches.

A political program that will need a strong administration to enforce its undertakings is making the churches to go into politics once more.

While the founder of Christianity ate and drank with publicans and sinners, and steadfastly refused to meddle with temporal affairs and policies of government, religionists in these days jump at the chance to get into politics.

These political reformers who take advantage of the pulpits to carry on

their agitations have a great advantage in one way—they plead the cause of morality in the name of purity and religion.

But this is a short-lived and specious advantage, because in the long run the people will not accept governmental policies or moral reforms at the hands of any religious denomination or combination.

Dealing with the liquor traffic is one of the gravest problems of government, and no political solution has yet been found for the evils that are connected with the business.

Merely taking possession of all the pulpits that will be surrendered to a temporal propaganda a few days before election will not solve the problem. It has been tried in other states and failed.

Church and State partnership in any undertaking in the end weakens the church and demoralizes the government and has done so in every country where it has been attempted.

AN EXHIBITION OF CRUELTY.

Portland papers advertise Prof. Miller as making a balloon ascension Sunday afternoon and dropping at an altitude of 2000 feet, with a parachute and at the same time liberating a live turkey that makes the descent to the ground as best it can. The man has a perfect right to take his life in his hands and make this leap, but the dropping of a large bird like a turkey that was never intended to fly at such an altitude, is an act of cruelty that should not be permitted by the humane society.
