

LARGE MONTANA SUIT

Two Companies Pursue Each Other With a Vengeance

Butte, Mont., July 19.—The Parrott Silver & Copper Company, an amalgamated corporation, this afternoon brought suit against F. A. Heinze and others demanding \$2,200,000 for ore extracted through the Nipper shaft. The suit is brought on the contention that the Nipper ore bodies are an apex in the Little Mina mine, the latter owned by the Amalgamated.

Will Not Reply.

The Oregonian, in commenting on the recent circular issued against Archbishop Christie and a number of Catholic priests, says:

"If the traducers of Archbishop Alexander Christie and the Catholic clergy of Oregon hoped to have the archbishop answer their charges, their hopes and desires have missed fire. At the archbishop's residence yesterday afternoon it was learned that the archbishop, under no circumstances, would answer the attacks made upon him in the circular, which not only was sent to Rome, but scattered broadcast throughout Oregon and Washington. "The archbishop is fully aware who is the originator of the circulars which seek to besmirch his good name, but he is holding himself aloof from criticism of the person himself. His treatment of the charges will be a dignified silence, although it is understood that others will take up the accusations, and answer them in due time."

"The attacks upon Archbishop Christie and the Catholic clergy of Oregon are generally supposed to be the work of one Joseph Schell, a pamphleteer, who, had he lived in the days of Dr. Johnson, would have been in his element. Had any other person save Schell been the author of the circular, the Catholic clergy and laymen would have been more thoroughly roused than they are; but Schell's predilection for using virulent language is so well known that he is not taken seriously."

"Schell has dragged the Right Rev. C. J. O'Reilly, bishop of Baker City, into his charges, seeking to establish the impression that there is an estrangement between Archbishop Christie and Bishop O'Reilly. This is also groundless, for Bishop O'Reilly has been and is the guest of the archbishop in Portland for several days, and he resents the attack upon Archbishop Christie, and the attempt to injure the Catholic church."

Henry S. Crocker Dead.

San Francisco, July 19.—Henry S. Crocker, the pioneer stationer, millionaire and brother of the late Charles Crocker, the railroad magnate, died yesterday, aged 72 years. He had been confined to his room for several weeks, but his death was unexpected. He came to California in the early

Cholera Epidemic.

Baku, Russia, July 19.—Refugees from Teheran tell terrible stories of the ravages of cholera. They say that on some days the mortality reaches 900. The Europeans are abandoning their property, and are fleeing to a camp in the mountains.

There is a pitiable condition of affairs at the railroad stations which are almost without food. The government ordered the closing of the frontier for the purpose of preventing the introduction of the disease.

LARGE NUMBER KILLED

Chee Foo, July 19.—A Chinese junk arrived here today, five days from Port Arthur, and says that on July 11th the Japanese captured and occupied with 4000 men one of the eastern forts. The Russians cut them off by exploding mines, which resulted in the annihilation of the entire number. The night before the junk left Port Arthur a Russian torpedo boat sunk a merchant ship, mistaking her for a Japanese transport. It is believed to be the Hipsang, now long overdue. The crew was rescued by the Russians, but a number of Chinese were drowned.

Root Visits President.

Oyster Bay, July 19.—Ellis Root left for New York at noon, after what he termed a "satisfactory conference with the President."

It is believed that he told the President that he did not care to re-enter public life again, even as a candidate for governor of New York.

Gorman for Chairman.

New York, July 19.—Further political conferences by the Democratic leaders were held today and the subject of the national chairmanship was discussed. It is said in the best opinion of the leaders that every effort will be used to bring about the selection of Gorman.

Miners Arrived Late.

Oyster Bay, July 19.—The miners' delegates, Burke and McCafferty, arrived at 3:20, and will call on the President late this afternoon, and present the petition asking for an investigation of the Colorado situation.

LARGE BIRD CROP

Pheasants Were Not Injured by the Heavy Spring Rains

Sportsmen are eagerly looking forward to the open season for Chinese pheasants, as it is evident that the shooting will be better than ever before. Everyone who has had occasion to go through the farming districts has noticed that the supply of young birds is unusually plentiful. One cannot drive through the wheat lands in any direction, without frequently starting up large flocks of the beautiful game birds.

As a general thing, a large percentage of the birds are killed each year by the rains soon after they are hatched. This year, however, there was no rain until the young pheasants were strong enough to survive it. For this reason there will be almost twice as many birds as last year.

The pheasants are less timid, too, than formerly, owing to a stricter enforcement of the game laws. A few years ago illegal hunting was so common that the pheasants became wild, and sportsmen had difficulty in getting within range of them after the season opened. Illicit hunting has now been almost entirely abandoned, and the birds are easily approached up to the beginning of the open season.

Inmates Increase.

The number of prisoners confined in the Oregon penitentiary has increased from 314 to 334 in the last three months. During the quarter 56 were received, 33 discharged, one died, and two transferred to the asylum. The earnings of the institution were: For board of United States prisoners, \$531.42; for convict labor in stove foundry, \$3980.90; for convict labor on public roads, \$526.20; for team on public road, \$164.25. The salary account for the quarter was \$5590.05, and the expense for maintenance \$7527.19. From the betterment fund \$683.10 was spent for improvements. Other expenditures brought the total expense for the quarter up to \$15,462.89.

Ranch Sold Well.

The prospect ranch located 40 miles up the Grand Ronde from La Grande, and owned by J. J. Conley, was sold to Antone Vey, one of the wealthy sheep owners of Umatilla county, for \$17,500. It consists of 2900 acres of fine hay and grazing land. Mr. Conley retains all the stock.

Dogs Must Pay Tax.

Chief of Police Gibson today appointed H. A. Dennison and Merritt Bartholomew extra policemen to round up the stray and unlicensed dogs. They will wage an active warfare on the canines, and if your tax is not paid you need not be surprised if your pet is in the pound.
