SENATE DEADLOCK REMAINS UNBROKEN

Kuykendall Forces Solid in Their Contention That He Is Legally Elected Caucus Nominee

The first session of this august body today lasted just half a minute. President Brownell called to order, and roll call showed every senator present. Senator Booth moved a recess until 10:30, which prevailed.

It was claimed by the Carter men that they had the deal all closed to get one vote from the Kuykendall men, and the five Democrats, which would have elected their man. This may be true, and it may not, for, while it is a fact that the Democrats are standing pat with the Carter forces in holding out the Kuykendall people, it is stated with great emphasis that Senator Miller would not be a party to the deal on the terms mentioned.

They Kuykendall people immediately went into caucus when the recess was taken. It was stated by their members that their 15—comprising one-half of the senate, and three-fifths of the Republicans—will stand solid to the end, and that it is only a matter of time when they will win.

Another little caucus was held by the Carter men, in which it is said that an effort was made to get the Carter men and the Democrats all to vote for Nottingham, on the theory that he is not a regular Republican, and the first ballot which followed showed that he received several votes, but not enough to make a ripple. o'clock, when Carter promptly asked for a division of the house. The result was 15 to 15, and the motion was lost and the balloting proceeded as before.

Another theory advanced for breaking the dead-lock is that Rand will become the candidate for his faction. The Carter men say that their resistance is purely a personal antagonism against Senator Kuykendall, and claim to be willing to accept almost any one else for a presiding officer. The Kuykendall men say that they have general party usage and precedent in their favor; that they have gained their strength by honorable means, hence that they would never be justified in receding from their position. Thus it looks as though there would be a prolonged dead-lock.

After the sixtieth ballot, Senator Hodson suggested that in lieu of this laborious process of voting a page might be appointed to cast the respective number of votes for each member. All appreciated the point, and the same old monotony followed until the 65th ballot, when, upon motion of Smith, the Democratic senator from Umatilla, the senate adjourned until 2 p. m.

BATTLE WITH MOROS

Manila, Jan. 10.—Word was received here today of an engagement with Moros on January 8th, on the island of Jolo, in which Lieutenant James J. Jewell and a private in the 14th cavalry were killed. Second Lieutenant R. W. Ashbrook, of the 17th infantry; Captain Habstrad Dory, of the fourth infantry; Lieutenant R. C. Richardson, of the 14th cavalry, and several privates were wounded. The fortress where the fight occurred was captured and demolished.

A meeting of the legislative committee of the Oregon Press association was held last evening in the office of President R. G. Hendricks in this city. It was decided that the committee request the passage of a law requiring the publication of assessment rolls of the several counties of the state. This idea is not alone for the benefit of the newspapers, but for the business interests of the state also, inasmuch as it would serve as a reliable bureau for information on the financial standing of the residents of the state. It is also claimed that this plan will bring into the county treasuries sums greatly in excess to those now paid. It is believed by the supporters of the plan in this county that in the entire state it will bring in no less than \$250,000 in excess of the amount now received. This plan has been adopted in Benton county already, it is said, with great success.

The committee also discussed the necessity of the publication of the official ballot and will take proper steps toward securing a law to that effect also.
