Y. M. C. A. ANNUAL MEETING**Elaborate Banquet With Toasts and Splendid Lecture**

The annual business meeting of the members of the Young Men's Christian Association, preceded by a sumptuous banquet, was held last night in the Association banquet rooms, followed by an address in the gymnasium by H. J. McCoy, general secretary of the San Francisco Y. M. C. A., illustrated with 75 views.

The banquet rooms were artistically decorated with ropes of ivy intertwined with streamers of red crepe, and the red shaded lights together with the numerous red candles made the rooms look festive indeed. The banquet was in charge of the Ladies' Auxiliary and was a charming success. Some fifteen young ladies graciously assisted in serving the members and guests.

The annual report of General Secretary John Fechter was encouraging, as it was a report of gain in every department during 1904. The old indebtedness has been reduced in some measure, \$300 was expended in remodeling the corner storeroom in the building, and there is no mortgage on their building.

Professor W. I. Staley, of the Capital Business College, was elected to a place on the board of directors and Hon. T. B. Kay, C. P. Bishop, Jos. H. Albert and R. J. Hendricks were re-elected as members of the board.

A number of toasts were responded to in a happy manner by H. W. Stone, general secretary of Portland; Mr. McCoy, of San Francisco; John Fechter, R. J. Hendricks and Hon. T. B. Kay.

The concluding part of the evening's program was by no means the least interesting, it being a faculty of Mr. McCoy to talk in a superbly entertaining manner, and his 32 years of experience in this line of work gives him a board of knowledge of the work accomplished. He spoke of the first organization of the work in London 60 years ago by a young business man, showing the picture of the room in which it was started, and said the reason of the rapid growth and substantial development of the Y. M. C. A. work was owing to its having been organized by a business man on a business basis and with business principles. The men who take the greatest interest in the work and who are at the head of its business men. He also spoke extensively of the work being done in foreign countries, especially in China and Japan, and of the effect it has on the men who come in contact with it. The first organization effected in America was at Montreal, the second at Boston, there being but a few days difference in the dates. In the past six years the work has grown more extensively in this country than in the 47 years preceding, and now there is estimated to be 1800 associations in the United States.

Mr. Coy's address was certainly a rich treat for those who were interested enough to be present.

Senate—Thursday Afternoon.

Upon motion of Senator Croisan the courtesies of the senate were extended to Hon. P. A. Cochran, of Woodburn.

The "age of consent" special order for 3 p. m. was extended to 11 a. m. next Tuesday.

The first reading of House bills was taken up as follows: Nos. 40, 61 (read twice), 87 (read twice).

S. S. M. No. 4—Hodson. To prohibit combinations between fire insurance companies. Signed by Portland chamber of commerce. Referred to committee on insurance and banking.

S. R. 13—Coe, authorizing payment to F. C. Middleton for services as temporary assistant chief clerk. Adopted.

The committee appointed in 1893 to investigate the advisability of an institution for defective youths, composed of Senators Kuykendall and Smith (idiotic and epileptic) reported in favor of such an institution as will give them the privilege of manual training. The report suggests that such an institution be established on the grounds of and under the control of the insane asylum. It was also recommended that the deaf mute building could be used, and a new place erected for that purpose. Referred.

S. B. 131—Tuttle, to appropriate \$8000 for Lewis and Clark memorial at Fort Clatsop.

S. B. 132—Malarkey, to appropriate funds for maintenance of wayward girls.

S. B. 133—Laughery, by request, to dense with county institutes for 1905.

S. B. 20—Croisan, regulating fees of county recorders.

Senate bills were read the second time, as follows: S. B. 82, 83, 84, 85, 86, 87, 88, 89.

S. B. 28—Pierce, protecting prairie chickens in all counties except Wasco. Read third time and passed.

S. B. 52—Brownell, protecting elk, mountain sheep or antelope until 1912. Referred.

S. B. 51—Smith, protecting Bob White quail until 1909. Made special order for 2 o'clock Monday next, as was also S. B. 55.

S. B. 62—Malarkey, making void unrecorded deeds in case of subsequent sale and filing of deed within five days.

Senator Croisan moved that the courtesies of the senate be extended to ex-Governor T. T. Geer. Passed.

S. B. 4—Miller, repealing health officers of Astoria, Yaquina Bay and other points. Senator Rand was called to the chair, and President Kuykendall spoke against the passage of the bill, until positive assurances are received that the general government will give Oregon ports this protection. Senator Smith thought we had the required assurance. Senator Howe wanted to know what good the health officers did anyhow. Senator Tuttle cited a case where a shipload of Chinamen, affected with smallpox, arrived at Astoria, but were quarantined by the health officer, and the state protected. Smith stated that the state health officer would furnish the necessary protection. Kuykendall moved that the bill be re-referred. Carried.

House bills were read the first time as follows: 41, 43, 54, 62, 69, 71, 82, (passed), 91 (passed), 124.

H. B. 40 was read second time and referred.

Senator Hodson gave notice that he would present a resolution for an additional committee of five on manufactures.

Large Barn Destroyed.

The large new barn of Clam Bros., situated five miles north of this city, on the Lincoln road, was totally destroyed by fire Thursday morning about 4 o'clock. The barn was filled with 90 tons of hay, 12 tons of wheat straw, a \$400 hay press, new wagon box, and a large amount of other farm machinery. The loss is estimated at \$2500, and the insurance is about \$1500.

New Improvements.

The Capital City Mills of Bryant & Pennell, of this city, are in the near future to make some improvements on their mill. They will erect a four-story addition on the east end of the mill, and it will be used for their cleaning department and for storage purposes.

Sent to the Asylum.

Robert Luther, of Yamhill county, was committed to the state insane asylum yesterday. He was 31 years of age and the theory he has is that he has committed an assault, and a mob is after him.

AMEND INSURANCE MEASURE

The Capron insurance bill, to prohibit and make unlawful insurance combinations in Oregon, will be strengthened in committee to require a surplus reserve of \$250,000 instead of \$200,000, as the bill provides, before a company can do business in the state, and the adoption of the New York code standard.

The Right Move.

The effort to convert the deaf mute school building and farm lands into an extension of the asylum, for feeble-minded persons, is in the right direction.

Another wing to the insane asylum should not be built. More lands should not be purchased for the asylum.

The feeble-minded and other persons not properly insane should be taken out of the asylum for insane, and then new buildings are not needed.

The senate special committee has reported in favor of using the deaf mute building for the relief of the crowded condition of the asylum, and for the erection of a new building for the deaf mutes on land owned by the state in the city.

By utilizing the buildings and lands of the deaf mute school for the above purposes, the state will avoid building a new wing to the asylum, will avoid buying more land, and will do an act of simple justice to the deaf mute children.

Hop Case Decided.

The hop case of Lillenthal Bros. against H. Hirschberg and Mr. Dove, of Independence, was decided in the United States court yesterday at Portland, by Judge Bellinger. It granted Lillenthal Bros. a judgment for the amount of \$6000. The suit was over a contract for the delivery of hops at 15 cents, and the amount of the judgment is based on the difference between 15 cents and 30 cents, the present price. The amount of hops was 40,000 pounds.
