OLD GRAFTS STAND

Thirteen Senators Refuse to Further Stultify Themselves

And Go on Record in Favor of a Convention to Revise the Constitution

The Brownell constitutional convention bill was read. It provides for a convention in Salem January 8, 1906, with 90 members, 60 to be elected June 5, 1905, and 30 to be appointed by the supreme court. Not more than two-thirds of the latter shall be appointed from one political party. Senator Brownell at once arose and made a succinct statement of the provisions of the bill. He started out by stating that all members of the senate were simply servants of the people, and that, as such, they should simply perform their full duty. He had been taught that a constitution should, under all circumstances, be held sacred and inviolate by every public official, as well as private citizen. He then charged that there had never been an official in the state, including himself, who had not winked at gross violations of the old constitution. He then went on to show that, under the decision of our supreme court, none of the state institutions or schools not at the seat of government had a legal right to exist. He also pointed out that the appropriations for all these institutions might at any time be enjoined and stopped. With this in view he thought it would only be fair and decent to have a constitution that would not require every state institution not at Salem to live under a cloud of unconstitutionality. He showed that the present constitution was adopted before Lincoln was President, and that our commonwealth had outgrown its provisions.

Next Senator Brownell stated that he wished to strike out the provision of the bill requiring the supreme court to appoint 30 of the delegates. This provision was the fruit of the committee's labors, and, while it was, in a sense, a good thing, he preferred to have it removed. He then pictured how Governor Chamberlain and his friends might, after the convention, composed in part of appointed delegates, go about the state and point out to the people how the Republican legislature had deprived them of the right to elect their own delegates.

Senator Brownell then pointed out the fact that the constitution conflicts with the national constitution. He referred especially to the words "free" and "white," in reference to citizens. Next he pointed out that the flat salary feature alone was sufficient reason for a new constitution. He reviewed the salaries provided by the constitution, and then showed what a burlesque it is to have state officers grow rich on petty salaries. He charged that nearly every state officer's salary was open to the inroads of corruption and dishonesty. He advocated that, among other things the new constitution ought give the governor authority to veto any item in an appropriation bill. He then advocated a reorganization of the judiciary of the state, including the supreme and circuit courts, and also suggested a reorganization of the land department. He pointed out the incongruity of the secretary of state being the state's purchasing agent, and at the same time the auditor of his own accounts. He showed how unbusinesslike it is to have the state printer protected in an everlasting sinecure cell in the name of the old constitution.

Senator Brownell spoke eloquently and clearly for half an hour, and really made a favorable impression upon the minds of his hearers, and the senate chamber was packed with visitors. He resented the insinuation that the main object of the convention is to kill the initiative and referendum, and showed that he was the prime mover for that law. He felt hurt and chagrined that this charge should come from the class

he had served in securing their favor to law.

In closing he claimed that it was simply a good proposition to get the constitution amended or reformed at one stroke by a convention, rather than the slow process of individual amendments.

Senator Pierce followed with a plea for the old constitution, and showed that, under the initiative and referendum, amendments could be made galore.

Senator Pierce stated that there was really no occasion for a convention, and stated that W. S. U'Ren assured him that he had prepared all the required amendments, and that they would be brought up at the next election. In closing, he also read a petition from Oregon City, signed by 70 citizens objecting to a convention, which had been handed to him by Mr. U'Ren, at his elbow.

Senator Malarkey followed in an eloquent speech. He showed that in the meetings of the judiciary committee Senator Pierce made no objections to the provisions of the bill. He denounced the attacks made by certain religious organizations of Portland upon the motives of the friends of a constitutional convention, and apologized for these foolish actions. He showed that it would not be practicable to adopt more than one amendment at a time, and that it would take half a century to get the necessary amendments. He also pointed out that the amendments offered by the initiative are, as usual, the result of a very few heads, and more often the work of some one crank, and that nobody else can have a voice in framing or shaping such amendments.

Senator Pierce followed with another plea for the initiative and referendum, and stated that the rulings of the supreme court of Oregon for the past 50 years upon the meaning of the various sections of the constitution would all be lost.

Senator Rand followed with a strong talk for the bill, and pointed out that a convention would, without doubt, re-adopt the main features of the present constitution. He called attention to the fact that a salary bill was before them to give the governor \$4500 a year when, under their oath as senators, none of them could honestly vote to give that official more than \$1500, provided by the constitution. He showed that for years the Oregon legislature had been kept busy avoiding the constitution.

Senator Miller then spoke against the bill, because the new constitution might be worse than the old one. The provision to have 30 appointed by the supreme court was unanimously struck out. The bill received 15 ayes and 14 nays, and was lost.

Adjourned to 2:30 o'clock p. m.

Those voting for a constitutional convention were Brownell, Coe, Coke, Farrar, Hobson, Hodson, Holman, Kuykendall, Loughary, Malarkey, Rand, Siebel, Wheelodon, 13. Mays, Booth and McDonald absent.

PLUCKY HORSEWOMAN.

Mrs. Chas. Schoeler Stops Runaway and Saves Her Life.

An exhibition of expert horsemanship was given this afternoon by Mrs. Charles Schoeler, who held her seat in a two-wheeled cart for six blocks behind a runaway "bunch grasser," and at the end of that distance gained control of the animal and stopped him, waiting calmly, and with a smile on her face, for her husband, who was rushing breathlessly up the middle of the street in pursuit.

Mr. and Mrs. Schoeler drove into town in the cart, and Mr. Schoeler having business in Livesley & Company's office, left his wife at the foot of the stairs until he returned. The horse was facing north, and for some unaccountable reason, known only to himself, started to run, wheeling directly around and going south on Commercial street. The bystanders declare that the beast was making something better than two minutes flat by the time he got started, and everyone expected to witness an appalling accident, but the pluck of the little woman, and her skill as a horsewoman, averted the accident, and probably saved her life.

TEXTBOOK COMMISSION NAMED

By Governor Chamberlain In Accordance With Wishes of the People

Governor Chamberlain has reappointed for a term of four years the following text-book commission:

Wm. Colvig, of Jacksonville.
H. W. Scott, of Portland.
M. W. Ladd, of Portland.
P. L. Campbell, of Eugene.
C. A. Johns, of Baker City.

This commission was appointed four years ago by Governor Geer, a Republican, and indicates that the present governor, a Democrat, approves of the reforms in text-books which they inaugurated.

The re-appointment of this commission was advocated by Senator Daly and many prominent citizens and educators, and against a great deal of political and personal pressure on the part of others wanting the places.

Governor Chamberlain has redeemed his pledges to make absolute non-partisan appointments in educational institutions and matters affecting the common schools. The present appointees are all Republicans, except Campbell, who has never been counted a partisan of any political organization, although originally a Democrat. This text-book commission will make the next adoption in 1907.
