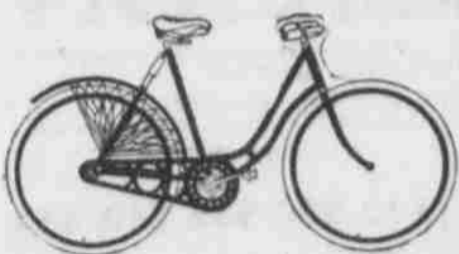
**Edison Scene of Good Show.**

**NATIONAL RIFLE CONTEST**

Adjutant-General W. E. Finzer has recently received from the United States war department copies of the general orders governing the national rifle contest, which is to be held at Sea Girt, N. J., on August 24, 1905. The national rifle range is located at Sea Girt, and every year teams from the different detachments of the United States troops assemble there and compete for trophies. Each team is composed of 12 men and the contest is open to the following: U. S. army, two teams, one cavalry and one infantry. U. S. navy, one team. U. S. marine corps, one team. U. S. military academy, one team. U. S. naval academy, one team, and one team from the national guard of each state and territory, including the District of Columbia. The men representing the teams go at the expense of the United States government, and must wear the authorized uniform of the corps to which they belong.

The prizes offered are as follows: To the team making the highest aggregate total in the three days' contest, the national trophy, authorized by act of congress, to be competed for annually, and \$300 in cash.

To the team making the second highest aggregate total, the Hilton trophy and \$200 in cash.

To the team making the third highest aggregate score, the bronze "Soldier of Marathon" and \$150 in cash.

To the team making the fourth highest score, \$100 in cash; to the team making the fifth highest score, \$75 in cash, and to the team making the sixth highest score, \$50 in cash, and also a medal for each member of the winning teams.

Although it is the privilege of each state to send a team of 12 men from the national guard, it is not compulsory, and so far it has not been decided whether Oregon will be represented in the shoot.

It is safe to say, however, that should a team from this state be sent to Sea Girt, they will be well at the head of the list, notwithstanding the fact that the members of the competing teams at the national contest are among the best rifle shots in the world.

At the state meet held in Portland last August there were some excellent scores made, and, with a few months' practice, there is no reason why these scores could not be greatly improved.

It would not be a difficult task to pick a competent team from this state, as the records show that there somewhere near 100 men in the O. N. G. who can average 100 or more out of a possible 150.

A team from Company M, of this city, won the state trophy last fall at Portland, making a total score of 457 points out of a possible 500 points, and should a team from this state be sent to Sea Girt next August, Salem will no doubt furnish three or four men to make up the team.

The eligible candidates from Company M, are Sergeant Roscoe Shelton and Sergeant Ralph White and Private Stanley Rider. These young men are unquestionably among the best all-around marksmen to be found, seldom making less than 45 out of a possible 50, at any range from 100 to 100 yards.

Captain Murphy has just completed a new rifle range in Polk county, which is considered to be the best in the state, as it covers a distance of 1000 yards. The members of the company are taking great interest in the practice, and a dozen or more men go over to shoot nearly every day.

It is to be hoped that Oregon will send a team to Sea Girt this season, as the members of the Oregon National Guard throughout the state are much interested in the affair, and in the next few months' of practice it will develop who are capable of holding a position on such a responsible team.

**Lane County Frost.**  
The frost of Monday night nipped some fruit in different parts of the county. A telephone message from H. H. Rath, at Pleasant Hill, yesterday stated that French prunes were damaged considerably. The thermometer registered 28 above, and a skim of ice was noticeable. Ward from Goshen brings information that prunes and apples were slightly damaged.

Y. D. Hensill, of the Hensill, Stainson Company, large fruit growers, on the river road, says the thermometer registered 33 at his place, and the damage was very slight.

It is probable that fruit along the foothills or on an elevation has felt the touch of the frost king, but unless more and heavier freezes come Lane county will have a big fruit crop.—Eugene Register.

**Farm House Burned.**  
The farm residence owned by the Barr estate, and occupied by John Edgar, in Polk county, was totally destroyed by fire yesterday, the occupants losing everything they possessed. The fire started through a defective flue, and before the family of Mr. Edgar could remove their furniture the entire house was consumed with its contents. The owners of the house had \$100 insurance on the house and barn, but Mr. Edgar was without protection.

**Goes to Portland.**  
Captain Charles A. Murphy left this afternoon for Portland, where he will take command of a detachment of the military guards at the Lewis and Clark fair grounds.

Captain Murphy is one of the three captains who were chosen for this honor, and he will have command during the entire fair.

There are already a number of guards on duty at the grounds, and on May 15th, the remainder will be sent. Among those going from Salem are H. H. Lucas, R. O. Shelton, W. C. Kantner, Robert Glenz and Chester Abrams.
